INSTRUCTIONS
<p>NARRATIVE:</p> <p>The objective of this operation is to conduct follow-up investigation on tip calls received in regards to the Susan Powell case and to visually inspect tip call locations. The operation will start on November 02, 2010 at 0900 hrs and will go all day until all Tip calls and sites have been cleared.</p> <p>Personnel participating in this operation will be split into 2 man teams. Each team will be given a packet containing the information on the areas to be searched/checked. Each area will be documented with digital photographs, GPS tracking, and a supplemental narrative for each area. Personnel who do not get placed on a two man team will be conducting follow-up on tip calls that have been received in regards to this case. A supplemental narrative will be completed for each follow-up handled. If any of the follow-ups result in an area that needs to be searched, this information will be forwarded to Detective Greco.</p> <p>The uniform for this operation/search will be plain clothes with ID. All personnel should make sure that they have the appropriate clothing for this time of year and should have plenty of water to drink and will be responsible for providing their own lunch.</p>

EVIDENCE RECOVERY PLAN

During this operation the general concept will be to operate as “low key” as possible to avoid alerting Josh Powell, media or others not involved in the operation or case. In the event Susan Powell is located the following will occur:

1. Site detectives will immediately contact Detective Greco and the site will be video recorded. Site Detectives will not enter the scene for any reason.
2. Notification will be made to Sgt. Bobrowski via satellite phone by Detective Greco.

3. One site detective will depart the scene with DVD video and deliver the DVD directly to Sgt. Bobrowski.
4. Remaining site personnel will remain at the scene until relieved by scene security provided by WVCPD.
