7-15-2011	0804	Steven Powell goes mobile in his personal van.
	1944	Steven Powell arrives home in his personal van.
	2228	Josh uses a hand dolly to retrieve boxes from his van. He makes two trips with the boxes and walks them into the house.
7-16-2011	1149	Steven Powell leaves in his personal van.
	1311	Josh is playing out in the front yard with the two children.
	1350	Josh takes children back inside the house.

	1427	Steven Powell arrives home in his personal van.
	1705	Josh's brother is out cutting the lawn.
	2015	Steven his washing his van. Josh is outside playing with kids.
	2042	Washing Josh's van now.
7-17-2011	1007	Steve leaves in personal van.
	1043	Steve returns with groceries and small children help him unload.
	1921	Josh comes out and get's unknown item from front passenger side of van interior.
	2059	Unknown family member carries large object from home and places in on side of home and goes back inside.
	2100	Unknown male opens garage and takes something out of garage to side of house and closes garage door.
7-18-2011	0818	Steven Powell leaves in his persona van.
	1820	Steven Powell arrives home.
	1827	Steven appears to be cleaning out the interior of his van.
	1846	Josh's van leaves the home. It appears the entire family including Steve and Josh are in the vehicle.
7-19-11	0013	Josh's van returns home. It is too dark to see the occupants.
	1425	Josh leaves alone in his light blue van.
	1431	Josh arrives home alone.
	1559	Steve leaves in his personal van with the kids.
	2240	Steve arrives home.
7-20-11	0704	Josh's sister leaves in Steve's personal van.
	0847	Josh's sister returns and carries what appears to be clothing items into the house.
	1421	Steven Powell leaves in his personal van.
	1716	Steven returns home.
7-21-11	1404	Josh and Steve leave in Josh's van.
	1412	Josh and Steve return
	1427	Power is disrupted on camera. The camera doesn't power up again until 1742. Steve's van is gone when the camera powers up.

	2056	Unknown person leaves in Josh's van. Can't tell who is driving.
	2117	Josh's sister returns home in Steven's van. She has the kids with her. It appears is wasn't Steve that left in his van when the power was disrupted.
	2217	Power is disrupted again. The camera doesn't power up again until 0100 hours. Both vehicles are there at the time the power goes off. It appears that both vehicles are still in driveway when power is restored.
7-22-11	1029	Steve's van goes mobile. Can't tell who is driving.
	1100	Steve returns in his van and he is unloading groceries.
	1839	Josh leaves in his van with the two boys.
	2230	Josh arrives home with kids. Unknown people walk up to Josh in yard from street and are speaking with him for a bit.
	2236	People leave yard and Josh and rest of family go inside.
	2244	Unknown family members unloading unknown items from Steven's van.
7-23-11	0931	Some type of large box van parked across the street and right under the camera partially blocking the view with the street light reflecting off the top of it. It looks like someone is moving in or out across the street.
	0931	Josh comes out to the passenger side of his van and puts what appears to be some kind of garbage bag in the front passenger seat then goes right back in the house.
	0935	He goes back to whatever he put in the passenger seat of the van, a small boy comes out with him this time. They get something out of the bag and go right back in the house.
	0946	They go back to the van and open the passenger side slider door. They then go back in the house.
	0947	Josh's van goes mobile.
	0949	An unknown female comes out of the house and goes mobile in Steve's van.
	1129	Steve's van returns.
	1149	The same female comes back out and puts something in the passenger seat, an older male, probably Steve, gets in the passenger seat and the female gets in the driver seat, they then go mobile in Steve's van.
	1400	Steve's van returns, the same male exits the passenger seat and goes in the house. The female follows after a couple minutes later.

	1540	The male, probably Steve is trimming a bush in the front yard.
	1630	Josh returns in his van.
	1650	An unknown male walks from the street area to Josh and is talking with him near the open passenger side slider door of Josh's van. The male is looking at something that Josh removes from inside the van. They then walk around the front yard talking. This male is possibly one of the people that appear to be moving in or out of the house across the street. They are all out doing yard work and playing with the kids in the front yard for the next few hours.
07-24-11		It appears that there is no movement through the entire night. The moving van is across the street again with the street light glare obstructing the view of the camera.
	1810	No movement all day until now, Steve's van goes mobile.
	1940	Female arrives home in Steve's van. Right after a heavier set male and possibly Steve come out of the house with a young boy. They open the back of the van and then the garage. The garage appears to be full of various furniture items and boxes and a fridge. They carry items from the back of the van and put some of them in the fridge in the garage.
	1952	They put the garbage can out after they finish putting stuff in the garage.
07-25-11		No movement through the night.
	1320	Someone messing with the camera and it is aimed up at a heater vent in a ceiling. The camera is no longer on the target house.
