44 DM: THAT'S DETECTIVE GRECO SO...

45 SW: OKAY

46 DM: UM YA I'M SURE (INAUDIBLE) TRANSFERS ON THAT, BUT...

47 SW: BUT YOU GOT TO ASK.

48 DM: OH ABSOLUTELY SO...

49 SW: SO WE'RE STILL TALKIN...WE'LL MEET AND IT'S AN ONGOING THING. DO

50 YOU WANT THIS STUFF ON THE DENTIST AND STUFF?

52 SW: KAY SO...

53 DM: YA WHAT'S THE DENTIST?

90 DM: CUT AND HIGHLIGHTED.

91 SW: I DON'T KNOW WAS IT CUT AT THAT ONE? THE BEST HE CAN

93 DM: OKAY SCARS, MARKS, TATTOOS, PIERCINGS?

119 DM: NO DIAMONDS IN THEM?

121 DM: SO TWO GOLD BANDS  
122 JP: OF DIFFERENT SIZES. UM SHE HAS ONE WITH DIAMONDS THAT SHE  
123 SOMETIMES WEARS.  
124 DM: OKAY WELL MORE SPECIFIC SCOTT...WHAT...I MEAN THERE WAS  
125 JEWELRY THAT...I MEAN OBVIOUSLY WOMEN HAVE QUITE A BIT OF

135 DG: I JUST NEED TO SEE YOUR ARMS. WE'LL SEE WHICH SPOTS GONNA BE  
136 BEST. OKAY CAN I SEE YOUR OTHER ARM REAL QUICK? GO AHEAD AND  
137 JUST EXTEND YOUR ARMS OUR LIKE THIS...ALL THE WAY JUST LOCK EM

145 DG: YOU'VE GIVEN BLOOD BEFORE? ARE YOU SCARED OF NEEDLES?

147 DG: IF YOU START FEELIN LIGHT HEADED OR ANYTHING JUST LET ME KNOW  
148 OKAY?  
149 DM: (INAUDIBLE TALKING)  
150 DG: I'M JUST GONNA GET SOME STUFF READY SO WHEN I'M DONE I'LL PUT A  
151 LITTLE BANDAGE ON THERE SO JUST RELAX. DETECTIVE MAXWELL...  
152 DM: YES  
153 DG: CAN YOU GET SOMEBODY TO GET ME A...I THINK I'M ALL OUT OF...OR  
154 WAIT NO NEVER MIND I FOUND EM. JUST ROLL YOUR SLEEVE UP A LITTLE  
155 BIT HERE. OKAY JUST KEEP YOUR ARM DOWN LIKE THIS FOR ME. I'M  
156 GONNA GO FOR THIS ONE RIGHT HERE. THIS IS JUST AN IODINE PAD I'M  
157 JUST GONNA CLEAN THE AREA. STILL OKAY?

160 DM: I'M GONNA GO SEE IF I CAN FIND BO.

164 DM: I'VE GOT TO GIVE HIM THIS STUFF SO I DON'T FORGET.

168 DM: I'M GONNA GO SEE IF I CAN FIND (INAUDIBLE) SEE IF WE CAN GET THAT  
169 SQUARED AWAY.

170 DG: YOU SEEM A LITTLE TENSE. A LITTLE...ARE YA NERVOUS? YOU GONNA  
171 BE OKAY CAUSE YOU'RE VEINS ARE SUCKIN UP LIKE YOUR...THEY'RE...AS  
172 SOON AS I TOUCH EM...ARE YOU A LITTLE BIT NERVOUS? YOU JUST NEED  
173 TO BREATH AND RELAX OKAY.

174 SW: JUST RELAX.

175 DG: YA JUST RELAX.

176 SW: HE'S JUST TAKING BLOOD. JUST LIKE GOIN TO THE BLOOD BANK.

177 DG: YA JUST RELAX THERE YOU GO. WE'RE ALMOST DONE. JUST GO AHEAD  
178 AND LOOK THAT WAY FOR ME I DON'T WANT YOU TO GET A LITTLE  
179 WOOZY. YOU DOIN OKAY? OKAY WE'RE ALL DONE WHY DON'T YOU  
180 HOLD THAT ON THERE FOR A MINUTE AND KIND OF PUT YOUR ARM UP  
181 FOR ME AND I'LL GET YOU A PIECE OF TAPE TO PUT ON THERE KAY?  
182 THANK YOU. OKAY LET'S JUST KIND OF TAPE THAT ON THERE. LEAVE IT  
183 ON FOR A LITTLE WHILE JUST SO IT DOESN'T START BLEEDING KAY? AND  
184 THEN ALL I NEED TO DO IS GET A SWAB OF THE INSIDE OF YOUR MOUTH
