Hello my Name is [REDACTED] Yall know me well I have been in contact with numerous Detectives over the past Year and a half! I've been in contact with them regarding the Susan Powell case trying to provide them info to help find her body and to close the case!

During those contacts with Detectives I have been given a lie Detector test which asked me if [REDACTED] I was being truthful on all the info I have provided to them and It determined I was telling the truth! I provided Detective Maxwell and US Marshal Daryl Spence with info about the child porn and computers and images and what not told them to Search the house and when they finally did they found what I told them about and MR. Powell was arrested and so you know [REDACTED] is involve with all that and so you know [REDACTED] the girl who knows were Susan is [REDACTED] took pictures of her and [REDACTED]

and im sure the images are among the thousand on the computers! I feel yall think im wasting your time and that what Im giving you isn't true and that im playing games with you and what not but I've seen result from the info I've been given you like the search of Steve Powells house, the lie Doctor test! People are keeping [REDACTED]

[REDACTED] hidden and you've been in contact with people who know who she is and were she is I've gotten word from people that she knows your on to her but she has some powerful people who have her cover and will green light people who agree her up and what not T [REDACTED]

It seems crazy but its true Josh powell got mixed up with the wrong people! Suprised honestly that no one has said anything and that there keeping solid! I've heard that if the reward was higher people would talk but that's just word of mouth! Here again is what I know about Josh Powell! He liked strip clubs, he was known to call live links, chat phone service, he used Craigslist an Adult friend finder where he meet [REDACTED] and [REDACTED] who were looking for dates/escort all this info checked out when Detectives looked into it after I gave it he sometimes went by different names, John, Joe, I hungout with him on numerous occasions, [REDACTED], [REDACTED] house parties, he was possessive and controlling during the time towards [REDACTED] if other guys would touch or mess around! He drove a Dark colored van on the times he drove! He acted like he was rich always had a stack of money most likely it was a once but I know he bought [REDACTED] stuff and liked to flaunt money and items! I was told by [REDACTED] that the reason Josh killed ~~Susan~~<sup>Susan</sup> was she was planning to leave him and take the kids after she found out about his infidelities! Josh also wanted be without his kids and knew the courts would grant Susan custody! I was told she was stabbed to death! Y and me both know she is Dead! we know Josh didn't camping! He didn't bury the body there was snow and ground was frozen! only one other person knows were Susan Powells remains are and that's [REDACTED] believe it or not! She Scared I was told she would come forward for immunity from prosecution! But I have a feeling y'all think she doesn't do

Its been 2 years since the day she was last seen alive  
next year will be 3 and the next will be 4! I'm  
trying to help you get this case solved for her family  
and friends sake and also because not a day goes by  
that I should have come forward after the first phone call  
at the Salt Lake County Jail I feel guilty and ashamed but  
in the criminal world you don't snitch or talk with cops  
look at this time I can't give you an exact location  
of her remains I have a clue and an idea from  
a couple ~~years~~ years ago when I spoke with [REDACTED] in  
County Jail I haven't told y'all because I wanted to get  
more concrete info plus I have a feeling y'all don't  
believe what I'm saying! look I can assist you in solving  
this case its been 2 years and still not solved I believe  
you making progress but in the end its all going to  
come back to the info I'm trying to give y'all! I have  
24 months left in prison the board is willing to release  
me earlier with letters from other agencies I have gotten  
1 letter from postal inspector Freemantle for giving him  
info that solved a case in [REDACTED] I got a 3 month  
time cut! I need your help in getting the rest of these  
cases I have info on solved I can give you info on  
lots of Robberies, burglaries, and other shit I need someone  
who will listen and look into them and get them solved  
I'm willing to give up a lot of people so I can help  
assist you with this case in return help me get time  
cuts so [REDACTED] I can get out and we can  
solve this case! We disrespect but to far in 2 years will

still be in the same boat 4 years without a body I know if I can locate [REDACTED] talk her into coming in to talk that this will be solved and everyone happy! This isn't a joke it isn't a game I'm willing to do whatever you need so this gets solved I'm tired of it being on my conscious all the time! look I want talk with who ever is over the case give them a few more names of people I know who know her and seen her give a little more info I think might help as well!

I was hoping y'all could contact the Draper prison and have them move me back up there from Gunnison so I can be closer for local agencies to come talk with me im going to great lengths to try to get out to help y'all! Help me help you is all I'm asking and best thing is to assist me in getting back to [REDACTED] to be close to the agencies I have info for so they don't have to travel so far and I can gain more info up there from inmates then down here also im getting in contact with certain agencies to give info I know y'all work together in the end it will benefit us all if y'all help me! It sounds desperate and it is but I know y'all can help me get back to Draper prison and I can help solve a lot of open cases as well as assist in yours so I hope to hear from y'all in the near future let's get this solved please help me help y'all Draper would be best place for me and easiest for you thanks for your time
