37 BP: ALRIGHT UM I THINK WE'LL JUST RUN AND WE'LL JUST HAVE YOU
38 TALK FOR NOW AND IF WE HAVE QUESTIONS OR EITHER WAIT FOR
39 YOU TO BE DONE OR WE'LL INTERRUPT YA AND KIND OF HAVE YOU
40 CLARIFY US. SO TELL US KIND OF WHAT YOU KNOW ABOUT SUSAN
41 ■ UM, SHE IS VERY OPEN. SHE WOULD UM TELL YOU THINGS JUST
42 LIKE, WAIT WAIT A SECOND TMI SOMETIMES. (LAUGH, LAUGH)

90 EARLY. THERE WAS ONE TIME I WENT OVER THERE AND HAD HER
