77 MF: HOW RECENT WAS THE THOUGHT OF HER BEING PREGNANT?

78 ■ TWO WEEKS AGO

79 MF: THAT SHE THOUGHT SHE MIGHT BE?

80 ■ UM HUH SHE WAS ACTUALLY POSITIVE SHE WAS PREGNANT BUT THE

81 TESTS WERE TELLING HER THAT SHE WASN'T  
82 MF: UM HUH K AND YOU'VE SEEN HER SINCE THEN?  
83 ■ UM HUH YEAH I HAVE WE ACTUALLY SHE STOPPED AND STOPPED AT MY  
84 DESK AND WE TALKED FOR ABOUT AN HOUR WHILE WE WAITED FOR HIM  
85 TO PICK HER UP BUT IT WASN'T ANYTHING IT WAS JUST GENERAL WORK

87 GC: (COUGH) WHEN HE PICKED HER UP FROM WORK WOULD SHE GENERALLY  
88 WAIT AND THEN HE'D CALL WHEN HE GOT HERE?

98 TO WAIT FOR A HALF AN HOUR SO IT WAS AN HOUR AND A HALF AFTER

101 ■ 5:30 SO IT WAS AN HOUR AFTER HER NORMAL TIME THEN THAT'S RIGHT  
102 SHE GETS OFF AT 5:30 ■ GETS OFF AT 5 SO YEAH  
103 GC: SO IT WAS 6:30  
104 ■ UM HUH  
105 GC: AND BEFORE HE GOT HERE?  
106 ■ RIGHT  
107 GC: OK HOW LONG HAVE YOU KNOWN SUSAN?  
108 ■ PROBABLY AS LONG AS SHE'S WORKED HERE. IM REALLY BAD WITH TIME  
109 IM GONNA SAY TWO YEARS IVE BEEN HERE THREE SO I THINK SHE'S BEEN

110           HERE SOMEWHERE IN THAT AREA

111   GC:   OK SO AS SOON AS SHE STARTED WORKING HERE

113   GC:   YOU MET HER AND YOU GUYS KIND OF BECAME FRIENDS?
