105 GOT THE THERE EMERGENCY CONTACT CARD AND I CALLED UM THE
106 FIRST NUMBER ON THE LIST WHICH WAS HIS SISTER AND I GOT HER
107 ANSWERING M...MACHINE AND I SAID YOU KNOW JOSH AND SUSAN
108 DIDN'T SHOW UP THEY DON'T NORMAL THIS IS NOT LIKE THEM IM VERY
109 CONCERNED IVE CALLED THERE THERE CELL PHONE OR I CALLED SUSANS

113 THAT ABOUT TEN MINUTES LATER JOSH'S MOM CALLED ME BACK [REDACTED]

195 THIS IS HOW I FIRST CAME IN CONTACT WITH THEM THEY CALLED ME OFF
196 OF THE STATE IM ASSUMING OFF OF THE STATE LIST I AM IM A LICENSED

197 FAMILY CHILD CARE PROVIDER SO I IM LICENSED THROUGH THE CITY THE
198 STATE HEALTH DEPARTMENT AND IM ON THEIR WEBSITE

201 REASON WHY IVE TRIED TO KIND OF STAY AWAY FROM THE NEWS AND

203 BE OR BE PRINTED BECAUSE I DIDN'T WANT THE OTHER KIDS THAT I CARE
204 FOR TO BE AT RISK SO THAT WAS ONE OF THE REASONS WHY

206 ■ I KIND TRIED TO KEEP IT YOU KNOW IF ANYBODY ASKED

207 BP: UM HUH

208 ■ YOU KNOW TRY TO KEEP IT LOW KEY BUT THEY CALLED UM ON MY CELL
209 PHONE WHICH I COULDN'T GET TO WORK UP IN THE CANYONS BUT WHEN
210 I CAME I CAME DOWN FOR A A TEMPLE WEDDING AND THERE WAS LIKE
211 EIGHT CALLS FROM HIM THAT HE WANTED TO BRING KIDS TO CHILD CA...

213 ■ FOR DAY CARE AND IT JUST SO HAPPENED WHILE I WAS THERE HE ACT...I
214 ACTUALLY ANSWERED MY PHONE AND IT WAS HIM AND HE SAID WE
215 WANT TO BRING THE KIDS TO CA....DAYCARE AND I SAID WELL RIGHT
216 NOW I CANT TALK TO YOU ABOUT DAYCARE IM HERE AT THE TEMPLE
217 GOING TO A WEDDING AND AFTER I GET DONE HERE IM GOIN BACK UP TO
218 CAMP GIRLS CAMP WITH MY CHURCH SO IM NOT GONNA BE HOME FOR
219 ANOTHER COUPLE DAYS WHEN I CAME HOME UM FRIDAY UM WE HAD AN

232 ■ THIS WAS A YEAR AGO JULY SO I FIN...I HE CAME TO VISIT ME FRIDAY
233 NIGHT AND HE WAS LATE TO HIS APPOINTMENT AND THEN I SAID I CAN
234 ONLY TALK TO YOU FOR A FEW MINUTES BECAUSE WERE GOING TO A
235 WEDDING AND THE EXPERIENCE THAT NIGHT WAS JOSH SHE HAS A
236 WEDDING WE HAVE TO GO JOSH SHE HAS TO GO THEIR WAITING THERE
237 WE WERE DRESSED AND READY TO GO
