117 UK: DO YOU KNOW BY CHANCE IF HE WORKS

118 JC: YEAH AS FAR AS I KNOW HE WORKS FOR I THINK (INAUDIBLE) COMPANY  
119 HE'S A SALES PERSON AND SHELBY WANTED TO AND SHE'S A REALTOR  
120 YOU KNOW IN PROFESSION RIGHT NOW BUT SHE WAS A POLICE OFFICER  
121 UM SHE JUST (INAUDIBLE) DRIVE BY GET THERE ADDRESS AND A SEE  
122 WHAT THE VEHICLES IN THERE AND THEY HAVE TWO VANS THAT I KNOW  
123 OF BUT I DON'T KNOW ABOUT ANY OF THE OTHERS BUT I DIDN'T GET A

135 JC: THE MOM AND FATHER DIVORCED A LONG TIME AGO I GUESS JOSH WAS  
136 SIXTEEN THAT'S ALL WE KNOW (INAUDIBLE) SUSAN WOULD TELL ME THIS  
137 AND THE FATHER HAS MENTAL PROBLEMS TO IN MY MY

140 GC: OK

141 JC: AND UM ONE REASON WHY SHE DIVORCED HIM SHE'S BUT SHE WAS  
142 TELL...AND SHE THIS INCIDENT THAT MY HUSBAND TOLD YOU ABOUT  
143 SHE WENT TO THE MOTHER ABOUT IT AND SHE GOES OH NO I CANT  
144 BELIEVE HE DID THIS TO YOU AND SAID YES THIS IS TRUE SO I I KNOW  
145 THAT ITS TRUE SHE SAID YES THIS IS TRUE THIS HAPPENED

146 GC: SUSAN SAID IT WAS? OK

147 JC: YEAH SO SHE SHE SHE WAS JUST VERY STUNNED AND DIDN'T KNOW  
148 WHAT TO MAKE WITH IT THEN JUST DIDN'T WANT TO BE AROUND HIM IN  
149 ANY ANY WAY SO AND JOSH TOOK IT AS WHATS THE BIG DEAL AND I JUST  
150 ANYWAY UM SO I TOLD MY HUSBAND I SAYS WOULD YOU GO DOWN  
151 THERE YOU NEED TO TALK TO HIM FACE TO FACE ABOUT THAT BECAUSE  
152 THAT IS A MENTAL ISSUE OR SOMETHING AND AND I GUESS I HAVE ALL  
153 THE'SE CRAZY THINGS GOIN IN MY MIND IM THINKIN IF IT WENT TO  
154 COURT AND EVERYTHING HE'D PROBABLY GET OFF ON INSANITY AND IM  
155 SCARED OF THAT JUST BECAUSE HE ASKS SO STRANGE AND SO AND SO

163 JC: OH HIM PERSONALLY I THINK ITS BEEN MORE THAN A YEAR IT COULDA I  
164 COULD OF SAID SOMETHING WHEN I WAS CALLIN FOR SUSAN ON THE  
165 PHONE BUT WE GE...GOT HER HER A PHONE CAUSE WE WERE AFRAID FOR  
166 HER THAT'S WHY WE DECIDED YOU HAVE THIS PHONE JOSH DOES NOT  
167 TOUCH IT AND A BUT THAT WAS WHEN THEY HAD A HOME PHONE AND I

168 THINK THAT'S BEEN A COUPLE YEARS

170 JC: AND THAT SO AS FOR REALLY TALKING TO HIM IT'S BEEN OVER A YEAR

171 GC: WHEN WAS THE LAST TIME YOU SAW HIM?

172 JC: IT COULD BE POSSIBLY A LAST FEBRUARY

173 GC: THE LAST TIME YOU SAW HIM?

174 JC: YEAH CAUSE THEY CAME FOR A SHORT VISIT

175 GC: OK

176 JC: FOR A WEEK OR SO

177 GC: OK DID THEY STAY HERE WITH YOU GUYS?

178 JC: UM AT ONE POINT HERE AND THEN SOME OF IT OVER THERE AND SUSANS

179 VERY UNCOMFORTABLE OVER THERE AND SO BUT SHE DOESN'T WANT TO

180 CAUSE A PROBLEM WITH THE KIDS AND SHE'S AFRAID TO HAVE THE KIDS

181 WITH JUST THEM SO IT'S REALLY A SACRAFICE FOR HER TO

182 GC: RIGHT

183 JC: SO UM...

184 GC: WELL YOU YOU KNOW AND THAT'S UM I HAVE TO GIVE HER A LOT OF

185 CREDIT BECAUSE FROM WHAT IM SURE YOU GUYS KNOW BUT YOU KNOW

186 WERE JUST FINDING THIS OUT IN THE LAST WEEK BUT UM SHE'S DONE A

187 LOT TO TRY TO

188 JC: UM

189 GC: SAVE THE MARRIAGE AND AND MAKE IT BETTER

190 JC: WE'VE BEEN WORKING ON THIS REALLY I'D WISH IT WOULD COME OUT.

191 YOU KNOW IF IT COMES OUT MORE ABOUT HER (INAUDIBLE) SHE'S BEEN

192 WORKIN ON THIS FOR THREE YEARS AT LEAST WORKIN THEIR MARRIAGE

193 AND SHE'S JUST HAD CERTAIN PRIORITIES AND THINGS THAT HE HAD TO

194 THAT HE WAS MEETING IN THE BEGINNING HE SEEMED LIKE A FINE

195 PERSON IN THE BEGINNING AND FOR A COUPLE YEARS THEY WERE OK

196 AND THEN IT JUST I'D SAY BY YEAR THREE WHEN HE WAS JUST REALLY

197 BEIN STRANGE BUT IN THE BEGINNING HE WAS LIKE NO CONCEPT OF TIME  
198 YOU KNOW AND YEAH ILL BE OVER THERE IN A HOUR IT COULD BE FIVE  
199 HOURS LATER OR SOMETHING IT IT JUST HE WAS A JUST VERY DIFFERENT  
200 AND WE THOUGHT OK WELL YOU KNOW HE NEEDS TO WARM UP AND YOU  
201 KNOW TO OUR FAMILY DIDN'T THINK MUCH OF IT BUT A WE JUST CHUCK  
202 AND I ALWAYS FELT A LITTLE DIDN'T FEEL COMFORTABLE WITH HIM  
203 AROUND SOMETHING ABOUT HIM.

204 GC: HOW LONG DID YOU KNOW JOSH BEFORE THEY GOT MARRIED? DID THEY  
205 DATE FOR AWHILE OR?

206 JC: IT WAS FIVE MONTHS AND THEY WERE MARRIED I THINK

207 GC: AND THAT'S THE FIRST THAT FIVE MONTHS PRIOR TO THEM GETTING  
208 MARRIED IS THAT THE FIRST TIME YOU'VE EVER MET HIM?

209 JC: YES

210 GC: OK

211 JC: YEAH AND AT THE TIME HE SEEMED NICE

212 GC: AT FIRST HE WAS?

213 JC: YEAH

214 GC: WHAT UM HOW DID THEY MEET DO YOU REMEMBER?

215 JC: AT A SINGLES AT CHURCH A CONFERENCE OR A YOU KNOW BEING L.D.S  
216 AND THEY HAVE LIKE A SINGLES WARD AND STUFF LIKE THAT AND GOSH  
217 MAYBE YOU SHOULD TALK TO THE BISHOP THAT WAS THERE BISHOP BUT  
218 NOW I DON'T REMEMBER WHO THAT PERSON IS MY HUSBAND WOULD  
219 HAVE TO TELL YA

220 GC: THAT'S HERE LOCALLY?

221 JC: YEAH WELL ACTUALLY IN TACOMA

222 GC: UM

223 JC: UM BUT YEAH AND AND WE WERE UPSET HUH (CHUCKLE) (INAUDIBLE)  
224 MARRIED WE TRIED TO TALK HER OUT OF IT SHE ALMOST QUIT SHE  
225 ALMOST SAID IT'S A... YOU KNOW WERE NOT GETTING MARRIED AND I



226 WISH I WOULD HAVE PUSHED MORE ON THAT  
227 GC: BY THAT POINT WERE YOU NOT?  
228 JC: HE A HE WAS JUST HE DID A STRANGE THING AT A BRIDAL SHOWER AND  
229 IT IT FREAKED HER OUT AND I SAID THAT'S JUST NOT RIGHT BUT  
230 EVERYONE LAUGHED AT IT AND I I I JUST I WASN'T THERE  
231 GC: WHAT CAN YOU ELABORATE ON THAT?  
232 JC: HE CAME IN DRESSED LIKE A GIRL AND STARTED ACTING AND WE  
233 THOUGHT THIS IS JUST CAUSE HE WANTED TO BE A PART OF THE BRIDAL  
234 SHOWER THAT'S REALLY FOR GIRLS  
235 GC: RIGHT  
236 JC: AND HE JUST DECIDED HE'D BE A GIRL THAT NIGHT AND THAT BOTHERED  
237 HER A LOT SO WE THINK HAD  
238 UK: (INAUDIBLE)  
239 JC: I GUESS THAT'S BASICALLY WHAT (INAUDIBLE) THE WAY HE ACT AND  
240 TALKED AND AND SHE JUST THAT WAS BOTHERED HER AND SHE TOLD ME  
241 ABOUT IT AFTER THEY'D BEEN MARRIED FOR A FEW YEARS AND I  
242 THOUGHT AND YOU MARRIED HIM I ANYWAY I JUST WAS THAT'S MY  
243 OPINION  
244 GC: WHEN DID THEY GET MARRIED WHAT YEAR?  
245 JC: A 2001  
246 GC: OK  
247 JC: AND IT WAS APRIL 6TH HAD TWO MARRIAGES THAT WERE IN TWO WEEKS  
248 UK: (LAUGHING)  
249 JC: I HAD  
250 GC: (COUGH)  
251 JC: ONE MARCH 24<sup>TH</sup> AND APRIL 6<sup>TH</sup> I THINK THEY WERE DOIN COMPETITION  
252 GC: (LAUGHING)  
253 JC: THEY BOTH SHOULDN'T HAVE GOTTEN MARRIED  
254 GC: A BUSY TIME

255 JC: YEAH  
256 GC: THAT'S A BUSY TIME TRYIN TO DEAL WITH ALL THAT ANYTHING ELSE  
257 YOU CAN THINK OF OR? I MEAN IT'S GOOD THAT YOU BRING THAT UP  
258 BECAUSE WHAT YOU HAD MENTIONED UM BECAUSE ON THE OFF CHANCE  
259 THAT WE DON'T KNOW SOMETHING SO ANYTHING YOUR THINKING THAT  
260 WE...  
261 UK: (INAUDIBLE) WE WERE A LITTLE SURPRISED THAT HE TOLD US DON'T  
262 WORRY ABOUT IT LIKE HE WAS ASKING IF WE WOULD HAVE ANY OTHER  
263 PERSON OR MAYBE YOU SHOULD FOLLOW UP ANOTHER WAY INSTEAD OF  
264 JOSH

266 JC: WELL (INAUDIBLE) STILL IS GONE  
267 GC: RIGHT  
268 UK: YEAH RIGHT  
269 JC: A I WILL TELL YOU OUT HERE IN THE SUMMER TIME AND I KNOW IT WAS A  
270 YEAR AGO OR TWO YEARS AGO I THINK IT WAS TWO YEARS AGO  
271 UK: (INAUDIBLE) TWO YEARS AGO  
272 JC: AND MARY WAS OUT HERE VISITING SHE'S IN WASHINGTON DC AND  
273 SUSAN WAS GONNA DO HER HAIR AND SHE PLANNED THIS THIS IS WHEN  
274 THEY (INAUDIBLE) UP FROM UTAH AND WERE GONNA SPEND A WEEK OR  
275 TWO AND BASICALLY SHE SHE ACTUALLY UM PLANNED THINGS  
276 THROUGH JOSH LIKE I WANT TO DO THIS ON THIS DAY FOR SO AND SO IS  
277 THAT OK? AND SHE GETS TO ASK FOR HIS PERMISSION AND SHE PLANS IT  
278 SO THAT HE CAN WATCH THE KIDS SO SHE CAN DO THIS FOR HER AND SHE  
279 JUST WANTED TO HIGHLIGHT HER SISTERS HAIR AND TRIM OR  
280 SOMETHING JUST AND UM HE SAID NO PROBLEM BUT WHEN THAT DAY  
281 ARRIVED SHE WAS WORKING AND I WAS TRYING TO WATCH THE KIDS

285 JC: AND THERE WAS LIKE SIX KIDS BETWEEN THEM AND AT THAT TIME AND  
286 IM GOING CAUSE MARY HAD A LITTLE GIRL AND THEY WERE ALL  
287 GETTING TIRED AND FUSSY AND YOU KNOW HOW IM SURE YOU

289 JC: MARRIED AND HAVE KIDS THEY GET TIRED AND AND THEY NEED TO BE  
290 HELPED AND I COULDN'T HELP THEM CAUSE I NEEDED TO FIX DINNER  
291 WELL POOR CHAD WAS TRYIN TO DO IT ALL

292 UK: (INAUDIBLE)

293 JC: JOSH WAS UP HERE UPSTAIRS AND WORKIN ON THE COMPUTER AND I  
294 SAID JOSH WILL YOU PLEASE GO DOWN AND HELP CHAD BECAUSE  
295 SUSANS ALMOST DONE BUT YOU KNOW LET HER FINISH AND HE JUST  
296 IGNORED ME AND THEN CHAD CAME UP TWO TIMES PLEASE COME DOWN  
297 SOME OF THE KIDS ARE YOURS YOU KNOW

298 GC: UM HUH

299 JC: AND HE DIDN'T WOULDN'T COME DOWN AND THEN CHAD WENT UP AND  
300 JUST SWORE WHICH I HATE AND ANYWAY BUT IT GOT JOSH MOVIN MAN  
301 AND AND I SAYS JOSH HE'S RIGHT YOU NEED TO HELP SO I CAN GET  
302 DINNER ON AND THEN THE KIDS CAN GET FED YOU KNOW AND HE HE  
303 JUST WAS IN HIS OWN WORLD IS WHAT I GUESS MY POINT IS HE'S KINDA  
304 IN HIS OWN LITTLE WORLD AND WHENEVER HE FEELS IS THAT TIME THAT  
305 EVERYONE ELSE CAN TOUGH IT OUT HE'S RIGHT AND THERE WRONG AND  
306 HIS ATTITUDE IS THAT AND WE HAD WORDS THAT DAY AND HE STARTED
