41 WAS OUT OF PLACE BECAUSE I HAD JUST FINISHED I, I REMEMBER I  
42 WAS WALKING DOWN THE HALL AND I WAS AH, I HAD JUST

44 THE PURSE IN THE OTHER ROOM AND THEN THE, THE FANS AND

64 PHONE NUMBER LATER FOR CHUCK, I CALLED CHUCK THE FIRST  
65 TIME AND YOU KNOW AND THEN THESE ARE JUST MY PHONE CALLS  
66 WITH ■ WITH CHUCK THERE IN YELLOW UM AND THEN  
67 LATER WITH JOSH, THIS IS THE FIRST TIME AH YEAH I TRIED TO  
68 CALL HIM HERE BOTH OF THEM AGAIN BUT LATER ON AT 4:48 P.M. I  
69 DIDN'T REMEMBER IT BEING THAT EARLY BUT FROM THE TIME

70 EM: UM HUH.

71 ■ I WAS GONNA LOOK IT UP ON MY PHONE RECORDS AH YEAH IT WAS  
72 TOTALLY BY ACCIDENT THAT I WROTE THAT DOWN. BUT UM IT  
73 WAS THE FIRST TIME JOSH CALLED ME THAT NIGHT AND THEN OF  
74 COURSE

75 EM: AFTER 4:48?

76 ■ WHEN WE WERE USING MY PHONE

77 EM: THAT'S WHEN I CALLED HIM?

78 ■ UH HUH

79 EM: AT 5:27?

80 ■ YEAH, SO THIS IS, THIS IS EVERYTHING FROM THAT DAY

81 EM: OH

82 ■ AND A FEW DAYS LATER

83 EM: OKAY.

84 ■ SO NOT THAT THE NEXT DAYS PROBABLY MEAN A LOT BUT

85 EM: OKAY.

86 ■ I JUST PRINTED OFF THAT WHOLE WEEK

87 EM: RIGHT...ALRIGHT PERFECT.

88 ■ BUT.

89 EM: UM NOW AS FAR AS.....OKAY....I GUESS LET'S JUST GO BACK LET'S  
90 JUST LOOK AT THIS. UM....SO THE LAST TIME YOU SPOKE WITH  
91 SUSAN ON THE PHONE WAS ON THE 3<sup>RD</sup> OF DECEMBER.

92 ■ YEAH THAT WAS WEDNESDAY AFTERNOON

93 EM: OKAY

94 ■ LATE AFTERNOON.

95 EM: DID YOU SPEAK TO HER ON THE 4<sup>TH</sup>, 5<sup>TH</sup>, OR 6<sup>TH</sup>?

96 ■ NOT THAT I REMEMBER.

97 EM: OKAY AND SO THAT LOOKS LIKE YOU WENT INTO THE HOUSE AND  
98 CALLED

99 ■ I BELIEVE THAT, I BELIEVE THAT MY ■ TALKED TO HER  
100 THOUGH ANOTHER COUPLE DAY OR TWO AFTER THAT WE WE'RE  
101 PLANNING BUT I'M NOT SURE ABOUT THAT I COULD ASK HER OR  
102 YOU COULD TALK TO HER I COULD GIVE YA HER PHONE NUMBER  
103 OR WHATEVER BUT.

104 EM: SO YOU CALLED ■ ON THE 7<sup>TH</sup> AT 9:50.

105 ■ UM HUH. SEE THAT WAS, THAT WAS ANOTHER THING THAT WAS  
106 INTERESTING ME I, I DIDN'T REMEMBER CALLING HER CELL PHONE  
107 AND THEY DON'T GET VERY GOOD RECEPTION OUT THERE SO SHE  
108 MUST HAVE BEEN STANDING IN JUST THE RIGHT PLACE IN THAT  
109 HOUSE

110 EM: YEAH.

111 ■ TO GET RECEPTION

112 EM: RIGHT

113 ■ AND I YOU KNOW AND IF THEY WERE AT THE HOUSE I'M ASSUMING  
114 THEY WERE AT THE HOUSE I DON'T KNOW, BUT I DID THINK IT WAS  
115 ODD THAT MY DAD WAS AT HOME WHEN I REALIZED THAT LATER  
116 AND MADE THAT CONNECTION LIKE HE WAS ON SPEAKER PHONE,  
117 WHAT THE HECK IS HE DOING ON A MONDAY AT HOME, AND THEN I  
118 ASKED HER LATER YOU KNOW JUST TO TRY AND BE CASUAL WHEN  
119 THEY WERE HERE I WAS LIKE, SO DOES MY DAD OR SO DOES DAD  
120 UM WORK FROM HOME A LOT OR YOU KNOW, SHE'S LIKE OH  
121 OCCASSIONALLY HE DOES YOU KNOW BUT THAT'S ONE OF THE  
122 THINGS THAT I, I ADDED MORE THOUGHT TO THE END OF THIS  
123 STATEMENT UM I, I DID DO SOME MODIFICATIONS THROUGH HERE  
124 BUT AH I THINK IT'S WEIRD.

125 EM: SO STEVE WAS HOME ON THE 7<sup>TH</sup> MONDAY.

126 ■ HE WAS.

127 EM: AT 09:32 HOURS.

128 ■ OR AT LEAST HE WAS WITH MY ■

129 EM: YEAH.

130 ■ SO WAS HE AT HOME I DON'T KNOW I'M ASSUMING THEY WERE AT  
131 HOME BUT I REALLY DON'T KNOW ENOUGH CAUSE I WAS THEY,  
132 LIKE I SAID SHE WAS ON HER CELL PHONE.

133 EM: THAT IS INTERESTING. UM...SO WHAT DO YOU REMEMBER AS FAR  
134 AS AH WHEN YOU WERE ON THE PHONE WITH ■ AND YOU'RE  
135 TELLING HER ABOUT THESE THINGS, AT THIS POINT WE, WE THINK  
136 THE WHOLE ENTIRE FAMILY IS MISSING CORRECT?

137 ■ OH YEAH.

138 EM: I MEAN AT THAT TIME.

139 ■ EXACTLY YEAH WE THOUGHT THAT EVERYBODY WAS GONE.

140 EM: AND STEVE MAKES THE COMMENT, "I BET IT'S THAT GUY SUSAN'S  
141 BEEN HANGING OUT WITH."

143 EM: AT 09:00 O’CLOCK ALMOST 10:00 O’CLOCK IN THE MORNING HE  
144 MAKES THAT STATEMENT.  
145 ■ YEAH IT WAS.  
146 EM: AND HE’S WITH ■ AND HE SHOULD BE AT WORK.  
147 ■ IT WAS EITHER 11:05 OR 12:57 P.M. IT WAS ONE OF THOSE CALLS  
148 THAT I FIGURED THE 11:05 ONE NEAR THE END UM YEAH I JUST  
149 WROTE MY DAD WAS ON SPEAKER PHONE WITH ■ AND SAID  
150 SOMETHING LIKE, “I BET IT WAS THAT WEIRD GUY SUSAN WAS  
151 SEEING IN HER WARD A LOT, JOSH SAID SHE’S BEEN SPENDING A  
152 LOT OF TIME WITH HIM LATELY I BET HE WENT HE WENT  
153 (INAUDIBLE) ■ THAT WAS JUST MY I MEAN THAT’S NOT HIS  
154 EXACT WORDS.  
155 EM: UM HUH.  
156 ■ BUT  
157 EM: SO  
158 ■ I JUST THOUGHT THAT WAS THE STUPIDEST THING IN THE WORLD.  
159 EM: DID STEVEN SAY ANYTHING ELSE, I MEAN WAS HE LIKE WAS HE  
160 SURPRISED THAT THE FAMILY WAS MISSING?  
161 ■ YOU KNOW WHAT I DIDN’T HEAR HIM NOW YOU ALSO HAVE TO  
162 UNDERSTAND THAT I BLOCK HIM OUT (LAUGH, LAUGH) SO I  
163 REALLY WASN’T PAYING THAT MUCH ATTENTION UNTIL HE SAID  
164 THAT AND I WAS JUST LIKE, WHOO WHERE DID THAT COME FROM!

166 ■ SO HE MAY HAVE SAID OTHER THINGS IN THE BACKGROUND AND I  
167 JUST DIDN'T CATCH THEM BEFORE, BUT I WAS MOSTLY TALKING TO

169 FIRST TIME LET'S SEE THE FIRST TIME LIKE I CALLED I WAS LIKE  
170 DID YOU DO YOU KNOW WHERE JOSH, JOSH IS, HAVE YOU HEARD  
171 FROM HIM LATELY AND SHE SAID THAT DAD SAID THAT HE CALLED  
172 AT 12:00 OR 12:30 RIGHT AROUND SUNDAY ABOUT A PANCAKE  
173 RECIPE. WHICH IS ANOTHER BIZAAR THING I'M, I'M THINKING  
174 ABOUT THAT THESE LAST WHOLE DAYS AND I'M LIKE WHY IS HE  
175 ASKING FOR A PANCAKE RECIPE BECAUSE THEY WERE CRITISIZING  
176 HAVING A CONVERSATION WITH MY ■ ■

177 EM: UM HUH

178 ■ UM JUST A FEW WEEKS AGO BECAUSE I WAS TELLING HER ABOUT  
179 THE WHOLE THEORY ABOUT YOU KNOW POISONING AND UM SHE  
180 SAID THAT HE ACTUALLY MADE THEM PANCAKES, IT WAS EARLY  
181 SUMMER WHEN THEY WERE PLANTING THEIR GARDEN, SHE WENT  
182 OVER TO HELP BECAUSE JOSH TOLD HER THAT SHE COULD YOU  
183 KNOW SHARE IN THE, IN THE AH HARVEST IF SHE CAME OVER AND  
184 HELPED PLANT THE GARDEN, SO HE MADE PANCAKES AND STUFF  
185 FOR HER THAT DAY. SUSAN WAS STILL THERE YOU KNOW HER  
186 KIDS, HIS KIDS UM AND HE MADE PANCAKES. I'M LIKE OKAY THEN  
187 THE OTHER THING WAS THAT IN THAT UM E-MAIL ABOUT THE UM...  
188 THE CAMPING TRIP THAT THEY WENT ON AND DID HE AND YOU  
189 SAW THE, THE ATTACHMENT SHE HAD WHERE SHE DETAILED THAT  
190 A BUNCH OF STUFF ABOUT WHERE AND WHEN THEY WENT TO THE  
191 WEST DESERT.

193 ■ ANY WAY SHE TALKED ABOUT HOW HE MADE PANCAKES AND  
194 EGGS AND SAUSAUGE THAT MORNING

195 EM: UM HUH.

196 ■ AND IT WAS WONDERFUL AND SHE ONLY WISHES THAT SHE COULD  
197 GET HIM TO MAKE FOOD MORE OFTEN OR SOMETHING LIKE THAT.  
198 WELL HE MADE PANCAKES....AND I'M JUST THINKING LIKE OKAY  
199 HE MADE PANCAKES ON DECEMBER 6<sup>TH</sup>.  
200 EM: UM HUH.  
201 ■ THAT HE HAD TO CALL MY DAD FOR A RECIPE THAT DOESN'T MAKE  
202 ANY SENSE.  
203 EM: UM HUH.  
204 ■ ANY WAY SO.  
205 EM: BECAUSE HE'S MADE PANCAKES TWO TIMES AT LEAST THAT YOU  
206 KNOW OF IN THE PAST.  
207 ■ AT LEAST SO THEY HAVE A RECIPE SOME WHERE AROUND THERE  
208 EM: OKAY.  
209 ■ THAT HE'S FAMILIAR WITH THE PROCESS  
210 EM: YEAH.  
211 ■ HE HAS A BETTER HOME AND GARDEN COOKBOOK IF NOTHING  
212 ELSE. WHY IS HE CALLING MY DAD AND HE DOESN'T (INAUDIBLE)  
213 SPEND A LOT OF TIME ON THE PHONE SO A SHORT CALL FOR A  
214 PANCAKE RECIPE  
215 EM: WHO DOESN'T  
216 ■ IS WEIRD, JOSH AND MY DAD  
217 EM: YOU DON'T THINK THEY TALK ON THE PHONE THAT OFTEN?  
218 ■ OH NO THEY TALK ALL THE TIME  
219 EM: OH.  
220 ■ BUT WHEN THEY TALK IT'S USUALLY A LONG PERIOD OF TIME.  
221 EM: OH OKAY  
222 ■ IT'S NOT LIKE A TEN MINUTE PHONE CALL.  
223 EM: OKAY  
224 ■ AND  
225 EM: RIGHT



226 ■ NOT THAT I KNOW I MEAN YOU HAVE HIS PHONE RECORDS MAYBE  
227 HE CALLED SOME TIME AND THEN JUST YOU KNOW

228 EM: YEAH

229 ■ IS ON FOR FIVE MINUTES I REALLY DON'T KNOW.....THE OTHER  
230 THING I WROTE AT THE BOTTOM OF HERE AND YOU'VE PROBABLY  
231 ALREADY THOUGHT ABOUT IT, BUT IT OCCURRED TO ME  
232 YESTERDAY I'M IN THE MIDDLE OF A CHURCH MEETING FOR MY  
233 DAUGHTER AND I WAS LIKE TRYING NOT TO BALL BUT UM, UM IF

245 GOING BACK THROUGH AH MY EARLY LIFE EVEN BEGINNING WITH  
246 MY DAD'S EARLY LIFE UM AND THEN YOU KNOW SOME STUFF  
247 ABOUT JOSH AND SUSAN AND OF COURSE AH SOME OF THAT'S JUST

258 ■ CAN I JUST READ YOU THIS PARAGRAPH IS THAT OKAY?  
259 EM: YEAH  
260 ■ OKAY  
261 EM: IS THAT YOU GOT SOMETHING YOU WROTE NOW?  
262 ■ UM HUH YEAH.  
263 EM: OKAY.  
264 ■ I TRIED TO FIND IT WAS 6:00 OR 6:30 THEN ACCORDING TO THE CELL  
265 PHONE RECORDS IT'S 4:48 UM I PUT IT, CAUSE MY CELL PHONE  
266 RANG I LOOKED INCREDIOUSLY AT THE CALLER I.D. JOSH AND  
267 SUSAN POWELL WAS I SEEING THAT RIGHT OR JUST WISHING, I  
268 ANSWERED IT AND IT WAS JOSH AND I SCREAMED INTO THE PHONE,  
269 "WHERE HAVE YOU BEEN? WE'VE BEEN WORRIED SICK ABOUT YOU  
270 IS SUSAN WITH YOU?" HE SAID, "NO". I ASKED HIM, "WHERE IS SHE?"  
271 HE YELLED RIGHT BACK THAT HE DIDN'T KNOW. I BELIEVE IT WAS

295 STUFF, MORE DETAILS THE TIME THAT I
