27 EL: YEAH THAT'S ALRIGHT IT SLIDES

28 SO: OH WELL I BROUGHT THIS THING TO BECAUSE WHAT WE DO IS WE HANG A

29 MICROPHONE ON YOUR SHIRT SO I DON'T KNOW AH THAT WAY THIS WAY

30 WE CAN ADJUST THE HEIGHT OF IT TO APPROPRIATE SO WE'LL SEE IF WE

61 SO: READ THROUGH THIS AND THEN AH SIGN IT AND WE'LL GO ON FROM
62 THERE. AND THE KEY THING TO REMEMBER ABOUT THIS WHOLE PROCESS
63 EL: AH HUH
64 SO: THIS IS REALLY INTERACTIVE PROCESS SO
65 EL: OKAY
66 SO: IF THERE'S ANYTHING THAT COMES TO YOUR MIND AS WE'RE TALKING
67 OR WHATEVER
68 EL: AH HUH
69 SO: JUST ASK ME
70 EL: OKAY
71 SO: I DON'T WANT THERE TO BE THERE'S NO TRICKS TO THIS GAME, THERE'S
72 NO ANYTHING WE'RE TRYING TO HIDE

74 SO: WE WANT YA TO FEEL LIKE YOU'RE A PART OF THE PROCESS

76 SO: CUZ ULITMATELY WE'RE TRYING TO GET YOU OUT OF HERE

78 SO: YOU KNOW WHAT I MEAN?

80 SO: WE'VE DONE A LOT OF THIS ON THESE A LOT OF THESE ON THIS CASE SO

89 SO: MAKE SURE YOU READ IT LIKE I SAID I DON'T WANT EVERYTHING TO FEEL
90 LIKE..... YOU'D UNDERSTAND YOU KNOW EVERYTHING.....
91 EL: SO IF I REFUSE THIS AT THIS TIME AT ANYTIME OR (INAUDIBLE) TO ANY
92 CASE AT WHICH I'M INVOLVED IN
93 SO: YEAH IT'S BASICALLY JUST CUZ SAY WE GOT PART WAY THROUGH THE
94 PROCESS YOU SAID YOU KNOW UM I DON'T WANT TO DO THIS
95 EL: AH HUH
96 SO: IT DOESN'T SAY THAT YOU'RE GUILTY OF THE CASE IT'S JUST PART OF
97 THE INVESTIGATORY PROCESS THAT WE USE
98 EL: AH HUH I THINK I THREW UP
99 SO: I BETTER LET YOU USE THE RESTROOM I THINK FOR A MINUTE CUZ THAT
100 ONE HIT ON YOUR SHIRT
101 EL: OH MY GOODNESS I CAN'T BELIEVE THIS
102 SO: GRAB THAT HANDFUL OF THE LITTLE ONES AND WE'LL THROW THEM
103 AWAY WHEN WE'RE
104 EL: I'M SORRY!
105 SO: HEY NO WORRIES
106 EL: (LAUGH)
107 SO: WORSE THINGS HAVE HAPPENED I CAN PROMISE YOU
108 EL: OH GOOD.....OH MY GOODNESS (INAUDIBLE) WHOW!
109 SO: BETTER KEEP SOMETHING ON THAT

110 EL: I KNOW I'M GONNA (INAUDIBLE)
111 SO: JUST THREW THE RAG HERE (INAUDIBLE) (THE DOOR OPENS AND CLOSES)
112 (THERE IS APPROXIMATELY 2 MINUTES OF DEAD AIR)
113 (THE DOOR OPENS AND CLOSES AGAIN) (APPROXIMATELY 2 MORE
114 MINUTES OF BACKGROUND NOISE AND DEAD AIR BEFORE THE INTERVIEW
115 RESUMES)
116 EL: I'M SORRY
117 SO: YOU NEED SOME MORE WATER OR YOU ALRIGHT WHILE I'M UP
118 EL: UM SOME WATER WOULD BE GREAT
119 SO: OKAY I'LL GRAP YA ANOTHER CUP
120 EL: OKAY THANKS A LOT..... (TALKING IN THE BACKGROUND)
121 SO: ALRIGHT THERE YA GO
122 EL: THANK YOU SO MUCH
123 SO: NO WORRIES. ONE MORE THING TO I JUST PUT MY PHONE ON VIBRATE
124 (THE DOOR CLOSES) YOU CAN'T HAVE ANYTHING THAT MAKES NOISE CUZ
125 IT CAN INTERFER
126 EL: OKAY
127 SO: SO IF YOU GOT THAT PHONE ON (INAUDIBLE)
128 EL: YOU WANT ME TO TURN IT OFF IF IT'S ON SILENT IT DOESN'T MAKE ANY
129 NOISE OR VIBRATE
130 SO: THAT'S GOOD WHATEVER
131 EL: OKAY
132 SO: AS LONG AS IT DOESN'T RING OUT WHILE WE SHOULD BE FINE
133 EL: OKAY
134 SO: ALRIGHT UM YEAH SO I'LL EXPLAIN TO YOU THEN THE TEST WORDS AND
135 THEN WE'LL MOVE TO THOSE HERE.
136 EL: DO YOU HAVE THAT PEN STILL?
137 SO: OH YEAH
138 EL: OKAY

139 SO: SORRY I WORKED IN THE JAIL BACK IN THE DAY SO I ALWAYS HAD A PEN
140 SITTING AROUND

141 EL: (LAUGH, LAUGH)

142 SO: IT COULD END UP BEING A TATTOO (INAUDIBLE) WHAT'S THE POLICE
143 PART OF THIS NO PLACE FOR THEM TAKE ALL OF OUR STUFF PENS,
144 ANYTHING VALUABLE. BASICALLY WHAT THE DEAL IS, GO AHEAD, WITH
145 THIS AH TEST IS THAT IT, IT MEASURES YOUR AH THE FM IN YOUR VOICE

146 EL: UM HUM

147 SO: AND BASICALLY IT'S AN INAUDIBLE DIFFERENCE TO YOUR EAR WELL YOU
148 KNOW LIKE DOGS CAN HEAR DOG WHISTLES

149 EL: UM HUH

150 SO: THAT WE CAN'T HEAR

151 EL: UM HUH

152 SO: BASICALLY THE COMPUTER CAN DETECT PATTERNS IN YOUR VOICE THAT
153 WE CAN'T HEAR AUDIBLY BUT THE IT WILL DETECT WHEN THE PATTERNS
154 READ THROUGH THE COMPUTER. SO BASICALLY WHAT IT IS, IS THAT
155 WHEN PEOPLE ARE BEING AH DIS-UNTRUTHFUL OR WHATEVER
156 DISHONEST WHATEVER YOU WANT TO CALL IT ABOUT A CERTAIN
157 SUBJECT THEIR VOCAL CORDS WILL TENSE UP KIND OF THEIR, A LOT OF
158 PEOPLE'S BODY TENSES UP

160 SO: YOU KNOW HOW KIDS ARE THEY GET LIKE ALL ANTSY WHEN THEIR
161 TELLING A LIE

162 EL: UM HUM

163 SO: AND YOUR VOCAL CORDS DO THE SAME THING AND SO EVEN IF YOU TRY
164 TO ANSWER THE QUESTION DIFFERENT IT STILL SHOULD, THE COMPUTER
165 WILL STILL READ INAUDIBLE TO THEM SO. BASICALLY IT'S A COMMON
166 THING WE DO IT ON ALL OF OUR OFFICERS THAT APPLY TO WORK HERE,
167 WE DO IT ON EVERY CASES FROM LIKE STOLEN BIKES TO MURDER CASES

168 YOU KNOW I'M JUST ONE OF THE LUCKY ONES THAT GETS TO DO THEM
169 ALL THE TIME SO. I DO ENJOY DOING THEM BECAUSE AH IT'S NOT MADE
170 FOR PEOPLE TO FAIL I KNOW I WOULD SAY PROBABLY SAY HALF TO
171 TWENTY-FIVE PERCENT OF THE PEOPLE THAT ARE TRUTHFUL PSST YOUR
172 OUT OF HERE AND THAT'S OBVIOUSLY THAT'S WHAT THE GOAL IS FOR US
173 YOU KNOW WHAT I MEAN, SO HOW WE'LL, HOW WE'LL PROGRESS FROM
174 HERE NOW THAT YOU'VE SIGNED THE WAIVER WE'LL GO THROUGH I
175 HAVE SOME BACKGROUND QUESTIONS, I DON'T KNOW THAT MUCH
176 ABOUT THIS CASE BECAUSE IT'S KIND OF LIKE SECRET YOU KNOW WHAT I
177 MEAN?

182 SO: HELP ON SOMETHING, SO I MIGHT ASK YA STUFF THAT YOU'RE GOING
183 DAM I'VE BEEN ASKED THAT TEN TIMES SO I'LL JUST APOLOGIZE IN
184 ADVANCE FOR THAT ONE OKAY?

185 EL: OKAY

186 SO: IF YOU HAVE ANY QUESTIONS ALONG THE WAY I'LL BE MORE THAN
187 HAPPY TO ANSWER THEM AND AH LIKE I SAID IT'S, IT'S AN INTERACTIVE
188 PROCRESS IT'S NOT SOMETHING THAT I'M JUST GONNA SIT HERE AND BE
189 LIKE, "YOU LIE"

191 SO: OKAY AH DO YOU HAVE ANY OF THAT I NEED THAT PEN

192 EL: (LAUGH, LAUGH)

193 SO: NICE TRY THOUGH

194 EL: (LAUGH, LAUGH)

195 SO: HEY DO YOU HAVE, DO YOU HAVE YOUR DRIVER'S LICENSE OR SOME
196 TYPE OF IDENTIFICATION WITH YOU?

198 SO: WHAT'S AH DO YOU KNOW YOUR DRIVER'S LICENSE NUMBER BY ANY
