25 CONCERNED ME AND IN TALKING TO OUR H.R. DEPARTMENT THEY FELT

89 WORKING WITH [REDACTED] YESTERDAY.

91 EM: AND YOU HAVE VIC [REDACTED], [REDACTED].

93 EM: OKAY AND SO THEY SHARED IT WITH ME AND THEY DOC, DOCUMENTED
94 THAT WHILE THEIR TEAM WAS OUT PLAYING IN THE SANDBOX OUT ON
95 THE FIELD AH UM HERE IN DAY CAMP. [REDACTED] BEGAN TO TELL THEM A
96 STORY ABOUT HOW TO KILL A BEAR. [REDACTED] EXPLAINED THAT THE BEST
97 WAY TO KILL A BEAR WAS TO DIG A HOLE AND PUT IT, PUT A BEAR INTO IT
98 THEN THROW ROCKS ON IT, COVER IT WITH A TREE SO NO ONE CAN SEE

104 EM: THEN HE ALSO TOLD THEM UM THE JETS ARE THE BEST RASPBERRYS
105 BECAUSE THE BEAR IS UNDERNEATH. YOU KNOW WHEN THEY ASKED
106 [REDACTED] HOW HE KNEW THIS, [REDACTED] TOLD THEM BECAUSE HE SAW
107 SOMEONE DO IT.

109 EM: OH AND THEN SHE WENT ON KNOWING WHEN, WHEN HE SAW SOMEONE

110 DO THAT HE HESTITATED AND THEN HE SAID UM ON T.V.
111 DM: UM HUH.
112 EM: SO THE ONE STATEMENT.
113 DM: OKAY.....
114 EM: AND THEN SHALL I CONTINUE?
115 DM: YEAH ABSOLUTELY.
116 EM: OKAY THEN THIS NEXT STATEMENT WAS FROM: [REDACTED]
117 WORKING WITH [REDACTED] YESTERDAY, HE HEARD [REDACTED], [REDACTED]
118 TALKING TO HIMSELF AND THEN HE WENT OVER TO [REDACTED] AND HE JUST
119 BLURTED OUT AND JUST SAID I WAS BORN IN UTAH AND THEN WE MOVED
120 SUDDENLY AND THEN [REDACTED] ASKED WHERE DID YOU MOVE TO? AND
121 [REDACTED] SAID WE MOVED TO WASHINGTON CAUSE PEOPLE THERE,
122 PEOPLE WERE TRYING TO KILL US IN UTAH, THE MORMONS AND THE
123 CHRISTIANS WANT TO HURT US, SO WE MOVED TO WASHINGTON, THEY
124 CAN ONLY HURT US THEY CAN'T KILL US HERE IN WASHINGTON. NO ONE

128 EM: ANOTHER STATEMENT, AND THEN THIS STATEMENT IS FROM: [REDACTED]
129 [REDACTED] AND HE SAID [REDACTED]
130 TOLD ME, THAT MORMONS KILL ANIMALS AND THAT JESUS OFFENDS ME
131 AND HE, HE SAID STATED THAT HE'S SEEN [REDACTED]'S BEHAVIOR AS
132 OBEDIENT, RESPECTFUL THROUGH THE DURATION OF THE CAMP UP UNTIL
133 YESTERDAY AND TODAY AND HE WAS NON-RESPONSIVE AT TIMES AND
134 THEN TRIED TO RUNAWAY FROM HIM SHOUTING, THAT HE WAS THAT
135 [REDACTED] WAS A MORMON.
136 DM: HUM. AND THIS IS [REDACTED] WHO?
137 EM: [REDACTED].

139 EM: ONE OF OUR CAMP COUNSELORS.
140 DM: ALRIGHT...LET ME JUST GO BACK HERE AND SEE.....I'M JUST GONNA
141 MAKE A COUPLE OF NOTES HERE.....OKAY....WHAT ELSE.
142 EM: WELL THIS NEXT ONE'S FROM MY DAY CAMP DIRECTOR, HER NAME IS
143 [REDACTED]
144 DM: OKAY.
145 EM: AND SO THIS IS FROM TODAY, UM SHE SAW [REDACTED] SITTING, WE HAVE A
146 BIG SPORTS PARK SOCCER ARENA THAT HE WE DO A LOT OF OUR
147 ACTIVITIES IN, AND [REDACTED] WAS SITTING OUT, OUTSIDE OF THE ARENA
148 YOU KNOW ON THE TABLES YOU COULD STILL SEE THROUGH THE
149 PLEXIGLASS WHAT'S GOING ON AND SO OUR DAY CAMP COUNSELOR
150 APPROACHED HIM AND TRIED TO COAX HIM TO JOIN THE GROUP BY
151 TELLING HIM THE GROUP WAS DOING SHOW AND TELL, AND [REDACTED]
152 SAID MY DAD WON'T LET ME SHOW ANY TOYS, MY DAD WON'T LET ME
153 SHOW ANYTHING, AND SO ANISA SAID, OH REALLY HE WON'T LET YOU
154 SHOW ANYTHING? AND [REDACTED] RESPONDED BY SAYING NO MY DAD
155 SAID I CAN'T TELL ANYONE IN THIS TOWN ANYTHING, AND SHE SAID
156 WELL [REDACTED] WE ARE FRIENDS AND YOU CAN TELL ME ANYTHING YOU
157 WANT....THAT WAS FROM THIS MORNING.
158 DM: OKAY.....IS THERE ANYTHING ELSE?

160 DM: OKAY
161 EM: FROM [REDACTED] CAMP COUNSELOR AND IT'S FROM TODAY
162 DM: OKAY
163 EM: UM [REDACTED] HAD COME INTO DAY CAMP THIS MORNING SAYING HIS
164 BROTHER IS NOW IS IN UTAH AND IT JUST KIND OF YOU KNOW WE RAISED
165 OUR EYE BROWS LIKE WHAT DOES HE MEAN BY THAT
166 DM: UM HUH.
167 EM: SO UM [REDACTED] WAS SITTING NEXT TO HIM UM WHEN OUR CAMP FIRE OR

168 SOMETHING WAS GOING ON AND SO [REDACTED] AND [REDACTED] WAS SITTING ON
169 THE BENCHES COLORING AND OR DRAWING PICTURES AND HE SAID
170 SOMETHING UM HE, HE STATES THAT [REDACTED] HAD SAID SOMETHING TO
171 HIM THAT SOUNDED NOT LIKE, HE TOLD ME THAT HIS LITTLE BROTHER
172 [REDACTED] TRIED TO KILL HIM AND THAT [REDACTED] HAD TO GO BACK TO
173 UTAH TO BE WITH HIS GRAND PARENTS BECAUSE OF THAT. SO HE JUST
174 SAID I THOUGHT YOU GUYS MIGHT WANT TO KNOW ABOUT THAT.

179 AND STAYED THE WHOLE TIME UNTIL CLEAN UP UNTIL ABOUT 7:30 LAST
180 NIGHT.

182 EM: SO THAT'S WHY FOR THIS MORNING [REDACTED] TO COME IN AND SAY
183 [REDACTED] IS IN UTAH

184 DM: RIGHT.

185 EM: THAT KIND OF SEEMED STRANGE TO ME.

186 DM: RIGHT OKAY....ALRIGHT UM...SO YOU'VE SEEN A CHANGE IN HIS UM
187 DEMEANOR, HIS BEHAVIOR

188 EM: YEAH

189 DM: FROM THE TIME THAT HE FIRST

190 EM: (INAUDIBLE) PARDON ME?

191 DM: FROM THE TIME HE FIRST STARTED TO NOW?

192 EM: YEAH... IT'S BEEN VERY NOTICABLE THIS WEEK WHERE HE'S JUST KIND
193 I'VE HEARD I HAVEN'T HAD ANYBODY DOCUMENT IT, BUT THAT'S HE'S
194 [REDACTED] AND I GO CONES, WE HAVE CONES ALONG OUR
195 WALK WAY GOING INTO THE BUILDING AND HE'S KICKED THE CONES
196 OVER AND HE JUST SEEMS A LITTLE MORE AGGRESSIVE AND NON

197 DOESN'T WANT TO LISTEN, RUNS AWAY.

198 DM: OKAY, IT SOUNDS LIKE HE MAY EVEN BE MORE TALKATIVE, MORE
199 OUTSPOKEN?

200 EM: YEAH, YES THAT'S DIFFERENT TO...

201 DM: WHEN ARE THEY DUE TO BE ENDING THERE?

202 EM: WE HAVE TWO MORE WEEKS OF DAY CARE.

204 EM: BUT I BELIEVE ITS WEEKT O WEEK.

206 EM: BECAUSE UM I KNOW I HAVE CONVERSATIONS WITH JOSH POWELL
207 REGARDING THE FINANCIAL, THE FINANCIAL SIDE OF IT OF THE DAY CAMP

209 EM: HE IS ON A SCHOLARSHIP OR ON A FINANCIAL AID SO UM HE, HE ASKS IF
210 THERE IS ANY OTHER WAY TO GO AROUND IT FOR DISCOUNT PURPOSES.

212 EM: BECAUSE HE'S OUT OF WORK AND UM ON UMEMPLOYMENT

213 DM: OKAY, ALRIGHT [REDACTED] UM.....HANG ONTO THOSE, ARE THOSE ALL
214 HANDWRITTEN BY YOUR STAFF?

215 EM: UM THERE TYPED UP

216 DM: OKAY THAT'S GREAT.
