6 CUZ MY DAUGHTER HAD JUST MOVED UP TO PUYALLUP
7 EM: UM HUH
8 MO: SO I THOUGHT OH I'LL TAKE CARE OF YOU GUYS AND YOU GUYS CAN
9 TAKE CARE OF MY BABY YOU KNOW, AND SOMETHING SO I WAS REALLY
10 EXCITED ABOUT THAT AND WE JUST HAD LIKE THIS INSTANT
11 CONNECTION I MEAN IT WAS, IT WAS GREAT AND UM...IT WAS KIND OF
12 MORE OF A PARENT/CHILD THAN A SUPER FRIEND YOU KNOW TYPE ONE
13 AND, AND THEY CAME OVER TO OUR HOUSE A LOT UM (LAUGH, LAUGH)
14 AND JOSH, AND JOSH IS AN INTERESTING PERSON AND HE KNEW WHERE
15 WE KEPT THE TREATS AND BECAUSE THEY WOULDN'T BUY ANY OR
16 ANYTHING I MEAN HE WOULD JUST FILL UP, HE WOULD EAT ANYTHING
17 AND EVERYTHING, HE'D GET IN THE FRIDGE, HE'D GET IN THE CUPBOARDS

29 ABOUT THE KIDS, UM FINANCES, HOW WE DEALT WITH THINGS AND STUFF
30 AND WE'RE KIND OF LIKE OH WELL OKAY YOU KNOW AND STUFF AND
31 THEN WE WOULD JUST, THEY WOULD USUALLY GET INTO A BIG

37 MO: YOU KNOW SHE NEVER WANTED TO GO UP AND VISIT WITH HIM UM JUST
38 REALLY HAD A DISLIKE FOR HIM AND STUFF. UM JOSH WAS REALLY
39 CONTROLLING EVEN RIGHT IN THE BEGINNING HE'D UM...HE WOULD
40 MAKE SUSAN CHECK THE ADS AND WHEN SHE BOUGHT ANYTHING,
41 ANYTHING AT ALL AND UM HE HAD A SPREAD, SPREAD SHEET PUT UP
42 AND STUFF AND IF SHE SPENT TWO OR THREE CENTS MORE ON A CAN OF
43 VEGETABLES OH MY GOODNESS SHE WOULD GET IN SO MUCH TROUBLE

50 MATCHING ADS YOU KNOW GOING YOU KNOW TO DIFFERENT STORES TO
51 BUY YOU KNOW THINGS AND STUFF AND THEN PUTTING THAT PRICE INTO

52 THE COMPUTER AND HE KNEW EXACTLY WHAT WAS EVERY CENT SPENT

55 MO: UM WE WENT TO THE TEMPLE A LOT OF TIMES, WE PLAYED GAMES WITH

72 YOU, WHAT WOULD START THE?

73 MO: YEAH JUST I DON'T KNOW JUST SOMETHING

75 MO: JUST YOU KNOW WE TALKED ABOUT OUR RELATIONSHIP WITH OUR
76 PARENTS

78 MO: OUR IN-LAWS

79 EM: JUST LEAD INTO THEIR FAMILY?

80 MO: AND THINGS LIKE THAT, YEAH AND STUFF THINGS LIKE THAT, BUT I KNEW

81 SUSAN'S THOUGHTS ABOUT HIS DAD OKAY, AND THEN UM MY SON, OR
82 MY DAUGHTER **STEPHANIE** AND I DECIDED WE WANTED TO DRIVE UP TO
83 PUYALLUP TO SEE [REDACTED] AND SEE HOW SHE WAS DOING AND UM OUR
84 HUSBANDS COULDN'T GO AND SO WE WERE LIKE OKAY WE'LL JUST GO
85 TOGETHER WITH THE KIDS YOU KNOW

87 MO: AND STUFF WE HAD, I HAD MY DAUGHTER AND ANOTHER DAUGHTER
88 THAT'S YOUNGER AND SHE HAD A LITTLE BOY AND WE FOUND OUT THAT
89 JOSH WANTED TA, WAS TRYING TO GO UP TO PUYALLUP BUT HE, HE
90 DIDN'T KNOW WHETHER TO TAKE THE BUS OR WHATNOT BECAUSE HE
91 HAD TO I THINK HE WAS PICKING UP A CAR I CAN'T REMEMBER EXACTLY
92 TO BRING HIM BACK, AND UM SO HE NEEDED OR A TRAILER, I DON'T
93 KNOW BUT ANY WAY HE, HE WAS HE HAD A WAY BACK BUT NOT A WAY
94 UP THERE, SO HE SAID WELL COME WITH US WE FELT LIKE, OKAY A GUY
95 WITH US IS GONNA BE SAFER ON THE LONG TRIP AND THINGS LIKE THAT

106 KNOW GOING INTO REALTOR UM THINGS UM

107 EM: WHAT WOULD HE SAY ABOUT CELL PHONES AND PHONES?

108 MO: OH YOU KNOW, LET ME JUST TELL YA, JOSH KNEW IF JOSH WAS
109 INTERESTED IN SOMETHING HE RESEARCHED IT, AND HE WAS SMART

110 ABOUT IT, HE KNEW BECAUSE HE KNEW HOW TO RESEARCH IT
111 EM: UM HUH
112 MO: AND SO HE COULD TELL YOU WHICH PHONE HAD WHICH PLAN AND HOW
113 YOU SWITCHED TO CHANGED PLANS AND HOW YOU DID THIS AND I MEAN
114 JUST HE JUST WOULD TALK ABOUT THINGS THAT INTERESTED HIM
115 EM: YEAH
116 MO: AND UM HE CONTROLLED THE, THE CONVERSATIONS A LOT IN THAT YOU
117 KNOW
118 EM: UM HUH
119 MO: THIS WAS SOMETHING HE WAS INTO AND SO ANY WAY HE UM SUSAN
120 ALWAYS CUT MY HAIR, SHE CUT MY GIRLS HAIR UM FOR MANY YEARS AT
121 LEAST THREE TO FOUR YEARS SUSAN CUT MY HAIR, UM BUT THEN SHE
122 WAS WORKING AND I DIDN'T I HAD A HARDER TIME GETTING OVER TO
123 HER SO YOU KNOW I JUST WENT TO SOMEBODY ELSE AND STUFF, BUT SHE
124 UM YOU KNOW WHEN I WAS OVER THERE OR WHEN MY GIRLS WOULD BE
125 OVER THERE GETTING THEIR HAIR CUT JOSH WOULD COME IN AND HE

150 YOU WOULD GO TO WATCH THE KIDS?
151 MO: TO WATCH THE KIDS CUZ JOSH WOULDN'T WATCH THEM AND STUFF
152 EM: WHAT COMPUTER WOULD HE BE ON?
153 MO: I DON'T KNOW
154 EM: WOULD HE BE UPSTAIRS OR DOWNSTAIRS?
155 MO: YOU KNOW WHAT I DIDN'T EVEN KNOW THAT
156 EM: OKAY
157 MO: I DON'T, I DON'T KNOW
158 EM: OKAY
159 MO: HE WOULD COME IN ONCE A WHILE, I THINK HE WAS UPSTAIRS
160 EM: OKAY
161 MO: AND STUFF BUT HE UM...
162 EM: WAS THAT EVERY TIME YOU'D GO OVER WITH YOUR CHILDREN?
163 MO: WELL SOMETIMES HE WASN'T THERE OR SOMETIMES HE'D BE DOING
164 SOMETHING ELSE AND

166 MO: AND JUST YOU KNOW
167 EM: BUT ANYTIME YOU'D GO OVER THERE TO GET A HAIRCUT OR GO WITH

169 WATCH THE CHILDREN, JOSH WOULD NEVER WATCH THEM?

171 KNOW WHEN JOSH WAS THERE AND HE WOULD KIND OF WATCH THEM
172 HALFWAY AND STUFF UM I MEAN I'VE GOT TO GET HER TA WRITE A
173 STATEMENT OR SOMETHING COME IN WHEN SHE COMES IN TOWN OR
174 SOMETHING BECAUSE SHE SAW THINGS WHERE SUSAN WOULD AH AND
175 SHE'D COME HOME AND SHE'D SAY I DON'T WANT TO EVER GO OVER
176 THERE WHEN JOSH IS THERE AGAIN YOU KNOW AND BECAUSE SUSAN

187 EM: IS HER LAST NAME STILL [REDACTED] ?
188 MO: NO IT'S UM SHE JUST GOT MARRIED IN JUNE IT'S [REDACTED], UM...I
189 DON'T KNOW HER E-MAIL ADDRESS
190 EM: THAT'S ALRIGHT I'LL GIVE YA MINE AND YOU CAN GIVE IT TO HER
191 MO: BUT UM YEAH SHE SAW A LOT OF THINGS LIKE THAT BUT ONE TIME
192 [REDACTED] NEEDED HER HAIR DONE AND THEY WERE TRYING, AND SUSAN
193 SAYS I NEED TO GO PICK UP SOME OF THE DYE, SO SHE WENT DOWN TO
194 FIND THE DYE AND THEY WERE OUT OF IT AT THE STORE, THE BEAUTY

202 TIME AND USE THE GAS IN THE CAR, AND, AND YOU KNOW THINGS LIKE
203 THAT SO SHE WAS REALLY PARANOID SHE TRIED TO DO THINGS ALL AT
204 YOU KNOW ONE TIME BECAUSE JOSH WOULD UM I KNOW WHEN THE GAS
205 PRICES WENT UP UM THE MAIN REASON JOSH UM SOLD THE OTHER CAR

224 FORMULA FOR THE KIDS SO SHE HAD TO NURSE

226 MO: EVEN THOUGH IT WAS AN INCONVENIENCE UM SUSAN TOOK CARE OF THE
227 KIDS NINETY-NINE PERCENT OF THE TIME. UM JOSH REALLY DIDN'T HAVE
228 A LOT TO DO WITH THE KIDS, HE DID UM AS ██████████ STARTED TO GET A
229 LITTLE BIT OLDER HE STARTED TO UM DO MORE THINGS WITH HIM, HE
230 WAS MORE YOU KNOW HE WOULD DO THINGS WITH HIM BUT HE DIDN'T
231 LIKE ██████████ UM BRAYDEN WAS TOO YOUNG HE WAS A NUISANCE HE

236 WERE I DON'T KNOW (LAUGH, LAUGH) UM LET'S SEE WHAT ELSE I'VE GOT

238 EM: WHEN DID YOU WRITE THESE NOTES DOWN THAT YOU'RE REFERRING TO?

239 MO: OH I WROTE THEM DOWN PROBABLY UM APRIL

240 EM: APRIL?

241 MO: ABOUT APRIL

242 EM: OKAY

243 MO: UM AH SOMETIMES YOU KNOW SUSAN WAS AT WORK AND SHE WOULD
244 ASK IF SOMEBODY COULD COME AND TEND THE KIDS WHILE JOSH
245 WORKED ON THE DECK, SHE WAS SO PROUD OF THAT DECK SHE LOVED
246 THE DECK YOU KNOW THAT WAS REALLY A BIG THING, A LOT OF TIMES
247 SUSAN UM WOULD ASK PEOPLE IF THEY COULD COME AND WATCH THE
248 KIDS SO SHE COULD WORK DOWN IN THE BASEMENT. SHE WANTED THAT
249 BASEMENT FINISHED SO BAD THAT SHE WAS LEARNING HOW TO DO IT

272 EM: THE AH
273 MO: YEAH
274 EM: THE GAS LIGHT?
275 MO: YEAH YOU KNOW AH, AH THEY DIDN'T EVER BORROW TENTS OR
276 ANYTHING LIKE THAT BUT YOU KNOW JUST THINGS THAT I KNOW AH.....I
277 DON'T KNOW THEY JUST THEY WOULD BORROW SOME OF OUR
278 EQUIPMENT SO I KNOW THEY DIDN'T HAVE EQUIPMENT YOU KNOW UM
279 AND EVEN THOUGH SUSAN LOVED THE OUTDOORS THEY WERE DAYTIME
280 OUTDOORS YOU KNOW THEY'D GO THINGS AND STUFF IT WASN'T, IT
281 WASN'T UM NIGHT TIME THINGS
282 EM: UM HUH
283 MO: AND STUFF UM....WHEN JOSH WAS GETTING TO BE A REALTOR HE SPENT

284 OODLES OF MONEY I MEAN JUST TONS OF MONEY (A CELL PHONE IS
285 RINGING) ANOTHER TIME WE'D GO OVER THERE

286 EM: SORRY!

287 MO: IT'S OKAY

288 EM: GO AHEAD

289 MO: EVERYTIME WE'D GO OVER THERE HE WOULD UM YOU KNOW HAVE TO
290 SHOW US HIS LATEST YOU KNOW THING AND

291 EM: UM HUH
