165 A FEW PEOPLE THAT I ASSOCIATE WITH

167 TP: BUT YOU KNOW I'M KIND OF A QUIET PERSON I STAY AT HOME.

168 EM: DO YOU HAVE A DOG?

169 TP: AH WE DO NOW.

170 EM: HOW LONG HAVE YOU HAD IT?

171 TP: AH SINCE CHRISTMAS....THAT'S KIND OF A STRANGE QUESTION!

172 EM: WELL THE REASON WHY I ASK IS BECAUSE UM THERE IS SOME  
173 INFORMATION OF AN INDIVIDUAL WITH A DOG THAT KIND OF IN  
174 THE NIGHT TIME HOURS AFTER ALL OF THIS HAD HAPPENED THAT  
175 WENT OVER TO THE POWELL'S RESIDENCE AND THE DOG, WALKING  
176 THE DOG SO DID YOU DO THAT BY CHANCE?

184 LEASH AND WALKED OVER TO THE POWELL'S RESIDENCE

186 EM: IN THE NIGHT AND JUST KIND OF WALKED AROUND.

188 EM: I JUST KIND OF FOUND THAT, THAT WAS INTERESTING AND  
189 WONDERING WHO,  
190 TP: NO I JUST  
191 EM: WHO WAS DOING THAT SO  
192 TP: I'VE ONLY BEEN OVER AT HER HOUSE A TOTAL OF GALL PROBABLY

223 TP: YEAH JOSH WAS PRETTY MUCH ABOUT HIMSELF

225 TP: HE'S, HE LIKES TO TALK ABOUT HIMSELF  
226 EM: YEAH I'VE LEARNED THAT. UM HOW OFTEN, HOW OFTEN WOULD  
227 SUSAN COME TO YOUR GUYS HOME?  
228 TP: UM...SHE'S ONLY BEEN SINCE THAT DAY I THINK AH SHE'S ONLY  
229 BEEN AT THE HOUSE MAYBE ONCE OR TWICE AFTER THAT.

232 EM: OKAY.  
233 TP: THAT WAS AH  
234 EM: SO SHE'S ONLY BEEN TO YOUR HOUSE ONE OR TWO TIMES?



235 TP: YEAH, YEAH IT WAS WELL IT WAS SHE CAME OVER TO GET THE  
236 CLOTHES AND I TOOK, WE DIDN'T EVEN STAY IN THE HOUSE I  
237 IMMEDIATELY TOOK THE CLOTHES OUT AND WE HAD THE  
238 CONVERSATION IN THE FRONT, FRONT YARD. UM AND THEN SHE  
239 CAME OVER TO THE HOUSE WHEN I WASN'T HOME AND TALKED TO  
240 ██████████...I DON'T THINK SHE WAS EVER THERE WITH JOSH I

246 EM: HOW LONG WAS SHE AT THE HOME THAT AH FIRST AND SECOND  
247 TIME WOULD YOU THINK?

248 TP: WELL THE FIRST TIME WHEN SHE WAS OUT IN THE FRONT YARD WE  
249 TALKED FOR ABOUT AN HOUR....AND

250 EM: DID JOSH EVER SHOW UP TO PICK HER UP OR SAY COME HOME?

251 TP OH AH THERE WAS AH THE SECOND TIME SHE CAME OVER SHE WAS  
252 TALKING TO ██████████ AND THEN I CAME HOME AND WE TALKED A  
253 LITTLE MORE, THEN JOSH CAME OVER AND THEN JOSH DOMINATED  
254 THE WHOLE CONVERSATION AND AH WE SAT AND LISTENED TO  
255 HIM WHILE HE TALKED AND UM WE AH IT GOT LATE AND SUSAN  
256 WANTED TO LEAVE AND HAD GOTTEN THE KIDS IN THE CAR AND  
257 SHE COULDN'T GET JOSH TO LEAVE AND SHE BASICALLY SAT IN  
258 THE CAR AND WE KIND OF WORKED, WORKED HIM OUT OF THE  
259 HOUSE INTO THE FRONT YARD YOU KNOW SLOWLY WALKING TO

264 TP: AND SHE WANTED HIM TO GO AND SHE GOT REALLY IRRITATED  
265 WITH HIM AND SHE WAS SHE DIDN'T REALLY YELL AT HIM BUT SHE  
266 WAS VERY STURN IN THE WAY SHE TALKED TO HIM, IT WAS LIKE  
267 YOU NEED TO GO AND HE COMPLETELY IGNORED HER, HE  
268 WOULDN'T EVEN LOOK AT HER AND SAY YES OR NOTHING.

269 EM: OKAY AND THAT'S THE LAST TIME YOU CAN, THE LAST TIME YOU  
270 REMEMBER SUSAN AND OR JOSH BEING AT YOUR HOME?

271 TP: YEAH UM HUH.

272 EM: SO SUSAN NEVER EVER CAME TO YOUR HOME AND SPENT A  
273 SIGNIFICANT AMOUNT OF TIME EITHER AN HOUR, TWO HOURS,  
274 THREE HOURS AND JOSH SHOWED UP TO SAY, HEY LOOK SUSAN  
275 YOU NEED TO COME HOME?

276 TP: NO UH, UH.

277 EM: OKAY

278 TP: NO JOSH, JOSH CAME OVER AFTERWARDS AND THEN SUSAN, SUSAN  
279 WANTED TO LEAVE AND JOSH WAS THE ONE THAT DIDN'T WANT TO  
280 LEAVE.

281 EM: HOW LONG DO YOU THINK SUSAN WAS THERE BEFORE JOSH, WELL  
282 YOU WEREN'T HOME?

283 TP: I WASN'T HOME.

284 EM: HOW LONG WAS SHE THERE AND YOU WERE THERE AND [REDACTED]  
285 WAS THERE BEFORE JOSH SHOWED UP DO YOU THINK?

286 TP: UM MAYBE, I DON'T KNOW MAYBE AN HOUR...PROBABLY LESS I  
287 DON'T KNOW IT WASN'T LONG AFTER I GOT HOME FROM WORK  
288 THAT, THAT AH JOSH SHOWED UP.

289 EM: HOW LONG DID AH JOSH STAY THERE FROM THAT POINT TO THE  
290 POINT YOU GUYS WERE ABLE TO GET HIM OUT OF THE HOUSE?

291 TP: THAT WAS HOURS, IT WAS A COUPLE OF HOURS.

292 EM: OKAY.

293 TP: AND HE, HE WAS AH STARTS TALKING ABOUT POLITICS AND GOT  
294 OFF ON THIS CONSPIRACY THEORY THING, I DON'T KNOW HE, IT  
295 WAS KIND OF STRANGE I REALLY DIDN'T LISTEN. I WAS JUST  
296 NODDING.....

297 EM: UM LET'S SEE.....THAT ANSWERS ALL MY QUESTIONS ON THAT. AH  
298 DID YOU, DID YOU KNOW EVER KNOW SUSAN JOGGING IN THE  
299 NEIGHBORHOOD AT ALL?

300 TP: UM THAT WAS ACTUALLY THAT WAS THE TIME THAT SHE CAME  
301 OVER SHE WAS WALKING SHE WAS, SHE HAD A WALKING THING  
302 WITH THE KIDS IN IT.

303 EM: UM HUH.

304 TP: AND SHE WENT, SHE CAME WALKING PAST THE HOUSE.

305 EM: THE SECOND TIME?

306 TP: YEAH I THINK THAT WAS...OH WHY DOES THAT STAND OUT IN MY  
307 MIND IS THAT HER OR IS THAT THE OTHER NEIGHBORS, LET ME  
308 THINK....I'M TRYING TO THINK...CAUSE I DO REMEMBER A TIME  
309 WHEN I WAS TALKING TO SOMEBODY, I WAS SITTING ON THE  
310 FRONT PORCH I WAS TALKING TO SOMEBODY I DON'T KNOW IF IT  
311 WAS HER OR NOT. YEAH I THINK IT WAS, I THINK THAT WAS WELL, I  
312 DON'T KNOW I WISH [REDACTED] WAS HERE SHE REMEMBERS  
313 EVERYTHING.

314 EM: YEAH....

315 TP: THAT MIGHT HAVE BEEN THE TIME IT, IT SEEMS TO ME IT KIND OF  
316 JOGS MY MEMORY THAT SHE, SHE HAS ONE OF THOSE PUSH THINGS  
317 THAT SHE PUSHED THE KIDS AROUND IN

318 EM: UM HUH.

319 TP: SO I DON'T KNOW IF YOU'VE SEEN ONE OF THOSE AT HER HOUSE.

320 EM: UM HUH

321 TP: DID YA?

322 EM: YEAH I THINK SO.

323 TP: OKAY, THERE MIGHT HAVE BEEN A TIME WHEN SHE CAME BY WITH  
324 ONE OF THOSE BUT I REMEMBER TALKING TO HER FOR VERY  
325 LONG...SHE RESPONDED, WE CORRESPONDED WITH EACH OTHER  
326 BY E-MAIL OR UM...UM...WHAT IT WAS PHONE CALLS.  
327 EM: OKAY.  
328 TP: AND TALKED.  
329 EM: UM SO BACK TO THAT QUESTION DID YOU KNOW HER TO GO  
330 JOGGING THROUGH THE NEIGHBORHOOD  
331 TP: AH SHE  
332 EM: OR JUST WALKING THE NEIGHBORHOOD WITH THE KIDS?  
333 TP: I THINK WELL I REMEMBER SEEING HER ONCE DO THAT WALKING  
334 WITH THE KIDS IN THAT THING.  
335 EM: NEVER JOGGING?  
336 TP: I DON'T REMEMBER EVER SEEING HER JOG.  
337 EM: DO YOU EVER JOG IN THE NEIGHBORHOOD?  
338 TP: NO YOU KNOW LOOK AT ME DO I LOOK LIKE A JOGGER? (LAUGH,  
339 LAUGH) PROBABLY KILL MYSELF. I'M AN OLD MAN.  
340 EM: (LAUGH, LAUGH) ALRIGHT UM LET'S SEE HERE.....YOU  
341 MENTIONED THAT AH YOUR CORROSPONDENCE WITH SUSAN WAS  
342 MOSTLY E-MAIL AND PHONE CALLS.  
343 TP: YEAH.  
344 EM: UM HOW FREQUENTLY ON THE E-MAILS?  
345 TP: OH I DON'T KNOW UM....MAYBE ONCE A MONTH OR SOMETHING  
346 LIKE THAT.  
347 EM: AND WHAT WAS THE CONVERSATION CONSIST OF?  
348 TP: WELL SHE'D HAVE SHE'D SEND THEM FROM WORK UM SHE, SHE  
349 WASN'T ALLOWED TO HAVE A, A COMPUTER AT HOME OR USE  
350 JOSH'S COMPUTER.  
351 EM: UM HUH.

352 TP: AND AH SO ON SATURDAY UM SHE WOULD UM SHE USUALLY HAD  
353 A LOT OF TIME SHE SAID ON SATURDAY THAT YOU KNOW SHE  
354 THAT'S WHEN SHE REALLY RESPONDED TO E-MAILS AND THINGS  
355 LIKE THAT. BUT I'D SEND AN E-MAIL OFF AND THEN MAYBE IN A  
356 WEEK OR SO WOULD GO BY AND SHE WOULD RESPOND TO IT.

357 EM: UM HUH.

358 TP: I NEVER CHECKED MY E-MAILS A LOT YOU KNOW THAT OFTEN SO
