3 VERIFY THAT WHAT YOU SAY ON THE APPLICATION IS TRUTHFUL

6 SO: WE ACTUALLY DO A LOT OF THESE, HALF OF THEM ARE PROBABLY  
7 NON-CRIMINAL AND HALF OF THEM ARE ON CRIMINAL CASES YOU  
8 KNOW, TO EITHER HELP INCLUDE OR EXCLUDE PEOPLE FROM A  
9 CASE SO.  
10 TP: THAT'S FINE.  
11 SO: BASICALLY AH WE ALWAYS GET THE POINT OF VIEW THAT IF AH  
12 EVERYBODY SAID THE TRUTH BASICALLY WE'RE GONNA VERIFY  
13 THAT AND YOU'LL BE GOOD TO GO SO.  
14 TP: YEAH.  
15 SO: AH I HAVE A FEW THINGS WE'LL DO HERE BUT FIRST OF ALL JUST  
16 THIS IS THE CONSENT FORM, BASICALLY JUST READ THIS IT'S  
17 SAYING PUT YOUR NAME THERE YOUR AGREEING TO SUBMIT TO  
18 THE TEST AND THEN  
19 TP: UM HUH.  
20 SO: IT'S KIND OF JUST SELF EXPLANATORY. THERE'S THAT.....  
21 (SOMEONE IS WHISTLING).....  
22 TP: THERE YA GO.  
23 SO: IS THAT THE FIRST TIME YOU GOT TO MEET DETECTIVE MAXWELL  
24 THEN?  
25 TP: YEAH. I'VE NEVER MET HIM BEFORE.

26 SO: HEY THAT GUY HASN'T SLEPT TOO MUCH FOR THE LAST LITTLE  
27 WHILE SO.  
28 TP: HE WHAT?  
29 SO: HE HASN'T SLEPT MUCH FOR THE LAST COUPLE MONTHS YOU  
30 KNOW.  
31 TP: OH BECAUSE OF THIS CASE?  
32 SO: YEAH.  
33 TP: ABOUT IT REALLY?  
34 SO: HE'S ENDLESSLY WORKING ON THIS CASE SO.  
35 TP: WELL GOOD.  
36 SO: YEAH.  
37 TP: ITS I WOULDN'T EVEN BE INVOLVED WITH THIS IF, IF I DIDN'T FEEL  
38 LIKE YOU KNOW SOMEBODY NEEDED TO BE THERE FOR  
39 SO: OH YEAH.  
40 TP: FOR HER YEAH.  
41 SO: IT LOOKS LIKE SHE'S GOT A BUNCH OF SUPPORTIVE FRIENDS SO IT'S  
42 GOOD.  
43 TP: YEAH SHE'S A GOOD KID, OR IS A GOOD KID, HOPEFULLY SHE'S  
44 STILL ALIVE.  
45 SO: YEAH. WELL WE, WE ALL HOPE FOR THAT OBVIOUSLY.  
46 TP: YEAH  
47 SO: AH YOU GOT YOUR DRIVER'S LICENSE OR SOMETHING HERE  
48 TP: YEAH  
49 SO: JUST WRITE DOWN THERE THE INFORMATION  
50 TP: YOU BET.  
51 SO: CAUSE REALLY THEY DON'T TELL ME MUCH I, I WORK AH  
52 DIFFERENT HERE I WORK ON AH SPECIAL VICTIM'S UNIT  
53 TP: AH HUH.  
54 SO: SO I'M NOT WORKING ON THE CASE BUT I JUST DO THESE FOR  
55 EVERYBODY LIKE  
56 TP: YEP

57 SO: (INAUDIBLE) OR ANYTHING SO.....WHAT'S YOUR MIDDLE NAME?  
58 TP: AH, "██████".  
59 SO: IS IT YOU'RE BIRTHDAY (INAUDIBLE)?  
60 TP: (INAUDIBLE)  
61 SO: NAW  
62 TP: YEAH.  
63 SO: JUST YOUR ISSUE DATE WAS AH TOMORROW.  
64 TP: OH IT WAS IT WAS LAST YEAR.  
65 SO: YEAH  
66 TP: (INAUDIBLE)  
67 SO: THEY DO THE ISSUE DATE ON YOUR BIRTHDAY SO THAT'S WHAT I  
68 WAS WONDERING ABOUT.  
69 TP: OH HOW'S THE WEEK GOING IT DEPENDS I GUESS.  
70 SO: TODAY'S MY SON'S BIRTHDAY SO  
71 TP: (INAUDIBLE) HOW OLD IS HE GONNA BE?  
72 SO: FIFTEEN.  
73 TP: OH SWEET  
74 SO: AND AT THIS AGE TO HE'S SIX-FOOT-TWO ALREADY SO.  
75 TP: HOLY COW!  
76 SO: (LAUGH, LAUGH)  
77 TP: ISN'T IT SOMETHING?  
78 SO: I KNOW MAN IT'S CRAZY I TELL YA.  
79 TP: WOW FIFTEEN AND THAT SIZE.  
80 SO: YEAH WE'RE ALL THERE, HE PLAYED SOME BALL LAST FALL AND  
81 HE'S A HE'S A STRAIGHT "A" STUDENT SO  
82 TP: THAT'S SO COOL  
83 SO: YEAH IT'S AH IT WAS HARD TO DO THAT ONE  
84 TP: A LOT OF WORK.  
85 SO: SO IF SOMETHING HAPPENS USUALLY  
86 TP: YEAH  
87 SO: MY DAUGHTER'S EIGHTEEN I'M GETTING OLD MAN

88 TP: YEAH I KNOW WHAT YOU MEAN I'VE GOT A TWENTY-THREE-YEAR-  
89 OLD  
90 SO: ARE YOU SERIOUS?  
91 TP: YEAH  
92 SO: YOU DON'T LOOK OLD ENOUGH TO HAVE SOMEBODY THAT AGE.  
93 TP: I'M FORTY-SIX MAN.  
94 SO: (LAUGH, LAUGH) ARE YOU REALLY?  
95 TP: YEAH  
96 SO: NICE WELL YOU SHOW WELL OR DON'T SHOW WELL ONE OR THE  
97 OTHER.  
98 TP: WELL THANKS I APPRECIATE THAT, THAT'S A NICE COMPLIMENT.  
99 SO: OKAY BASICALLY AH LIKE DETECTIVE MAXWELL SAID AH WE, WE  
100 RUN THE EXAM PART OF THE AH, AH PROCEDURE IS AS WE GOT TO  
101 SIGN THE RELEASE FORM YOU JUST SIGNED AND WE READ YOU  
102 MIRANDA RIGHTS THAT'S THE WAY  
103 TP: UM HUH.  
104 SO: CAUSE WE HAVE HAD PEOPLE IN HERE BEFORE THAT WE BROUGHT  
105 IN AS A NEIGHBOR OR JUST AS A FRIEND OR SOMEBODY THAT WE  
106 DIDN'T THINK WAS RELATED TO THE CASE AND THEN THEY ENDED  
107 UP CONFESSING THAT  
108 TP: NOT ME.  
109 SO: THAT THEY DID THE WHOLE THING. SO BASICALLY IT'S JUST PART  
110 OF THE PROTICAL SO I'LL READ YA MIRANDA IF YOU HAVE ANY  
111 QUESTIONS FEEL FREE TO ASK, I'M NOT HERE TO TRICK ANYBODY  
112 OR IF THEY ARE, OR YOU KNOW WHATEVER IT'S WE RUN THE TEST  
113 ON YA, BE UP FRONT, WE'RE GONNA GO OVER EVERY QUESTION  
114 WITH YOU BEFORE I ASK YOU  
115 TP: UM HUH.  
116 SO: I MEAN IT'S PRETTY SIMPLE, THE, THE MAIN THING IS IT'S AN  
117 INTERACTIVE COMMUNICATION BETWEEN BOTH OF US SO IF YOU  
118 HAVE ANY QUESTIONS ASK ME OKAY?

119 TP: YEP.

120 SO: DON'T BE LEFT WONDERING AND AH BECAUSE IT IS, I UNDERSTAND  
121 PEOPLE ARE ALWAYS UP TIGHT YOU KNOW WHAT I MEAN BUT AH  
122 IT'S AN ODD SITUATION TO BE IN.

123 TP: IT IS REALLY KIND OF AN ODD SITUATION TO BE IN BUT YOU KNOW  
124 I UNDERSTAND THIS IS A CRIMINAL INVESTIGATION.

125 SO: YEAH.

126 TP: YOU'RE TRYING TO ELIMINATE ME AS A SUSPECT.

127 SO: EXACTLY.

128 TP: WHICH IS FINE

129 SO: AND WE DO THESE ON AS MANY PEOPLE AS WE POSSIBLY CAN IN  
130 MOST CASES ESPECIALLY THE HIGHER PROFILE CASES YOU KNOW?

131 TP: UM HUH.

132 SO: LIKE AH YOU KNOW THE CASE WHERE THE GUY KILLED THE  
133 NEIGHBOR WITH A BASEBALL BAT?

134 TP: UH UH

135 SO: IT WAS AH SIX MONTHS AGO PROBABLY THAT'S HOW WE CAUGHT  
136 HIM WAS USING THIS MACHINE

137 TP: REALLY!

138 SO: SO YEAH I USED THIS ONE ON THE NEIGHBORS. SO AH WE TRY TO  
139 RUN IT ON AS MANY PEOPLE AS WE CAN BECAUSE IT BASICALLY  
140 GIVES YOU UMPH IN YOUR STORY. IF I DIDN'T DO AH THERE YOU  
141 GO YOU KNOW I GOT

142 TP: UM HUH

143 SO: AND IT'LL LET US HEAD IN A DIFFERENT DIRECTION YOU KNOW

144 TP: GOOD

145 SO: AT LEAST ELIMINATE YA

146 TP: YA

147 SO: AND AH FOCUS ELSEWHERE SO

148 TP: OKAY

149 SO: AH LET ME READ YA MIRANDA RIGHTS AND THEN WE'LL GET  
150 GOING HERE.

151 TP: OKAY

152 SO: YOU HAVE THE RIGHT TO REMAIN SILENT ANYTHING YOU SAY CAN  
153 AND WILL BE USED AGAINST YOU IN A COURT OF LAW. YOU HAVE  
154 THE RIGHT TO A LAWYER AND HAVE HIM PRESENT WITH YOU  
155 WHILE YOU ARE BEING QUESTIONS, IF YOU CANNOT AFFORD TO  
156 HIRE A LAWYER ONE WILL BE APPOINTED TO REPRESENT YOU  
157 BEFORE ANY QUESTIONING IF YOU WISH. YOU CAN DECIDE AT  
158 ANYTIME TO EXERCISE THESE RIGHTS AND NOT ANSWER ANY  
159 QUESTIONS OR MAKE ANY STATEMENTS. DO YOU UNDERSTAND  
160 EACH OF THESE RIGHTS AS I'VE EXPLAINED THEM TO YOU?

161 TP: UM HUH.

162 SO: OKAY HAVING THESE RIGHTS IN MIND DO YOU WISH TO TALK TO  
163 US NOW?

164 TP: YES

165 SO: OKAY THAT'S STRAIGHT OFF THE DISTRICT ATTORNEY'S  
166 RECOMMENDED CARD SO. (LAUGH, LAUGH)

167 TP: SOUNDS FAMILIAR

168 SO: I READ THE SAME CARD TO EVERYBODY BUT THEY ALL SAY HOW  
169 DO YOU REMEMBER ALL THAT, SO I DON'T I JUST READ IT.

170 TP: YEAH

171 SO: SO, ALRIGHT BASICALLY WE'LL JUST GO THROUGH SOME AH BACK  
172 GROUND INFORMATION HERE AND YOU MIGHT HAVE TO  
173 ENLIGHTEN ME A LITTLE BIT AS WE GO ALONG ABOUT

174 TP: OKAY.

175 SO: WHAT EXACTLY YOUR INOVLEMENT IS IN THE CASE

176 TP: OKAY

177 SO: BECAUSE THEIR GOAL IS TO TRY TO GET PEOPLE LIKE ME THAT  
178 DON'T KNOW THAT MUCH

179 TP: UM HUH

180 SO: TO HAVE AN OBJECTIVE TEST.  
181 TP: SURE.  
182 SO: AND THEN WHAT I DO IS I'LL RUN THROUGH THE TEST AND THEN I  
183 PRINT THE CHARTS OFF AND THEN I GIVE THE CHARTS WITHOUT  
184 ANY INFORMATION TO ANOTHER GUY THAT READS THEM  
185 TP: UM HUH  
186 SO: AND VERIF, SEE IF WE AGREE AND THEN I TELL HIM WHAT THE  
187 QUESTIONS WERE THAT I ASKED  
188 TP: AH HUH  
189 SO: IT BRINGS AN OBJECTIVE AH IT'S CALLED A COLD CALL IT'S JUST A  
190 SECOND IT'S ALMOST LIKE A DOCTOR'S SECOND OPINION  
191 TP: SURE  
192 SO: NOT TELL THE DOCTOR WHAT THE QUESTIONS WERE  
193 TP: OH OKAY  
194 SO: IT'S OVER  
195 TP: (LAUGH, LAUGH)  
196 SO: OKAY SO WHERE I, I DON'T THINK YOU LIVE ON THEIR STREET DO  
197 YA?  
198 TP: NO  
199 SO: OKAY SO YOU JUST LIVE IN THE NEIGHBORHOOD THEN?  
200 TP: YEAH  
201 SO: HOW FAR IN YOU IN THE WARD OR?  
202 TP: I'M IN THE WARD  
203 SO: OKAY  
204 TP: UM HUH WE'RE ON ONE SIDE OF THE WARD AND THEM ON THE  
205 OTHER.  
206 SO: OH OKAY, SO HOW DID YOU GUYS FIRST BECOME FRIENDS THEN?  
207 TP: AH WE MET AH SHE CAME OVER TO THE HOUSE TO GET SOME  
208 CLOTHES AH THAT MY WIFE HAD FOR THE KIDS.  
209 SO: BUT YOU GUYS MET AT CHURCH AND SAID HEY COOL NOW WE  
210 KNOW HER?

211 TP: WELL THAT'S CRYSTAL'S IN RELIEF, SHE'S IN THE RELIEF SOCIETY  
212 PRESIDENCY SUSAN IS AND CRYSTAL KNEW OF HER THEN AND SHE  
213 HAD SOME CLOTHES OF MY SON THAT HE HAD GROWN OUT OF  
214 AND, AND SUSAN CAME BY TO PICK THEM UP.

215 SO: HOW LONG AGO WAS THAT?

216 TP: AH IT WAS IN AUGUST

217 SO: JUST BEARLY LIKE THIS PAST AUGUST?

218 TP: YEAH

219 SO: OH OKAY

220 TP: 2009 I HAVEN'T KNOWN THEM FOR VERY LONG.....I JUST CAME  
221 FORWARD BECAUSE I FELT LIKE THE INFORMATION I HAD WAS KEY  
222 TO THE INVESTIGATION SO.

223 SO: YEAH WE DEFINITELY APPRECIATE THAT. IT'S LIKE TRYING TO PUT  
224 A PUZZLE TOGETHER AND WE GET PIECES FROM ALL DIFFERENT  
225 PEOPLE EVERY WHERE SO.

226 TP: YEAH

227 SO: AH LET'S SEE SO ARE YOU FROM HERE ORIGINALLY?

228 TP: YES.

229 SO: FROM WEST VALLEY OR SALT LAKE?

230 TP: AH I GREW UP OUT IN MAGNA.

231 SO: OKAY

232 TP: YOU'RE MARRIED RIGHT?

233 SO: YEAH.

234 TP: WHAT HIGH SCHOOL DID YOU GO TO?

235 SO: [REDACTED]. WHAT YEAR DID YOU GRADUATE?

236 TP: AH [REDACTED], WELL I GRADUATED IN [REDACTED] MY GRADUATING CLASS WAS [REDACTED].

237 SO: OH OKAY I'M TRYING TO THINK I KNOW SOMEONE, DO YOU KNOW  
238 A GUY NAMED [REDACTED] THAT WENT TO CYPRUS?

239 TP: THE [REDACTED] I KNOW THE [REDACTED] [REDACTED] AND [REDACTED]

244 SO: THERE'S LIKE FIVE OR SIX OF THEM THAT WENT TO CYPRUS  
245 TP: YEAH I THINK THEY WERE DOWN THERE ON 3100 SOUTH IS WHERE  
246 THEY LIVE  
247 SO: I DON'T KNOW WHERE THEY LIVE NOW HIS MOM STILL LIVES OVER  
248 THERE IN A TOWNHOME BUT EVERYBODY ELSE IS THE DAD'S  
249 HOUSE BUT WHEN I WORKED IN THE GYM (INAUDIBLE) WAS THE  
250 SCHOOL COP A FEW YEARS AGO I MET HIM CAUSE HE WORKS FOR  
251 THE SCHOOL DISTRICT (INAUDIBLE) SO  
252 TP: YEAH IT MIGHT BE, IT MIGHT HAVE BEEN HIS OLDER SISTER OR  
253 SOME RELATIONSHIP.  
254 SO: WELL IF I REMEMBER RIGHT HIS OLDER SISTER WAS A REAL  
255 PRETTY BLONDE GIRL  
256 TP: YEP  
257 SO: YEAH  
258 TP: THAT'S █████  
259 SO: YEAH SHE'S BEEN DIVORCED FOR A WHILE I GUESS HUH?  
260 TP: HAS SHE?  
261 SO: YEAH SO (INAUDIBLE)  
262 TP: YEAH SHE'S, SHE'S A NICE GAL  
263 SO: HER SON LIVES IN TIJUANA IF YOU CAN BELIEVE THAT, THEY GO  
264 DOWN TO VISIT HIM AFTERWARDS  
265 TP: LIVES DOWN THERE?  
266 SO: YEAH HE'S MARRIED AND LIVES IN TIJUANA, WORKS IN SAN DIEGO  
267 TP: WOW  
268 SO: IT'S CRAZY. ALRIGHT WHERE DO YOU WORK AT BRO?  
269 TP: I WORKED FOR █████ I'M A PROCESS SERVER  
270 SO: OH YOU SERVE LEGAL PAPERS?

272 SO: OH OKAY, WHEN I USE TO WORK FOR THE SHERIFF'S OFFICE BACK  
273 IN THE DAY I USE TO SERVE ALL THAT STUFF MAN THAT'S SCARY  
274 PEOPLE DON'T THEIR NOT HAPPY TO SEE YA SOMETIMES. (LAUGH,

276 TP: NO IT'S, IT'S KIND OF A NEGATIVE ENVIRONMENT. BUT MOST  
277 PEOPLE FOR AVERAGE PEOPLE LIKE YOU KIND OF CATCH THEM BY

281 SO: AND THAT'S THE SCARY THING IS SOME OF THOSE PEOPLE WHEN I  
282 WOULD SHOW THEM THE DIVORCE PAPERS THEY HAD NO IDEA  
283 THEY WERE COMING (INAUDIBLE)  
284 TP: YEAH  
285 SO: HEY YOUR WIFE FILED FOR DIVORCE, WHAT! YOU KNOW SO I RAN  
286 MY TAPE RECORDER EVERY TIME OFF THE DOOR OBVIOUSLY  
287 TP: YEAH  
288 SO: WE HAD SOMEBODY HERE GET A SHOTGUN PULLED ON THEM ONE  
289 DAY  
290 TP: HOLY HELL!  
291 SO: SERVING PAPERS  
292 TP: DON'T TELL ME THINGS LIKE THAT I'LL THINK ABOUT IT!  
293 SO: YOU JUST GOT TO BE CAREFUL (LAUGH, LAUGH) THERE'S PEOPLE  
294 THAT JUST UP AND LEAVE THEIR SPOUSES THEY REALLY JUST  
295 WANT TO SHOOT THEM HALF THE TIME YOU KNOW  
296 TP: THAT'S AMAZING  
297 SO: SO THAT'S WHAT I WORK WITH MOST OF THESE DOMESTIC  
298 VIOLENCE, PROTECTIVE ORDERS ALL THAT KIND OF STUFF SO  
299 TP: YEAH  
300 SO: THIRTY-FIVE HUNDRED CASES A YEAR OUR SQUAD DOES  
301 TP: WOW

302 SO: YEAH IT'S PRETTY GOOD. ALRIGHT YOU WERE IN THE MILITARY  
303 BEFORE?  
304 TP: YES.  
305 SO: WHAT AH BRANCH?  
306 TP: AH AIR FORCE RESERVES  
307 SO: NICE, YOU STILL IN OR DID YOU GET OUT?  
308 TP: NO I'VE BEEN OUT FOR YEARS  
309 SO: HOW LONG OF A STINT DID YOU DO?  
310 TP: AH FROM ■ TA WHAT WAS IT ■ SEE I WENT ON MY MISSION, GOT  
311 HOME IN JUNE AND WENT IN FEBRUARY OF ■ AND I WAS IN FROM  
312 ■ TO ■  
313 SO: OH SO YOU DID A GREAT SET TWO AH TWO FOUR YEARS OF THAT?  
314 TP: NO SIX, SIX YEARS RESERVE, TWO YEARS INACTIVE.  
315 SO: OH OKAY SO YOU PROBABLY GOT SOME GOOD EXPERIENCES DOING  
316 THAT?  
317 TP: YEAH IT WAS OKAY  
318 SO: YEAH?  
319 TP: YEAH IT WAS OKAY, I DIDN'T LIKE THE PEOPLE AT THE, AT THE AH,  
320 AT THE BASE THAT MUCH.  
321 SO: WAS THAT HILL OR?  
322 TP: IT WAS HILL  
323 SO: I USE TO LIVE UP THERE BY HILL  
324 TP: YEAH  
325 SO: SOME PEOPLE JUST THEY'VE HAD ENOUGH AFTER FOUR OR SIX  
326 YEARS AND THEY GET OUT, SOME PEOPLE WANT TO DO THE  
327 TWENTY AND GET THE HUNDRED DOLLAR A MONTH RETIREMENT  
328 TP: YEAH I SHOULD OF  
329 SO: (LAUGH, LAUGH) A LOT OF MY FRIENDS OUT OF HIGH SCHOOL  
330 JOINED ACTUALLY JUST TO GET THEIR FORMAN SO  
331 TP: YEAH  
332 SO: YOU HAVE ANY CRIMINAL HISTORY?

333 TP: NO...

334 SO: AS A JUVENILE EITHER?

335 TP: NO...

336 SO: WELL YOU'RE BETTER OFF THAN MOST OF US THEN

337 TP: YEAH

338 SO: HAVE YOU EVER HAD A POLYGRAPH OR A VOICE STRESS ANALYSIS

339 TEST BEFORE?

340 TP: YOU KNOW I DON'T, FOR SOME REASON I, I DON'T KNOW IF SMITH'S

341 DID ONE I WORKED AT SMITH'S

342 SO: WAS IT A POLYGRAPH?

343 TP: SEE THAT'S WHAT I, I DON'T KNOW IF I

344 SO: DID THEY HOOK YA UP TO YOUR PULSE AND ALL THAT STUFF? THIS

345 ONE'S JUST A VOICE

346 TP: YEAH

347 SO: THIS HAS BECOME MORE POPULAR

348 TP: I DON'T, I DON'T YOU KNOW I'M SUCH AN OLD GUY I CAN'T

349 SO: (LAUGH, LAUGH)

350 TP: THAT WOULD HAVE BEEN THIRTY YEARS AGO SO, I WORKED FOR

351 THEM FOR THEM ABOUT SIX OR

352 SO: YOU KNOW BACK THEN THAT MIGHT HAVE BEEN THEIR PROTOCOL

353 SO

354 TP: I DON'T KNOW FOR SOME REASON THIS SEEMS FAMILIAR TO ME

355 BUT I, I DON'T KNOW I CAN'T REMEMBER

356 SO: NO WORRIES YOU MUST OF DONE ALRIGHT THEN

357 TP: YEAH WELL I GOT NOTHING TO HIDE.

856 SO: ONLY MAKES SENSE TO YOU AND THEN IT BASICALLY SAYS SHOWS

1101 BE SHOWING STRESS AND ANSWERS BECAUSE YOU'RE NERVOUS

1102 TP: YEAH, YEAH

1103 SO: SO I'M GONNA ASK YOU THE EXACT SAME QUESTIONS AGAIN

1104 TP: OKAY

1105 SO: AND IN THE EXACT SAME ORDER NOTHING CHANGES BASICALLY.

1106 TP: GOOD.

1107 SO: THIS TIME YOU'RE YOU'LL, YOU'LL JUST BE MORE USE TO THE

1108 PROCESS

1109 TP: YEAH.

1110 SO: AND YOU WON'T HAVE THAT SITUATIONAL STRESS AND SO WHAT I  
1111 TELL EVERYBODY IS THIS WILL BE THE ONE THAT'S A LOT MORE UP  
1112 OR DOWN YOU KNOW?  
1113 TP: YEAH.  
1114 SO: THAT FIRST CHART CAN BE LIKE THIS BECAUSE PEOPLE ARE JUST  
1115 STRESSED, NEXT CHART YOUR BAM, BAM YOUR IN THERE, YOUR IN  
1116 THERE IT'S A LOT EASIER TO READ. SO BASICALLY WE ASK THE  
1117 SAME QUESTIONS, WE GRADE THE CHARTS AND YOU WIND UP

1126 SO: HERE'S YOUR LIE QUESTION, IS THE COLOR OF THE WALL BLACK?  
1127 TP: YES....  
1128 SO: IS TODAY WEDNESDAY?  
1129 TP: YES....  
1130 SO: HAVE YOU WITH HELD ANY INFORMATION THAT WOULD HELPFUL  
1131 IN FINDING SUSAN POWELL?  
1132 TP: NO....  
1133 SO: IS THIS THE MONTH OF FEBRUARY?  
1134 TP: YES....  
1135 SO: ARE YOU RESPONSIBLE FOR THE DISAPPEARANCE OF SUSAN  
1136 POWELL?  
1137 TP: NO....  
1138 SO: OKAY YOU CHANGED YOUR VOICE A LITTLE BIT AT THE END  
1139 TP: YEAH

1140 SO: I GUESS WHAT I'LL DO IS IF IT'S NOT LOUD ENOUGH I'LL JUST HAVE  
1141 TO RE-ASK THE SAME QUESTION  
1142 TP: OH OKAY  
1143 SO: SO IT'S JUST GONNA RE-ASK THE EXACT SAME QUESTION  
1144 TP: OKAY  
1145 SO: SO ARE RESPONSIBLE FOR THE DISAPPEARANCE OF SUSAN  
1146 POWELL?  
1147 TP: NO...DID I DO GOOD THAT TIME?  
1148 SO: THERE YA GO YEAH  
1149 TP: YEAH  
1150 SO: ARE WE IN THE CITY OF WEST VALLEY?  
1151 TP: YES....  
1152 SO: HERE'S YOUR LIE QUESTION, HAVE YOU EVER DRIVEN OVER THE  
1153 POSTED SPEED LIMIT?

1175 SO: IT'LL TAKE US PROBABLY AT LEAST TEN MINUTES TO PRINT THINGS  
1176 TP: THAT'S FINE.  
1177 SO: ALRIGHT THANKS BRO!  
1178 TP: OKAY (THE DOOR OPENS AND CLOSES) (THE DOOR OPENS AND  
1179 CLOSES)  
1180 UN: THERE YA GO MY MAN  
1181 TP: THANK YOU APPRECIATE IT  
1182 UN: YOU BET YOU SURVIVED?  
1183 TP: YEAH  
1184 UN: OKAY JUST A FEW MINUTES  
1185 TP: OKAY (THE DOOR OPENS AND CLOSES).....  
1186 (BACK GROUND  
1187 TALKING).....  
1188 SO: (THE DOOR OPENS AND CLOSES) ALRIGHT WE'RE BACK SORRY IF IT  
1189 WAS MORE THAN TEN MINUTES.  
1190 TP: THAT'S ALRIGHT.  
1191 SO: I'M GONNA SHOW YOU THESE CHARTS HOW THEY WORK HERE  
1192 TP: ALRIGHT  
1193 SO: LET'S GET THE LINES SCORED. YOU GOT THE FULL MONTY TODAY  
1194 THERE WAS LIKE FIVE EVERY SINGLE PERSON THAT DOES THIS  
1195 WILL SERIOUS HAND THEM TO EVERYBODY TO MAKE SURE.  
1196 TP: OH (LAUGH, LAUGH)  
1197 SO: SO THESE, THESE ARE THE CHARTS YOU DID AND WHAT YOUR  
1198 ULTIMATELY TRYING TO GET IS A CHRISTMAS TREE DESIGN  
1199 TP: UM HUH



1200 SO: THAT MEANS THE TALLER THE CHRISTMAS TREE LOOKING IS THE  
1201 MORE TRUTHFUL YOU ARE AND THE WIDER THE MORE BLOCKED  
1202 YOU ARE THE, THE MORE STRESS IS IN YOUR VOICE OKAY?

1222 SO: AND AH WE DID EACH EXAMINER AND THE COMPUTER ALL

1225 TP: WONDERFUL  
1226 SO: ON YOUR CHART SO. DO YOU HAVE ANY QUESTIONS FOR US OR  
1227 ANYTHING?

1228 TP: AH WELL YOU KNOW MY ONLY CONCERN YOU KNOW I MEAN  
1229 HERE'S, HERE'S THE SITUATION AH I GOT INVOLVED BECAUSE I  
1230 WAS HELPING SOMEBODY OUT, I PROVIDED HER WITH SOME  
1231 ADVICE  
1232 SO: UM HUH

1233 TP: AND AH SHE ENDED UP DISAPPEARING AND I YOU KNOW IT'S JUST  
1234 BASED UPON WHAT SHE WAS GOING THROUGH AND BASED UPON  
1235 WHAT SHE WAS TELLING ME I WAS CONCERNED FOR HER WELL

1267 TP: I PROBABLY SHOW THE SAME FRUSTRATION AS EVERYBODY ELSE

1268 I'M SURE

1269 EM: OH I'M SURE ABSOLUTELY AND YOU'RE REACTED ON IT

1270 TP: YEAH

1271 EM: WHICH YOU KNOW THERE'S NOTHING WRONG WITH THAT UM YOU

1272 KNOW?

1273 TP: WELL I ASKED DETECTIVE PETERSON

1274 EM: THERE'S NOTHING WRONG WITH THAT SO, BUT AH NO I CAN

1275 ASSURE YOU JUST AS I'VE AH TOLD OTHERS THAT ARE CLOSE TO

1276 THE FAMILY AND YOU KNOW HER, HER PARENTS AND STUFF THAT

1277 YOU KNOW WE'RE WORKING ON THIS THING EVERY DAY

1278 MULTIPLE HOURS EVERY DAY AH

1279 TP: MANY PEOPLE

1280 EM: ALL WEEK MANY PEOPLE UM AND IT'S A VERY UNIQUE CASE UM AS

1281 FAR AS ON A LAW ENFORCEMENT SIDE AND A PROSECUTION SIDE

1282 AND, AND EVIDENCE AND ALL THAT STUFF IS VERY UNIQUE SO YOU

1283 KNOW THIS TYPE OF INVESTIGATION JUST HAS TO BE

1284 INVESTIGATED IN A DIFFERENT FASHION SO YEAH YOU'RE NOT

1285 GONNA SEE A LOT ON THE NEWS, YOU'RE NOT GONNA HEAR MUCH

1294 TO INVESTIGATE EVERYTHING WE HAVE TO INVESTIGATE IT FROM  
1295 THE INSIDE OUT

1296 TP: UM HUH

1297 EM: AND AH YOU KNOW LOOK UNDER EVERY STONE, CROSS EVERY "T"  
1298 AND DOT EVERY "I" AND JUST YOU KNOW I MEAN THAT STUFF  
1299 TAKES SOME TIME UM UNFORTUNATELY. NOW IN REGARDS TO  
1300 YOUR STATEMENT ABOUT JOSH AND YOU KNOW HIM BEING

1352 TIME I MET HIM AH YOU KNOW THIS GUYS NUTS, THIS GUY IS HE'S  
1353 A WHACK JOB, I COULD TELL THAT RIGHT FROM WHEN I MET HIM

1376 BROTHER AND HIM ARE TWO PEAS IN A POD

1377 EM: UM HUH.

1378 TP: AND AH AND SUSAN HAD TOLD ME THAT ONE OF THE REASON WHY  
1379 SHE LEFT AH WASHINGTON WAS BECAUSE AND MOVED DOWN  
1380 HERE WAS BECAUSE HIS AH DAD WAS HITTING ON HER

1381 EM: UM HUH.

1382 TP: YOU KNOW SUSAN I TOLD HER  
1383 SO: DID SHE SAY ANY OTHER REASONS WHY IT'S KIND OF IN THE  
1384 (SOMEONE COUGHING IN THE BACK GROUND)  
1385 TP: NO UM ALL I KNOW IS HE APPROACHED HER ONE DAY ON THE  
1386 PHONE AND SAID AH HE TOLD SUSAN THIS, HE SAID AH, AH I KNOW  
1387 THAT YOU CAN SENSE AH THE FEELING BETWEEN THE TWO OF US
