62 TP: SO UM... I'M NOT SURE IF I WAS IN DAVIS COUNTY THAT DAY OR NOT...

63 BUT ANYWAY I WAS ... I WAS HOME I WAS...(PEN CLICKING) I THINK I

64 WAS ALREADY ON MY WAY HOME AND A ... I WAS THERE WITHIN...

80 TP: IT... SHE JUST HURTS YA KNOW... SHE'S GOT A LOT OF FEELINGS, BUT

81 ANYWAY SHE WAS JUST DRILLING HIM ABOUT YA KNOW WHERE'S SUSAN  
82 AND ... AND A ...I GUESS HE HAD SAID BEFORE I GOT THERE THAT ITS...HE  
83 SAYS IT'S NOT LIKE I STABBED HER AND UM... BUT YOU COULD TALK TO

91 LITTLE SPACEY... A...HE SAID THAT HE HAD ONLY HAD SIX HOURS OF

104 KNOW... HE SAYS (PEN CLICKING) WELL (PEN CLICKING) NO I WAS UP  
105 GETTING ... GETTING READY FOR OUR CAMPING TRIP AND I SAYS..  
106 CAMPING TRIP... WHAT... YA KNOW WHAT ARE YOU TALKING ABOUT AND  
107 HE SAID A (PEN CLICKING) HE SAID A ...WELL I GOT A NEW GENERATOR

120 WHAT'S GOING ON... YA KNOW... HOW YA FEELING AND HE HE'S LIKE  
121 WELL THE POLICE ARE DEALING WITH THAT

123 TP: AND I JUSSST YA KNOW AND THEN CRYSTAL JUST KEPT GOING ON AND  
124 ON AND ON AND I SAYS CRYSTAL ... YA KNOW CAUSE IN THE PROCESS HE  
125 TOLD US THAT HE HAD MET WITH YOU GUYS AND HAD SPENT TEN HOURS  
126 HERE I GUESS TALKING WITH YOU GUYS

128 TP: OR SOMETHING LIKE THAT (SOMEONE CLEARING THROAT) AND I I TOLD I  
129 FINALLY TOLD CRYSTAL I SAYS YA KNOW WHAT HE'S (PEN CLICKING) HE  
130 DOESN'T.. HE HASN'T HAD A LOT OF SLEEP YA KNOW ...LET'S YA KNOW...  
131 LET'S CUT DOWN ON THE QUESTIONS YA KNOW AND UM... YA KNOW HE

183 TP: NO HE DIDN'T ... HE DIDN'T SAY ANYTHING YA KNOW AND SO ... UM ...

184 AGAIN IT WAS MORE ABOUT JOSH... IT WAS MORE ABOUT YA KNOW JUST

185 KIND OF TALKING ABOUT HOW HE WAS TIRED AND TALKING ABOUT HIS

186 VAN AND YA KNOW THE SMELLS IN HIS VAN AND WORRIED ABOUT HIS

187 KIDS YA KNOW SMELLING THE SMELLS IN HIS VAN AND HE JUST DIDN'T

188 WANT TO TALK ABOUT SUSAN AT ALL

191 TP: AND SO... YA KNOW THAT'S ... THAT'S BASICALLY IT I MEAN AS FAR

192 AS...WHAT'S HAPPENED SINCE

193 BP: HAVE... HAVE... HAVE YOU TALKED TO HIM SINCE THEN

194 TP: NO ACTUALLY A... UM... YA KNOW...WELL... LE..LET'S JUST SAY

195 THIS...OKAY...ME ... CRYSTAL AND I UM... YA KNOW CHURCH GOERS...

196 SUSAN IS ALWAYS THERE YA KNOW SHE'S A WAS A IN THE RELIEF

197 SOCIETY PRESIDENCY AND SHE ALWAYS HAD HER BOYS AND YA KNOW  
198 WE KIND OF GOT TO KNOW HER BECAUSE JOSH REALLY DIDN'T GO TO  
199 CHURCH UNTIL THEY STARTED DOING THEIR [REDACTED]
