6 AP: RECORD YOUR MESSAGE AFTER THE TONE, TO SEND A NUMERIC PAGE  
7 PRESS "5" WHEN YOU ARE FINISHED RECORDING HANG UP OR FOR  
8 DELIVER OPTIONS PRESS POUND.  
9 GC: (PHONE RINGING)  
10 AP: HELLO  
11 GC: HEY IS STEVEN THERE?  
12 AP: UM LET ME CHECK, MAY I ASK WHO CALLED?  
13 GC: THIS IS DETECTIVE COOK FROM WEST VALLEY CITY  
14 AP: OKAY LET ME JUST LOOK AND SEE IF HE'S HERE.  
15 GC: THANK YOU..... (A LOT OF BACKGROUND NOISE).....  
16 AP: I'M SORRY HE DOESN'T APPEAR TO BE HERE.  
17 GC: OKAY DOES HE, DOES HE WORK USUALLY DURING THE WEEK AT THIS  
18 TIME?  
19 AP: YEAH HE DOES/  
20 GC: OKAY THANK YOU VERY MUCH.  
21 AP: UM WOULD YOU LIKE ME TO TAKE A NUMBER AND HAVE HIM CALL YA  
22 BACK?

23 GC: YEAH THAT WOULD BE GREAT.  
24 AP: OKAY WHAT'S YOUR NAME?  
25 GC: ITS GAVIN COOK, DETECTIVE COOK AND I SPOKE WITH HIM A LITTLE

40 GC: NO PROBLEM. YEAH JUST TELL HIM I CALLED AND THEN IF HE CAN GIVE  
41 ME A CALL BACK I'D APPRECIATE.  
42 AP: I WILL  
43 GC: IS THIS ALENA?  
44 AP: I'M SORRY?  
45 GC: IS THIS ALENA?  
46 AP: AH YEAH  
47 GC: OKAY I APPRECIATE IT.  
48 AP: YOU KEEPING TABS.  
49 GC: WHAT'S THAT?  
50 AP: YOU GUYS ARE KEEPING TABS.  
51 GC: WHEN I, WHEN I TALKED TO HIM BEFORE HE JUST SAID WHO, WHO AH
