20 SP: YEAH AND I, IF, IF THERE'S ANY WAY TO FIND SUSAN WE WANT THAT, I
21 WANT THAT I'M SO DEFINITELY IF THERE'S SOMETHING I CAN DO
22 GC: WELL I

23 SP: I CAN SAY OR DO OR WHATEVER.

24 GC: AND THAT'S WHAT ULTIMATELY THAT'S AH, THAT'S OUR GOAL HERE

25 SP: WHAT, WHAT ARE YOU GUYS THINKING RIGHT NOW (INAUDIBLE) ARE WE

26 TALKING ABOUT THE, IS SHE JUST MISSING OR DO YOU THINK SHE IS

27 PRESUMED DEAD OR WHAT, WHAT ARE WE TALKING ABOUT HERE

28 ANYWAY?

29 GC: YOU KNOW YOUR GUESS, RIGHT NOW UM WE DON'T KNOW

30 SP: YOU DON'T KNOW

31 GC: UM OBVIOUSLY AH, AH SHE'S MISSING AND WE KNOW THAT AND THAT'S

32 KIND OF WHERE WE'RE AT AND

33 SP: SO SHE'S MISSING OKAY

34 GC: UM WE WANT TO WORK TO AN END WHERE WE CAN FIND HER AH

35 HOPEFULLY YOU KNOW OUR, OUR AH PREFERENCE WOULD BE THAT

36 SHE'S OKAY AND SHE'S JUST SOME WHERE.

37 SP: OKAY

38 GC: BUT WE DON'T KNOW AH OBVIOUSLY THERE'S A LOT OF INFORMATION IN

39 THE MEDIA AND A LOT OF INFORMATION THAT AH THROUGH OUR

40 INVESTIGATION THAT WE'VE GATHERED

41 SP: YEAH

42 GC: UM I CAN'T GET INTO A LOT OF THAT WITH ANYBODY

43 SP: OH SURE YEAH

44 GC: UM BUT BASICALLY WHY WE'RE HERE TODAY STEVE IS TO JUST GET AN

45 IDEA OF, OF UM YOUR THOUGHTS YOU'RE AH YOU KNOW YOU'RE

46 RELATIONSHIP WITH JOSH AND, AND YOUR KNOWLEDGE OF JOSH AND

47 SUSAN'S RELATIONSHIP AND JUST KIND OF BUILD THIS PUZZLE AND PUT

48 SP: YEAH

49 GC: TOGETHER AND AH, AH JUST SO WE HAVE INFORMATION.

50 SP: YEAH, YEAH ABSOLUTELY

51 GC: AND, AND ANTHING CAN HELP YOU KNOW THAT'S WHY WE'RE HERE AND

52 THAT'S WHAT WE'RE DOING.

53 SP: LET ME ASK YOU, MAY I ASK GAVIN COOK YOU'RE THE ONE SPEAKING

54 ARE YOU THE LEAD INVESTIGATOR?

55 GC: I'M NOT.

56 SP: YOU'RE NOT WELL LEFAVOR YOU ARE, ARE YOU

57 JL: I'M JUST ANOTHER DETECTIVE.

58 SP: OH SO ONE OF WEST VALLEY'S DETECTIVES

59 JL: JUST SO YOU UNDERSTAND THERE'S SO MANY DIFFERENT DIRECTIONS

60 SP: YEAH SURE

61 JL: THIS INVESTIGATIONS GOING AND WE PULL UP A LOT OF RESOURCES

62 SP: GOT IT, GOT IT

63 JL: AND ONE GUY AS THE LEAD INVESTIGATOR OBVIOUSLY CAN'T DO

64 EVERYTHING HIMSELF AND SO WHAT WE TRY TO DO IS JUST USE OTHER

65 RESOURCES TO GO IN ALL THESE OTHER DIRECTIONS TO TRY AND

66 GATHER AS MUCH INFORMATION AS WE POSSIBLY CAN.

67 SP: OKAY NOW SUSAN

68 JL: AND RELAY THAT INFORMATION TO THE, THE LEAD INVESTIGATOR

69 SP: AND JUST ANA, ANALIZE IT AND

70 JL: IT (INAUDIBLE TWO PEOPLE TALKING AT ONCE) IT JUST ISN'T POSSIBLE

71 BECAUSE

72 SP: SOME PERSONS

73 JL: THERE'S SO MUCH SPECULATION AS TO WHAT'S GOING ON AND A LOT OF

74 DIFFERENT THEROIES THAT WHAT POSSIBLY COULD GO ON.

75 SP: IT'S A MEDIA CIRCUS.

76 JL: WE'RE JUST TRYING TO GATHER AS MUCH INFORMATION AS WE CAN

77 SP: YEAH, YEAH AND GARY SANDERS FROM THE PIERCE COUNTY AH

78 SHERIFF'S DEPARTMENT ARE YOU INVOLVED OR ARE YOU JUST HERE AS

79 A JURISDICTIONAL THING

80 GS: YEAH.

81 SP: JURISDICTIONAL?

82 GS: YEAH LIASON AND LAW (INAUDIBLE)

83 JL: IT WOULD BE INAPPROPRIATE FOR US TO COME AND AH MAKE CONTACT
84 WITH AN INDIVIDUAL IN SOMEBODY ELSE'S JURISIDICATION

85 SP: OH SURE.

86 JL: WITHOUT HAVING A REPRESENTATIVE FROM THEM WE DON'T WANT TO
87 STEP ON ANYBODY'S TOES IN THEIR AREA

88 SP: YEAH

89 JL: AND AH SO IT'S, IT'S MUCH BETTER TO DO THAT.

90 GC: WELL I WILL TELL YOU THIS STEVE AH JUST SO YOU KNOW MY, MY
91 SQUAD

92 SP: UM HUH

93 GC: IS AH THE MAIN SQUAD HANDLING THIS UM THE LEAD DETECTIVE IS
94 OBVIOUSLY BACK IN SALT LAKE CITY

95 SP: UM HUH

96 GC: AH HE'S YOU KNOW

97 SP: YOU KNOW I'VE BEEN, YOU KNOW I'VE BEEN SAYING ALL THIS STUFF AND
98 I DIDN'T EVEN TURN THIS ON BUT THAT'S OKAY

99 GC: OKAY

100 SP: WE'LL JUST GO FROM HERE SO YEAH I JUST WANTED TO, I'M FINE WITH IT
101 I JUST WANT TO GET YOU KNOW FOR MY OWN GOOD A RECORDING HERE
102 OF WHY I'M THIS HAS BEEN A REAL EMOTIONAL TIME FOR ME TO I MEAN
103 REALLY EMOTIONAL.

104 GC: SO ANY WAY MY SQUAD'S HANDLING THE INVESTIGATION AND WE THE
105 ACTUAL LEAD DETECTIVE IS IN, IS IN SALT LAKE

106 SP: UM HUH.

107 GC: UM AND THERE'S SIX OF US AND WE'RE OUR SQUAD IS THE UM MAIN
108 SQUAD HANDLING THIS.

109 SP: THERE'S SIX IN YOUR SQUAD?

110 GC: YEAH THAT HANDLE SO, SO WE'RE THE KEY, WE'RE THE HUB OF
111 EVERYTHING FOR THE MOST THE PART ONE OF THE SIX DETECTIVES IS
112 THE ACTUAL LEAD DETECTIVE AND HE'S GATHERED ALL THE
113 INFORMATION
114 SP: OKAY
115 GC: AND THEN WE HAVE, JUST LIKE AH DETECTIVE LEFAVOR SAID YOU KNOW
116 HAVE THIS IS HUGE THING IT TAKES A LOT OF PEOPLE SO
117 SP: YEAH
118 GC: UM YOU KNOW THERE'S QUITE A FEW OTHER DETECTIVES AND
119 INVESTIGATORS
120 SP: YEAH
121 GC: HELPING US OUT SO
122 SP: OKAY
123 GC: SO AH TELL ME ALITTLE BIT ABOUT UM AH WHAT YOU KNOW ABOUT
124 JOSH AND SUSAN'S RELATIONSHIP MAYBE OVER THE LAST COUPLE OF
125 YEARS, AH
126 SP: OKAY
127 GC: GIVE US AN IDEA OF WHAT'S GOING THROUGH SUSAN'S HEAD YOU
128 KNOW?
129 SP: OKAY LET ME, LET ME START BACK A LITTLE FURTHER THAN THAT
130 BECAUSE UM YOU KNOW THEIR WERE SOME ISSUES IN THEIR MARRIAGE
131 EARLY ON
132 GC: AH HUH
133 SP: AH WE'RE TALKING MAYBE ABOUT MAYBE 2002 YOU KNOW THEY HAD
134 BEEN MARRIED A YEAR OR TWO AND AH UM AND, AND SOME OF THESE
135 THINGS THAT HAVE HAPPENED IN THE LAST COUPLE OF WEEKS AH HAVE
136 BROUGHT THINGS TO MIND AND I START ASKING MYSELF WHAT ELSE IS
137 GOING ON YOU KNOW BECAUSE UM FOR EXAMPLE: AH YOU KNOW ONE
138 DAY AH SUSAN IT WAS (INAUDIBLE) RUSH AND SHE GOT A SHE WORKED

139 FOR A SHOP HERE IN THE SOUTH OF THE MALL AH HERE IN THE VALLEY IT
140 WAS SOUTH JUST DOWN THE ROAD FROM HERE AND AH UM YOU KNOW
141 ONE DAY I WALKED INTO THE SALON IT WAS THE EVENING AND I DON'T
142 KNOW IF ANYBODY ELSE IS AROUND BUT SUSAN YOU KNOW SOME
143 PEOPLE YOU KNOW THEY PROBABLY JUST DIDN'T HAVE A LOT OF PEOPLE
144 ON THE STAFF ON IT LOOKS QUIET AND AH I, I DON'T REMEMBER WHAT I
145 WAS DOING THERE BECAUSE I DIDN'T I WASN'T THERE TO HAVE MY HAIR
146 CUT EVEN THOUGH SHE DID CUT MY HAIR THERE FREQUENTLY YOU
147 KNOW, ONCE A MONTH OR WHATEVER, AND I WALKED UP BEHIND HER
148 AND SHE WAS BASICALLY JUST YOU KNOW IT WAS I FIND, I FIND HER SHE
149 DIDN'T KNOW I WAS THERE, SHE WAS JUST UNKNOWING ABOUT
150 PROBLEMS IN HER MARRIAGE WITH JOSH AND THINGS LIKE THAT, THAT
151 WAS SEVEN YEARS AGO THOUGH

152 GC: UM HUH

153 SP: NOW I DON'T KNOW OF ANY PROBLEMS IN RECENT TIMES BUT THAT I
154 KNOW THEY'VE HAD SOME ISSUES YEARS AGO YOU KNOW

155 GC: AH HUH

156 SP: AND SHE HAD, HAD EVERYTHING I MEAN JUST BASED ON THAT'S THE
157 ONLY INCIDENT THAT I ACTUALLY WITNESSED BUT THAT WAS ABOUT
158 2000 I'M GONNA SAY 2002 SHE KIND OF HAD A TENDANCY TO AH YOU
159 KNOW JUST UNLOAD ON STRANGERS

160 GC: AH HUH

161 SP: YOU KNOW ABOUT HER, SHE PROBABLY, I MEAN SHE TALKED TO ME
162 ABOUT HER PROBLEMS AND EVEN LITTLE BIT ABOUT THEIR SEX LIFE I
163 MEAN IF SHE WAS YOU KNOW THAT KIND OF THING SO I MEAN SHE
164 TENDED TO BE A LITTLE BIT OPEN ABOUT STUFF LIKE THAT YOU KNOW.
165 UM AH AND I LIKE I SAY I DON'T KNOW OF ANY THE LAST TIME I SAW HER
166 WAS IN FEBRUARY SHE LOOKED YOU KNOW WHEN SHE AND JOSH AND I
167 WERE TOGETHER WITH THE BOYS IT WAS PERFECT. I MEAN IT WAS COLD

168 AH IT WAS PLEASANT SHE WAS ALWAYS NICE TO ME, SHE, SHE SEEMED
169 TO LIKE ME A LOT

170 GC: AH HUH

171 SP: AH SOMETIMES LIKE IF HER, IF HER IN FACT ABOUT MAYBE ABOUT TWO
172 YEARS AGO THERE WAS SOME ISSUE THAT CAME UP WHEN JOSH WOULD
173 COME UP AND VISIT AND WE'RE VISITING WITH HER PARENTS AND HER
174 MOTHER IS YOU KNOW PRETTY AH I DON'T KNOW I WON'T GET INTO THIS
175 THAT'S A DIFFERENT ISSUE BUT AH WHEN THE TWO OF THEM GOT, GOT
176 TOGETHER THEY WERE (INAUDIBLE) WERE TALKING ABOUT ME AND IT
177 WASN'T REALLY VERY GOOD AND SUSAN STILL CAME OVER TO VISIT AND
178 WAS (INAUDIBLE) NICE TO ME THAT JOSH HAD TO KIND OF YOU KNOW
179 HEY LOOK, "LAY OFF THIS IS MY DAD", YOU KNOW WHAT I MEAN DON'T,
180 DON'T BE HAVING A CONVERSATION LIKE THAT.

181 GC: WHAT HAD, HAD SORRY TO STOP YA UM, MAYBE I'M I MISSED SOMETHING
182 IN THERE I, YOU SAID, JOSH SAID TO LAY OFF A LITTLE BIT OR WHATEVER
183 I

184 SP: WELL TO STAND ON THAT I, I DON'T PART OF IT IS THAT YOU KNOW I'LL
185 GO BACK EVEN A LITTLE FURTHER AND THAT IS THESE PEOPLE ARE, ARE
186 VERY GOOD LATTER DAY SAINTS AND I'M NOT

187 GC: OKAY

188 SP: I'M A DROP OUT

189 GC: OKAY

190 SP: I'M, I'M, I'M A BAD INFLUENCE ON JOSH I COULD BE A BAD INFLUENCE ON
191 THEIR KIDS I MEAN THAT'S WHAT THEIR

192 GC: OH OKAY

193 SP: AND SO

194 GC: THAT'S WHAT THAT CONVERSATION WITH HER MOM WAS ABOUT?

195 SP: THERE'S SOME POINTS OF CONTENTION THERE YEAH, YEAH

196 GC: OKAY, OKAY

197 SP: SO ANYWAY SO THE FACT IS UM THAT, THAT WHEN SHE WAS VISITING ME
198 AND SHE DID THAT SAME WEEK AFTER THE CONVERSATION THE, THE
199 COUPLE OF YEARS AGO YOU KNOW EVERYTHING WAS FINE, I MEAN
200 THERE WAS YOU KNOW I MEAN IT WAS FINE. UM THE AH THE, THE VISIT
201 THEY MADE LAST AH FEBRUARY AH A VERY HAPPY VISIT. THEY WERE
202 HAPPY, I WAS HAPPY, I WAS HAPPY TO BE WITH THEM. UM THEY SEEMED
203 TO BE HAPPIER TO ME AH THE BOYS HAD A LOT OF FUN OVER AT [REDACTED]
204 PLACE THEY WENT ON THE FERRY, AH TOOK PICTURES ALL KINDS OF
205 STUFF AND AH YOU KNOW AH JOSH SAID YOU HAVE HIS HARD DRIVE AND
206 I DIDN'T SEE IN FRONT OF IT (INAUDIBLE) YOU TOOK A LOT OF HIS STUFF
207 SO

208 GC: AH HUH

209 SP: ANY WAY BUT AS FAR AS IN SUSAN AND ME

210 GC: OKAY SO 2002 YOU KNOW THERE'S SOME ISSUES IN THE MARRIAGE, AH
211 BUT SINCE THEN JOSH HAS NOT AH TALKED TO YOU OR MENTIONED
212 ANYTHING YOU KNOW OVER THE LAST YEAR OR TWO THAT UM WAS
213 GOING ON WITH THEM OR MAYBE ANY PROBLEMS

214 SP: NO NOT AT ALL.

215 GC: EVERYTHING AS FAR AS YOU'RE CONCERNED IS GOOD?

216 SP: YEAH I MEAN, I MEAN AND WHEN THEY WERE WITH ME IT WAS PERFECT. I
217 MEAN YOU KNOW THERE MAY, I'M, I'M NOT GONNA SAY THEY PROBABLY
218 DIDN'T HAVE SPATS AND ISSUES AND THINGS LIKE BUT I MEAN IT WAS
219 GOOD UM

220 GC: WELL EVERY MARRIED COUPLE YOU KNOW.

221 SP: YEAH EVERY (INAUDIBLE)

222 GC: IT GOES UP AND DOWN

223 SP: YEAH, YEAH

224 GC: NOTHING'S AH NOTHING'S PERFECT ALL THE TIME SO. UM TELL ME ABOUT
225 SUSAN WHAT DID YOU THINK OF HER AS A PERSON, OR WHAT TYPE OF

226 PERSON OR PERSONALITY DOES SUSAN HAVE?

227 SP: UM I LIKED HER

228 GC: UM HUH

229 SP: AS A PERSON UM SHE SEEMED, SHE SEEMED VERY CONFLICTED TO ME
230 YOU KNOW IN A LOT OF WAYS

231 GC: AH HUH

232 SP: AH HER RELIGION AND BY HER SEXUALITY BUT OTHER THAN THAT SHE, I
233 THOUGHT SHE WAS A VERY NICE PERSON. I, I FELT LIKE I UNDERSTOOD
234 HER BECAUSE I THOUGHT SHE HAD SIMILAR CONFLICTS IN MY LIFE AND I
235 RESOLVED A LOT OF THEM YOU KNOW.

236 GC: AH HUH

237 SP: SO FOR ME WHEN I SEE PEOPLE LIKE THAT IN CONFLICT ESPECIALLY
238 AROUND THAT RELIGION YOU KNOW I JUST AH YOU KNOW, YOU KNOW IT
239 JUST SEEMS TO ME LIKE THIS, YOU KNOW PEOPLE LIKE IN MY OWN HEART
240 YOU KNOW THAT KIND OF THING YOU KNOW. UM I MEAN AH UM SO YOU
241 KNOW THAT'S KIND OF THE WAY I SAW HER, SHE HAD, SHE HAD
242 CONFLICTS IN HER MIND I THINK. UM I REMEMBER AH THIS IS AGAIN BACK
243 IN 2002 AND SHE MAY HAVE CHANGED SINCE THEN, I MEAN PEOPLE
244 CHANGE WHEN THEY HAVE KIDS YOU KNOW I MEAN THEY'VE GOT TWO
245 KIDS SINCE THEN, SO ANYTHING THAT HAPPENED IN 2002 YOU KNOW ALL
246 BETS ARE OFF YOU KNOW THEY PROBABLY PART OF THEIR PAST HISTORY
247 BUT IT TRAVEL, THE ONLY REASON I BROUGHT THAT ONE INCIDENT UP AT
248 THE HAIR SALON IS BECAUSE IT, IT WHEN I THOUGHT ABOUT IT, IT KIND
249 OF IT OCCURRED TO ME THAT COULD BE A CLUE TO WHAT I MEAN SHE
250 LIKES TO TALK ABOUT THINGS LIKE THAT, SHE DOESN'T NECESSARILY AH
251 AT LEAST AT THAT TIME I DIDN'T THINK THAT WAS A VERY DISCREET
252 THING TO DO YOU KNOW WHAT I'M SAYING IT DIDN'T SEEM VERY
253 DISCREET TO ME TO BE DISCUSSING YOUR OWN MARRIAGE OR YOUR
254 (INAUDIBLE) I, I DON'T KNOW MAYBE THE GUY WASN'T A TOTAL

255 STRANGER, HE WAS TO ME BUT HE MIGHT OF JUST BEEN A CLIENT THAT
256 SHE HAD IN HER REGULAR I DON'T KNOW, BUT I MEAN THAT'S EVEN
257 WORSE SO I DON'T KNOW.

258 GC: OKAY

259 SP: SO WAS SHE TALKING TO PEOPLE MAYBE SHE WAS MAYBE THERE WAS
260 SOMEONE LIKE I TALKED TO MY NIECE WHO SAID THAT SOME OF HER
261 FRIENDS APPARENTLY SHE WAS TALKING TO THEM ABOUT ISSUES AND
262 PROBLEMS AND YOU KNOW I, I DON'T KNOW ABOUT THOSE ISSUES AND
263 PROBLEMS. APPARENTLY IF SHE HAD SOMETHING IN HER MIND THAT WAS
264 CONCERNING HER MAYBE IT WAS SOMETHING ELSE PROBABLY, MAYBE
265 JOSH DIDN'T KNOW ABOUT IT, I DIDN'T KNOW ABOUT IT.

266 GC: OKAY

267 SP: YOU KNOW

268 GC: UM GENERAL PERSONALITY AH FOR SUSAN, HARD HEADED, EASY GOING,
269 AH?

270 SP: I'D SAY, I'D SAY HARD HEADED.

271 GC: OKAY

272 SP: IN SOME WAYS AND, AND SWEET AND EASY GOING IN OTHER WAYS, I
273 MEAN SHE COULD, SHE COULD TURN FROM SWEET AND EASY GOING TO
274 HARD HEADED VERY QUICKLY I'VE, I'VE SEEN HER DO THAT YEAH.

275 GC: OKAY

276 SP: BUT YOU KNOW I, I GUESS THERE'S A LOT OF PEOPLE LIKE THAT THERE'S
277 JUST I MEAN SHE, SHE DIDN'T HAVE THE HARD HEADED ASPECT.

278 GC: OKAY. UM YOU SAID THAT SHE AH IN THE PAST HAD TALKED TO YOU
279 ABOUT SOME OF THESE CONFLICTS AH REALLY

280 SP: WELL I'M, I'M NOT GONNA SAY SHE REALLY TALKED TO ME ABOUT IT I
281 THINK I PICKED UP A LOT OF THINGS JUST FROM WHAT THINGS SHE SAID
282 YOU KNOW OVER HEARING STUFF, PUTTING TWO AND TWO TOGETHER,
283 READING BETWEEN THE LINES, I DON'T KNOW I GUESS THAT'S PROBABLY

284 MORE WHAT, WHAT IT WAS THAN ANYTHING AND HER HAVING VIEWS
285 ABOUT ME SOMETIMES AND I, I CAN'T PINPOINT IT DOWN I COULDN'T
286 EVEN PIN POINT BUT YOU KNOW HOW IT IS YOU KIND OF HAVE THESE
287 IMPRESSIONS IN YOUR MIND AND THEY DON'T REALLY AMOUNT TO
288 ANYTHING BUT YOU KNOW THERE'S SOMETHING THERE

289 GC: RIGHT

290 SP: YOU JUST GO I THINK THERE'S, I THINK THERE'S A CONFLICT HERE YOU
291 KNOW

292 GC: RIGHT

293 SP: I THINK YOU KNOW AND, AND OF COURSE GIVEN MY ATTITUDES I WOULD
294 BE LOOKING FOR CONFLICTS

295 GC: RIGHT

296 SP: YOU KNOW, MAYBE SEEING THINGS THAT WE'RE NOT THERE BUT WHO
297 KNOWS

298 GC: CAN YOU TELL US A LITTLE BIT SOME EXAMPLES OF THAT OR WHAT YOU?

299 SP: WELL YEAH LET ME JUST GIVE YOU ONE EXAMPLE: THAT, THAT UM WHEN
300 YOU KNOW THEY VISITED WITH ME FOR A WHILE THAT WAS ABOUT 2002 I

1171 OUT IN MY MIND YOU KNOW LIKE SHE JUST SHE GOT IMMEDIATELY
1172 UPSET, COLD I MEAN IT WAS LIKE NIGHT AND DAY
1173 GC: AH HUH
1174 SP: BECAUSE SEE WHAT WAS HAPPENING IS WE WERE UP IN KENT WHERE
1175 JOSH WAS MEETING WITH SOME PEOPLE I KNOW AND HE KNOWS AND HE
1176 WAS THERE GIVING ME SOME HELP LEARNING HOW TO UM TO DRIVE
1177 TRUCK HE WAS GOING TO GET AH COMMERCIAL DRIVING TRUCK
1178 DRIVER'S LICENSE
1179 GC: AH HUH
1180 SP: AND UM SHE DECIDED TO GO BACK TO PUYALLUP WITH ME AND THIS WAS
1181 WAY AFTER THAT PEAK INCIDENT I MENTIONED SO YOU KNOW LIKE I SAY
1182 THERE WAS SOMETHING THERE WAS ANOTHER INCIDENT AFTER THAT

1183 WHERE SHE AND I WERE ROLLING TOGETHER DRIVING SOME WHERE OR
1184 WHATEVER AND YOU KNOW I, I NEVER REALLY FELT LIKE IT'S NOT LIKE I

1201 TIME THAT WAS?

1202 SP: AH THAT WOULD BE I DON'T KNOW 2003 AND IT WAS YEARS AGO WAY
1203 BEFORE THEY MOVED TO, TO UTAH IT WAS YOU KNOW IT WAS A MATTER
1204 OF I WANT TO SAY WEEKS OR MONTHS BEFORE THEY MOVED TO UTAH.
1205 THAT WAS YEARS BEFORE THEY HAD KIDS TO AND I MEAN YOU KNOW

1207 KNOW I, I, I WOULD HOPE TO THINK THAT SHE WAS NOT REALLY YOU

1209 WHATEVER DEEP CALLING MAYBE IT WASN'T A (INAUDIBLE)

1237 BELIEF OR HER YOU KNOW THE BACK OF HER MIND AH WHO KNOWS WE
1238 COULD OF I DON'T KNOW I MEAN THERE IS SPECULATION YEAH

1239 GC: RIGHT AND YOU KNOW

1240 SP: I DON'T HAVE A CLUE I JUST ALWAYS MAKE I MEAN MAYBE THE STAGE

1241 WOULD OF, WOULD OF HAPPENED YOU KNOW BECAUSE IT LIKE I'VE
1242 OFTEN WISHED THAT IT HAD SOMETHING HAD GONE FURTHER VERY
1243 MUCH, VERY OFTEN
1244 GC: RIGHT, RIGHT
1245 SP: YOU KNOW AND I MEAN IT WAS A REALLY, IT WAS A REALLY HARD THING
1246 TO WALK AWAY FROM I MEAN EITHER YOU CAN'T, YOU CAN'T YOU CAN
1247 NEVER STOP THINKING OF SUCH THINGS, YOU KNOW WHAT I MEAN, AT
1248 LEAST I CAN'T IT HURTS MY YOU KNOW
1249 GC: YEAH WELL HEY YOU KNOW I KNOW WHAT YOU'RE SAYING

1254 GC: OKAY, UM....AND LIKE I SAID THIS AH THIS IS CONFIDENTIAL PRIVATE AH
1255 IF WE TALK TO JOSH OR IF YOU WANT TO TALK TO US, WE'RE NOT, WE'RE

1316 GC: OKAY

1317 SP: I MEAN IT'S AN ODDITY BUT IT'S AH IT'S ONE OF THOSE THINGS THAT
1318 MAYBE THAT MAYBE THAT'S ONE OF THE PARTS PART OF HER
1319 PERSONALITY YOU KNOW

1320 GC: RIGHT

1321 SP: YOU KNOW WHAT I'M SAYING?

1322 GC: RIGHT

1323 SP: THAT'S WHY I BRING IT UP

1324 GC: OKAY

1325 SP: SO

1326 GC: UM ANYTHING ABOUT JOSH, JOSH IS AH LIFE IN THE LAST MONTH OR TWO
1327 OR SOMETHING LIKE THAT, THAT YOU CAN TELL US I THINK WE TOUCHED

1328 ON IT BEFORE BUT JUST AGAIN JUST TO MAKE SURE UM
1329 SP: WELL THE LAST COUPLE OF YEARS I MEAN HE JUST HAS SPENT SO MUCH
1330 TIME WITH THE BOYS AND YEAH HE'S CONSTANTLY TAKING THEM TO AH
1331 YOU KNOW HOME DEPOT AND LOWE'S SO THEY BUILD THINGS WITH THE

1348 SP: AND AH
1349 JL: MARRIAGE COUNSELING?
1350 SP: YEAH MARRIAGE COUNSELING YOU KNOW AND AH I, I, I YOU KNOW I FELT
1351 LIKE I MEAN I'M NOT A FAN OF THE MORMON CHURCH BUT I KIND OF FELT
1352 LIKE YOU KNOW BECAUSE WHEN I WAS GOING THROUGH MY I MEAN NOT
1353 BEFORE I WAS GOING THROUGH THE DIVORCE BUT WHEN MY, MY EX-
1354 WIFE AND I STARTED HAVING PROBLEMS ABOUT FIVE YEARS ACTUALLY
1355 BEFORE WE DIVORCED UM THIS WAS ABOUT FIFTEEN YEARS INTO OUR

1377 JL: WAS HE OR BOTH, BOTH OF THEM OKAY WERE THEY EQUALLY AND GOOD
1378 WITH GOING

1379 SP: I, I, I THINK SO YEAH I DON'T KNOW I THINK I MEAN I DIDN'T I DON'T
1380 SORRY I'M BEING ABSTINENT BUT I DON'T KNOW, I JUST DON'T EVEN
1381 KNOW I MEAN I'M GUESSING THAT THEY BOTH WERE BECAUSE THEY
1382 BOTH WERE GOING YOU KNOW, BECAUSE I KNOW THERE ARE CASES
1383 WHERE THE HUSBAND OR THE WIFE OBJECTS TO IT AND ONE OF THEM

1399 THAT SHE WANTED I, I CAN'T BELIEVE I HAVE A HARD TIME BECAUSE I
1400 CAN'T IMAGINE SUSAN NOT CALLING HER PARENTS, I JUST CAN'T
1401 IMAGINE THAT I MEAN SHE'S VERY CLOSE TO HER FATHER. UM I, I

1412 FAMILY SITUATION LIKE THAT I THINK SUSAN, I, I THINK HER, I THINK HER,
1413 HER YOU COULD SAY HER SELF IMAGE WAS BATTERED. I MEAN SHE
1414 SEEMED VERY CONFIDENT TO ME, SHE WAS A HARD WORKING PERSON,
