

Your name was given to me as one who has been successful prosecuting civil cases against Washington State agencies and others.

You may have heard of me and/or my family, because the Washington State Attorney General's office, various federal and local law-enforcement agencies, and private individuals have engaged in a smear campaign and attack against myself and my family for nearly three years.

The most salient consequence of that campaign was, in fact, the February 5, 2012 tragedy that claimed the lives of my beloved son, Josh Powell, and my two grandsons, [REDACTED] My son and grandsons were violated as a result of a "gut feeling" of

Some FBI operatives, that Josh's missing wife is dead, and that Josh and I and my youngest son conspired to eliminate her. I continue to believe in my son Josh's innocence with regard to his wife's disappearance. The simple truth is, there is no evidence that Susan Powell is dead or that Josh Powell had anything to do with her disappearance.

The circumstances surrounding the deaths of my three loved ones have convinced me that I am well-justified and strongly-advised to hold the offending agencies and individuals accountable by way of a wrongful-death suit, civil action.

There were dozens of unjustifiable, and I believe in some cases illegal and even criminal, acts taken against my family, some of which are as follows:

- 1) On 8/25/2011 my Puyallup, Washington home, shared by my son and grandsons, was searched for evidence related to my daughter-in-law Susan Powell's disappearance. The search of my home

took place 20 months after her disappearance, which occurred on December 7, 2009. Coincidentally, in that search, a compact disc was found with alleged evidence of voyeurism. The Pierce County Sheriff's Dept. arrested me and seized my grandsons on 9/22/2011, based on evidence in that disc. My conviction on that evidence is under appeal.

2) Although investigators in Utah drew a line from that compact disc pointing to me, and never even implied that Josh Powell had any part in it, a hearing held in early October 2011 in Pierce County, to review the seizure of the boys, denied him custody of his sons.

over his strenuous objections,

3) Josh Powell's sons were placed by the State, with his in-laws, Chuck and Judy Cox. Only weeks prior to the seizure of the two boys, Josh Powell had been awarded a restraining order against Chuck Cox, because Cox had been stalking and harassing his sons - Josh and his sons.

While in the Coxes' care, four-year-old [REDACTED] sustained the only serious and debilitating

wifey of his life, due to Cox's negligence in December 2011. Josh's ^{desperate} plea to have his sons placed in a safe and neutral environment ~~was~~ was ignored by the State DSHS.

4) Josh moved out of my house within weeks of losing custody of his sons, in order to distance himself from the investigation against me.

OZO 5) Assistant attorney general [REDACTED] turned the child-custody case into a malicious prosecution of my son. Asst. AG [REDACTED] accused Josh Powell, in court proceedings over child custody, of being responsible for the disappearance of Susan Powell, misstating the facts of that case in the process. Asst. AG [REDACTED] was again, in December 2011, able to block Josh's custody bid in December 2011.

6) Asst. AG Long played keep-away from Josh Powell with my grandsons for ^{more than} four months, promising the court at every hearing that there

Was evidence against Josh, but never producing any evidence.

7) West Valley City, Utah Police Department, with the guidance of the FBI Sexual Deviancy unit in Salt Lake City, reported to the court, through Asst. AG [REDACTED] that sexually-graphic cartoon images found on Josh Powell's computer in December 2009, shortly after Susan Powell disappeared, were a cause for denying Josh Powell custody of his sons. The alleged images, evidently not illegal in any way, were never provided by the WVPD or the FBI.

8) At Josh Powell's final "Custody" hearing on 2/1/2012, the court again denied Josh Powell custody of his sons, based on Asst. AG [REDACTED] assurance that "evidence" against Josh Powell was soon forthcoming.

9) At the 2/1/2012 final hearing the court ordered Josh Powell to undergo a Psycho-Sexual exam, without any evidence.

of criminal wrongdoing on his part.

10) On Friday 2/3/2012 Josh visited the office of a court-approved psychologist and asked to take the psycho-sexual exams immediately, in order to expedite the return of his sons to his care. He was told that the evaluation process would take at least eight weeks.

11) On 2/5/2012 the unthinkable happened. Josh and his sons perished in an explosion and fire.

The mind games the AG's office and various law-enforcement agencies played with my son, all the while trampling on the civil rights of two little boys aged four and six, were malicious, and unjustified in any sense.

Josh Powell was never guilty of any serious wrong doing up to the last day of his life.

The above outline does not begin to cover what I view as government misconduct in the way my family, especially the three deceased members of my household, were treated. Too often this kind of abuse is perpetrated by agencies, such as the FBI, that are subject to little or no oversight, and are in a position to nullify the civil rights of anyone they decide to harass, attack or destroy.

I intend to file a claim in the amount of \$20M for my Son Josh Powell's wrongful death, and \$10M each for the wrongful deaths of my grandsons. The agencies I will file claims against include but are not limited to the following:

- 1) West Valley City, Utah and its police department
- 2) Pierce County, Washington and its Sheriff's dept.
- 3) Washington State, Attorney General's office and DHS
- 4) FBI Federal Bureau of Investigation
- 5) USMS U. S. Marshals Service

I recognize this is a long-range process that could take years to litigate. I will

need the assistance of a law firm that is willing and able to accept a percentage of any award or contingency, and is motivated to right grave wrongs against a family that, while it is in no way perfect, does not deserve what these government bureaucrats have brought down on its head.

Please be so kind as to let me know if you and your firm would be willing to help me and my family obtain justice. If not, your recommendation of another attorney or firm, that may be motivated to provide a counterweight to this massive injustice by multiple agencies, with compensation contingent on successful litigation, would be appreciated.
