59 EM: PERSONALITY, CHARACTERISTICS?

60 ■ PERSONALITY- OUTGOING UM WHEN WE MOVED HERE THREE, JUST
61 OVER THREE YEARS AGO SHE WAS ONE OF THE YOU KNOW THE
62 FIRST PEOPLE TO COME UP AND INTRODUCE HERSELF AND
63 OBVIOUSLY WE HAD KIDS THE SAME AGE AND SHE WAS KIND OF
64 ASKING ABOUT YOU KNOW PLAY DATES AND CHURCH AND THINGS

78 WITH JOSH OR ANY OTHER PEOPLE?

79 ■ NO AH ABOUT THE ONLY THING I REALLY COULD SAY THAT I, I
80 KNEW AND THAT SHE KIND OF LET ME KNOW ABOUT WAS YOU
81 KNOW USUALLY SHE WOULD SHOW UP TO CHURCH WITH JUST THE
82 TWO KIDS JOSH WOULD STAY AT HOME, SO THERE WERE SEVERAL
83 TIMES YOU KNOW I WOULD BE IN THE PARKING LOT OR WALKING
84 WE'D GIVE HER A RIDE UM BUT TOWARDS I'D SAY THE LAST THREE
85 MONTHS

87 ■ JOSH STARTED SHOWING UP AT CHURCH AND UM HE KNEW THAT I
88 KIND OF HELPED SUSAN OUT WITH THE KIDS

89 EM: UM HUH
90 ■ EVERY NOW AND THEN HE'D KIND OF POKE HIS HEAD IN HE SAYS
91 HEY DO YOU KNOW WHERE SUSAN'S AT?
92 EM: UM HUH.
93 ■ SO SHE WOULD SHOW UP FOR CHURCH ON TIME, BE THERE AND
94 THEN YOU KNOW AN HOUR LATER AFTER SACRAMENT THEN
95 EVERY NOW AND THEN HE'D KIND OF POKE HIS HEAD IN AND SAY
96 DO YOU KNOW WHERE SHE'S AT.
97 EM: UM HUH.
98 ■ AND THEN I'D GO IN AND I'D FIND HER, HE DIDN'T WANT TO GO
99 INTO THERE IT'S ALMOST HE NEEDED TO TALK TO HER SEVERAL
100 TIMES I'D SAY PROBABLY SEVEN OR EIGHT TIMES THIS HAPPENED.
101 EM: UM HUH
102 ■ YOU KNOW HE'D KIND OF SAY HEY COULD YOU GO GET HER, AND
103 I'D GO IN AND SAY HEY JOSH IS HERE LOOKING FOR YOU AND A
104 COUPLE OF TIMES HE WOULD STAY AROUND MAYBE HE'D GO SIT
105 DOWN AND I'D KIND OF SAY OH SHE'S SITTING IN THERE OVER ON
106 THAT CORNER
107 EM: UM HUH.
108 ■ UM I JUST KIND OF NOTICED THAT AT FIRST IT WAS SHE WOULD
109 COME AND THEN AS HE WOULD COME IT WAS ALWAYS LATER, HE
110 WAS ALWAYS REALLY QUIET WHEN HE WOULD SHOW UP UM
111 DIDN'T WANT TO MAKE A SCENE, DIDN'T WANT TO REALLY
112 ATTRACK ANY ATTENTION.
113 EM: UM HUH.
114 ■ WE'D ALWAYS BE LOOKING FOR HER TO GO SIT BY HER SO I YOU
115 KNOW I WASN'T REALLY TOO SURE WHY HE DIDN'T COME IN THE
116 BEGINNING AND WHY HE WAS COMING LATER BUT IT SEEMED TO
117 BE A PATTERN.
118 EM: YEAH

119 ■ BUT AND THEN I'D SAY THE, THREE OR FOUR MAYBE EVEN FIVE
120 WEEKS BEFORE SHE WENT MISSING HE WAS PROBABLY THERE
121 FOUR OUT OF THE FIVE WEEKS.

122 EM: UM HUH

123 ■ AND AH HE'D ACTUALLY COME FOR THE WHOLE ENTIRE THREE
124 HOURS, HE'D ACTUALLY STICK AROUND AND AT THE VERY END
125 WE'D HAVE OUR MALE THE PRIESTA GROUP AND HE'D COME AT
126 10:00 BY HIMSELF AND STAY IN CLASS BUT KIND OF HANG BACK TO
127 HIMSELF DIDN'T REALLY TALK TO TOO MANY PEOPLE.

128 EM: IS THAT OF THE ORDINARY FOR HIM TO COME TO CHURCH AND
129 STAY THROUGH THE WHOLE?

130 ■ OUT OF THE THREE YEARS I'VE BEEN HERE YEAH

131 EM: OKAY

132 ■ THAT WAS DEFINITELY A CHANGE AH A COUPLE MEMBERS WHO
133 MIGHT KNOW BETTER STATED THAT IN THE PAST HE WOULD SHOW
134 UP WHEN HE NEEDED HELP WITH STUFF

135 EM: UM HUH

136 ■ AND WHERE HE WAS ASKING FOR HELP WAS WORKING ON HIS
137 DECK, WHERE HE WAS ASKING WITH THINGS AROUND HIS HOUSE

138 EM: UM HUH

139 ■ WHEN HE WAS BUYING SHEET ROCK AND STUFF TO FINISH HIS
140 BASEMENT. PEOPLE WOULD SAY YOU KNOW OH HE'LL SHOW UP
141 FOR A WEEK OR TWO WHEN HE'S GONNA ASK FOR HELP, SO IT
142 MIGHT HAVE BEEN RELATED TO THAT, THAT HE WAS ASKING FOR
143 HELP MOVING A COUPLE OF SHEDS INTO HIS BACK YARD BUILDING

144 EM: YEAH

145 ■ A SHED AND STUFF LIKE THAT SO I DON'T READ TOO MUCH INTO
146 WHY HE WAS THERE BUT IT WAS UNUSUAL FROM WHAT I KNEW OF
147 THE THREE YEARS HE WAS NOT THAT OFTEN THERE.

148 EM: RIGHT

149 ■ SO IT WAS DEFINITELY A CHANGE IN THE LAST FEW MONTHS.

180 ■ UM DURING THE MOVE AND THEN YOU KNOW WHEN HE WAS HERE
181 PACKING UP HIS HOUSE I TALKED TO HIM A MINUTE OR TWO BUT
182 MOSTLY ABOUT YOU KNOW WE HAD A LARGE ENTERTAINMENT
183 CENTER THAT HE BUILT THAT HE WAS VERY METICULOUS ABOUT
184 HOW IT WANTED IT PACKED.

185 EM: UH HUH.

186 ■ SO THERE WAS SOME INTERACTION THERE BUT NO PERSONAL
187 CONVERSATIONS.

188 EM: SO WHEN YOU WERE HELPING HIM PACK HIS STUFF AND MOVE HE
189 WAS PRETTY QUIET?

190 ■ AH HE WOULD YOU KNOW AVOID GOING OUT NEAR THE CAMERAS,
191 HE WOULD STICK TO HIMSELF AND TALK TO ONLY A COUPLE
192 PEOPLE UM BUT THEN IF HE LIKE MOVING THAT ENTERTAINMENT
193 CENTER HE WAS OUT THERE AND HE'S LIKE, OKAY WE NEED MAKE
194 SURE WE DO THIS AND I WANT A COVER ON THIS AND DON'T BEND
195 THIS, I WANT THIS SECURED, I WANT YA TO TAKE THESE CLOTHES,
196 UM SO HE WAS VERY METICULOUS ABOUT HOW WE MOVED
197 CERTAIN PIECES

198 EM: UM HUH

199 ■ AND THEN HE'D COME TALK TO PEOPLE AND TELL THEM EXACTLY
200 HOW HE WANTED IT DONE BUT BEYOND THAT NOT VERY
201 CONVERSATION HE KEPT PRETTY QUIET AROUND ME.

202 EM: OKAY, WAS THERE ANYTHING ELSE THAT WAS KIND YOU
203 DESCRIBED AS BEING ODD OR CONCERN DURING THE MOVE?

204 ■ UM

205 EM: EITHER HIS ACTIONS OR STATEMENTS?

206 ■ NO AH...NOTHING REALLY JUST HE SEEMED VERY PARTICULAR
207 ABOUT CERTAIN THINGS BUT NOT ANYTHING FROM YOU KNOW
208 DON'T LOOK AT THIS, DON'T TOUCH THAT IT WAS JUST MORE THIS
209 IS WHERE I WANT THAT AND I WANT YA TO MOVE THIS AND I WANT
210 TO SECURE THAT.

211 EM: UM HUH

212 ■ UM BUT NO NOTHING REALLY SAID BEYOND THAT.

213 EM: OKAY, HOW ABOUT WHEN YOU GUYS WERE HELPING WITH HIS
214 DECK?

215 ■ AH THAT WAS AND I'D HAVE TO LOOK AT MY CALENDAR IT WAS A
216 SATURDAY

217 EM: YEAH

218 ■ IT WAS PROBABLY ABOUT FIVE OR SIX WEEKS AGO. UM NOT
219 ANYTHING REALLY THAT WOULD STAND OUT TO ME. UM JUST
220 MORE HIS THOUGHT PROCESS WAS KIND OF SCATTERED, HE
221 WASN'T REALLY YOU KNOW THINKING LOGICALLY ABOUT HOW HE
222 WAS DOING THINGS HE HAD BUILT HALF A DECK AND HE HAD TWO
223 SUPPORT BEAMS AND HE HAD TO PUT A THIRD ONE ON

224 EM: UM HUH

225 ■ AND HE TRIED TO PULL IT OFF THE FOUNDATION SUPPORTS TO PUT
226 THAT THIRD ONE ON AND DIDN'T THINK ABOUT YOU KNOW HOW
227 TO HOLD THE DECK UP WHILE HE WAS DOING THAT.

228 EM: RIGHT

229 ■ HE'S A, HE'S AN INTERESTING PERSON, CONVERSATIONS WITH HIM
230 TENDED TO BE VERY LIKE I SAID WHATEVER HE THOUGHT HE JUST
231 SAID.

232 EM: UM HUH

233 ■ SO AH WHEN HE TALKS WHATEVER POPS IN HIS HEAD COMES RIGHT
234 OUT HIS MOUTH SO USUALLY YOU HAVE TO TELL HIM, WELL JOSH
235 YOU NEED TO HOLD ON, SLOW DOWN WE NEED TO DO IT THIS WAY.
236 BUT AH NOTHING ON A PERSONAL LEVEL AS FAR AS
237 COMMUNICATIONS MOSTLY JUST YOU KNOW RELATED TO WHAT
238 WE WERE DOING AT HAND.

239 EM: RIGHT, OKAY, HOW ABOUT WITH SUSAN WHEN WAS THE LAST TIME
240 YOU SEEN OR SPOKE WITH HER?

241 ■ UM I ACTUALLY SAW HER THE SUNDAY BEFORE SO SHE
242 DISAPPEARED SUNDAY NIGHT TO MONDAY MORNING

243 EM: OKAY

244 ■ AH I SAW HER AT CHURCH WE HAD THE DIFFERENT BLOCK
245 SCHEDULE IT WAS AH, A STATE CONFERENCE

246 EM: RIGHT

247 ■ ARE YOU LDS?

248 EM: YEAH

249 ■ OKAY I WASN'T SURE UM SO IT WAS ONLY THE TWO HOUR BLOCK

250 EM: RIGHT

251 ■ RIGHT AND UM SHE WAS THERE BY HERSELF JOSH WASN'T THERE,
252 NOTHING SEEMED REALLY OUT OF THE ORDINARY BUT SHE
253 SEEMED A LITTLE I DON'T KNOW HURRIED MAYBE SHE WAS
254 RUNNING LATE OR WHAT NOT, UM AND OUR STAKE CENTER THE
255 NURSERY ROOM HAS A SPEAKER SO YOU CAN TURN IT ON AND
256 LISTEN TO THE TALKS IN THERE AND SO I HAD MY KIDS IN THERE
257 UM WELL NOT MY KIDS MY KIDS ACTUALLY STAYED AT HOME
258 ■ BUT I WAS IN THERE WITH TWO OF THE OTHER KIDS

259 EM: UM HUH

260 ■ AND SHE CAME IN AND SHE WAS LIKE, "OH SO THERE'S NOBODY IN
261 HERE GOOD!" AND TURNED ON THE SPEAKER AND I TALKED TO HER
262 FOR A COUPLE MINUTES JUST ABOUT KIDS AND PLAYED AROUND
263 JOSH, OR WITH ■ AND JUST TALKED TO HER FOR A FEW
264 MINUTES AND THEN I WAS HELPING PERSONNEL AND PARK CARS
265 AND STUFF LIKE THAT SO.

266 EM: UM HUH

267 ■ IT WAS A PRETTY SNOWY DAY AND SO I TALKED TO HER FOR
268 ABOUT FIVE OR TEN MINUTES NOTHING SEEMED OUT OF THE
269 ORDINARY IT WAS JUST HEY HOW'S IT GOING, GOOD, TURNED ON
270 THE SPEAKER, TALKED, PLAYED WITH THE KIDS A LITTLE BIT AND I
271 SAID WELL I GOT TO GET OUT AND HELP WITH THAT AND THAT
272 WAS ABOUT ALL I TALKED TO HER.

273 EM: OKAY

274 ■ AND THAT WOULD HAVE BEEN ABOUT 10:15, 10:30ISH AND NOTHING
275 OUT OF THE ORDINARY BUT SHE JUST SEEMED A LITTLE FLUSHED
276 OR HURRIED OR RUSHED.

277 EM: OKAY

278 ■ AND THAT WAS THE LAST TIME I SAW HER.

279 EM: OKAY...ANYTHING IS THERE ANYTHING ELSE THAT YOU WANT TO
280 SHARE WITH ME THAT MAYBE I DIDN'T ASK YA THE RIGHT
281 QUESTION ABOUT EITHER ONE OF THEM?

282 ■ NO NOTHING THAT I CAN REALLY GIVE TO INSIGHT I JUST YOU
283 KNOW MOSTLY AT CHURCH, THE INTERACTION BETWEEN THEM
284 SEEMED A LITTLE AND I DON'T WANT TO SPECULATE TOO MUCH
285 BECAUSE I DIDN'T KNOW HOW THEY WERE AROUND THE HOUSE I
286 DIDN'T SEE THEM TOO MUCH TOGETHER BUT JUST SEEMED A
287 LITTLE ODD YOU KNOW IN THAT THEIR RELATIONSHIP WAS
288 STRESSED OR WHAT NOT, BUT WHEN HE WOULD COME TALK TO
289 HER OR COME LOOK FOR HER AT CHURCH YOU KNOW USUALLY
290 HE'D GO SIT DOWN NEXT TO HER

291 EM: UM HUH

292 ■ WOULDN'T SAY HI, WOULDN'T REALLY TALK TO HER WOULD KIND
293 OF USUALLY JUST SIT THERE WITH HER HEAD DOWN AND SHE
294 MIGHT PUT HER HAND ON HIS BACK OR HE MIGHT PUT HIS HAND ON
295 HER BACK BUT NO REAL COMMUNICATION BETWEEN THEM.

296 EM: YEAH

297 ■ IN MY MIND IT APPEARED AS IF YOU KNOW MAYBE THEY WERE A
298 LITTLE STRESSED IN THEIR RELATIONSHIP BUT HE WAS MAKING AN
299 EFFORT COMING TO CHURCH BECAUSE SHE HAD ASKED HIM TO, I
300 DON'T WANT TO SPECULATE TOO MUCH INTO THAT BECAUSE I
301 DON'T KNOW.

302 EM: YEAH

303 ■ SEEMED A LITTLE STRANNED AND NOT THERE WOULD BE
304 COMFORTABLE AROUND EACH OTHER AT LEAST AT CHURCH.

305 EM: OKAY

306 ■ BUT THAT'S IT NOTHING I COULD REALLY SAY TO YOU ON THAT.

307 EM: ALRIGHT, WELL PERFECT I APPRECIATE IT ■

308 ■ SURE ANYTHING ELSE LET ME KNOW

309 EM: OKAY THANK YOU.

310 ■ AH ALRIGHT BYE.
