About 2 to 2.5 years ago I had multiple conversations with Susan pertaining to [REDACTED] behaviors. We were both having the same trouble. We found that [REDACTED] were controlling, manipulative, threatening, and insecure. She had informed me that she was having, "the seven year itch." Our conversations were held through facebook and hotmail. I deleted all the conversations we had [REDACTED]. I imagine she did the same. We both found that [REDACTED] lacked in helping around the house and were very selfish people. Last time she contacted me was November 6, 2009, she asked me what had happen [REDACTED]. I was surprised she wasn't divorced yet. If there is a way to get a hold of deleted information through hotmail or facebook then I would be more than happy to give you any information of mine you need to get a hold of the conversations I had with her. I'm sure there is a way, as the information is probably stored in some archive through the server. The hotmail account she contacted me through was [REDACTED]. I knew something was wrong when she'd send me generic emails about how her and the kids were doing, not mentioning her husband. That's never a good sign. I wish I could help you out more with your investigation, but I think I only have information that other's already have. When she got married shortly after [REDACTED] it came no surprise to me because she had often talked about in high school how she wished she would find someone to marry and so on and so forth. She wanted a fairytale story. [REDACTED] and I tried to tell her otherwise, that it just wasn't real. She pushed for it anyway. Six months after her marriage, she stopped talking to [REDACTED] me, as if she was too busy for us and only hung out with her friends she had with her husband. I realized later that it was because her husband was controlling and only allowed her to converse with certain people. I only met her husband once at the reception and did not like him. He was not very friendly to me and without reason to be. I was uncomfortable at the reception and only stayed for about an hour.

This is a recent email to [REDACTED]
"Is there a police officer that is trying to contact you via facebook... Ellis Maxwell? I was concerned that it wasn't an actual police officer. He says he is investigating the Powell case. I just want to be sure if I give any information to anyone, it's a valid source.

The dream was so real seeming. The lady really stuck out in my mind in detail; she and I were face to face in my dream as the police were taking her away. I could try to draw her. She was very clear to me. The man I knew he was there, but never saw him in my dream. [For whatever reason I knew he had dark hair.]

This is the post I made on Susan's Facebook page: {Susan - I had a dream that was very detailed... you were being held captive by a man and a short, spiky haired woman... you were under the ground

in a hallway under the city. You were found and more importantly you were found alive. I pray every day that you will be found soon and that you will be alive and able to be with all your loved ones again. So many miss you Susan and the happiness you brought in so many lives by simply being their friend.} Reply: [REDACTED] Holy! minus the people holding her captive. I had that exact same dream just 2 days after she went missing!!!} Reply to [REDACTED]: Hmm... The people in my dream were white, the woman had dirty blond, spiky [short] hair and was slender. And the man I didn't get to see his face, but he had dark hair. I saw the police pull her out of the top of the hallway that was underground in the ally of a city. That's crazy that you had a very similar dream.}

The other odd thing that was in the last week. It was really disturbing for me and I just never know what could be true or not. I had a lady come into [REDACTED] and I couldn't hear what she said she was, but I think she was one of those psychic ladies. She was really weird to begin with and only came into [REDACTED] a hurry. Said she had to get her husband and needed [REDACTED] right away. She even sat on the edge of her seat.

I have been asking God and Susan for a sign, a message, something to help find her. I can't help, but think that lady that came [REDACTED] may have been it.

It was weird because the whole time she was watching me as if she had to get a message to me and then she asked me what my purple ribbon was for, as MANY people do all day long. So, I thought nothing of it and said like always that my friends, Susan Powell is missing. She said, she knew. Everything is on the news though, so I do run into people that have heard already.

My friend said he remembers the lady, she only had water, but she came to the register where I was; as if she was going to pay and stated that she was pray for Susan to be found and the kids.

I hate to say what she told me at the table, but... I guess I should air what I know. ... She said, Susan is no longer with us. She said that her body is near her home, she didn't say what home. She said, she is watching over her kids and she really wants to be found. She said, her kids are in danger because they are with him, she didn't say who he was.

The lady was so vague... I mean anyone could have said what she said. The lady explained that she was able to see things others cannot when she came to the register.

I was so busy at the time, my whole [REDACTED] was full. I didn't have time to sit and chat with her, but she kind of forced me to hear what she had to say."
