21 AM THE LEAD PER SAY OR THE ASSISTANT WITH A SUPERVISOR OR

22 DIRECTOR HERE (INAUDIBLE) SO

24 CB: IM THE GO TO PERSON WHEN SHES NOT AROUND
25 RB: K AND YOUR EMPLOYED HERE FULL TIME?
26 CB: IT'S PART TIME
27 RB: PART TIME AND MY UNDERSTANDING IS IS THAT YOU MAY HAVE HAD
28 SOME INTERACTION WITH A THE POWELL FAMILY, DO YOU KNOW WHO IM
29 SPEAKING ABOUT?
30 CB: YES I DO
31 RB: AND WHO IS THAT? DO YOU KNOW THERE FIRST NAMES?
32 CB: [REDACTED] IS THAT HOW YOU PRONOUNCE IT? UM POWELL IM
33 TRYIN TO REMEMBER (INAUDIBLE)
34 RB: HOWEVER HOW YOU KNOW IT
35 CB: YEAH JOSH POWELL UM SO
36 RB: K
37 CB: I KNOW THERE WAS THE TWO LITTLE BOYS AND THEN THE FATHER
38 RB: K
39 CB: UM I HAVE THEIR FACES IN MY HEAD
40 RB: SURE
41 CB: SO AND UM YEAH THE LITTLE BOYS THAT BEEN IN ONE OF OUR SUMMER
42 CLINICS
43 RB: K AND HOW LONG AGO WAS THAT?
44 CB: UM ACTUALLY IM THINKING THAT WAS JUST A COUPLE WEEKS AGO
45 RB: DID YOU SPEND ANY TIME WITH HIM A ONE ON ONE TIME WITH HIM AT
46 ALL?
47 CB: A LITTLE BIT BUT NEVER ALONE ITS WHEN WERE RUNNIN OUR SUMMER
48 CLINICS WE HAVE LIKE WE MAKE SURE THAT THERES UM THREE STAFF
49 AND THEN SOME VOLUNTEERS AND MAYBE THE CLINICS HAVE BEEN LIKE
50 TEN TO FIFTEEN CHILDREN APPROXIMATELY
51 RB: K

52 CB: AND... SO NO ONE ON ONE THAT'S (INAUDIBLE) YOU KNOW PEOPLE ALL
53 EYES WATCHIN ALL THE STAFF WITH ALL THE KIDS

54 RB: UNDERSTOOD

55 CB: (INAUDIBLE)

56 RB: K DURING THAT TIME DID YOU GET TO KNOW [REDACTED] AT ALL?

57 CB: OK SEE I KNEW I WAS OFF [REDACTED]

58 RB: OH YEAH

59 CB: (INAUDIBLE) YEAH UM HE WAS PRETTY HESITANT PRETTY KEPT TO
60 HIMSELF KIDDO I DID HOLD HIM FOR A LITTLE BIT BECAUSE WHEN YOU
61 HAVE THE BRAND NEW WHEN THEY'VE NEVER BEEN TO A CLINIC THESE
62 KIDS THE PRESCHOOLERS WERE USE TO THEM NOT WANTIN TO BE THERE

63 RB: SURE

64 CB: THERE PRETTY CLINGY THEY UM YEAH JUST UM NEED SOME CALMY LIKE
65 COAXING YOU KNOW THEM TO TRY AND GET THEM OVER THOSE
66 ANXIETIES BUT HE WAS DEFINITELY HIGH ANXIETY CHILD ABOUT THE
67 CLINIC BUT NOT ON A BASIS WHERE HE WOULD TALK TO ME ABOUT HIS
68 FATHER OR MOTHER OR BROTHER OR SISTER.

69 RB: UM HUH

70 CB: YOU DON'T GENERALLY GET THAT OUT OF PRESCHOOLERS ANYWAY

71 RB: (INAUDIBLE)

72 CB: YEAH

73 RB: OK ANY SPONTANEOUS STATEMENT OR BEHAVIOR THAT YOU WOULD
74 CONSIDER UNUSUAL OR OF THE NORM?

75 CB: UM NO HE WAS PRETTY A JUST UM ONE OF THOSE WHAT I WOULD CALL A
76 HI...A HIGH ALERT WHERE YOU REALLY NEED TO A UM TRY TO GET HIM
77 TO JUST STOP A CRYING A LOT HE HE DIDN'T SAY ANY STRANGE
78 STATEMENT OR ELSE THAT WOULD STICK IN MY MIND

79 RB: K DID YOU SPEND ANYTIME SPEAKING WITH JOSH POWELL AT ALL EVER?

80 CB: UM A LITTLE BIT BUT IT WOULD JUST BE MAYBE AT THE BEGINNING OF

81 THE START TIME OF THE CLINICS OR A WHEN WE HALF WAY THROUGH
82 THE CLINIC UM SINCE WE TRANSITIONED FROM ONE GYM TO A DANCE
83 ROOM

84 RB: UM HUH

85 CB: WHERE WE HAVE THE REST OF PLAY HE'D COME IN UM BUT THAT WAS
86 JUST A COUPLE OF TIMES I ACTUALLY WHEN THE CLASSES WERE OVER I
87 CAN REMEMBER TALKING TO HIM A LITTLE BIT

88 RB: DID HE EVER MENTION HIS WIFE TO YOU AT ALL?

89 CB: NO NOT A WORD

90 RB: K ARE YOU AWARE OF SOME OF THE CIRCUMSTANCES SURROUNDING THE
91 POWELL FAMILY?

92 CB: YEAH BECAUSE UM I UM ESPECIALLY IN MY POSITION ITS BETTER FOR ME
93 TO KNOW SO THAT I CAN HAVE AN EXTRA SET OF EYES TO KEEP UM
94 AWARE ON THE LOOKOUT FOR THINGS TO KEEP KIDS SAFE.

95 RB: UM HUH

96 CB: SO...

97 RB: WHAT WHAT ARE THE CIRCUMSTANCES AS YOU UNDERSTAND THEM?

98 CB: HE'S SPECULATION OF MURDERING HIS WIFE

99 RB: ALRIGHT DO YOU THINK THAT THERES ANY INFORMATION THAT YOU
100 HAVE THAT WE OUGHT TO KNOW? REGARDING A THIS CASE OR THE
101 POWELL FAMILY?

102 CB: WELL UM I JUST I SENSED BUT MAYBE IT'S A ITS HARD TO SAY W....WITH
103 THE CHILD UM I I I JUST FELT AUTOMATICALLY YOU KNOW WHA...WHAT
104 DO YOU CALL IT MOTHERS LOVE OR INTUITION OR SOMETHING THAT THIS
105 CHILD IS MISSING SOMETHING HE WAS NEEDY UM MORE SO THEN OTHERS
106 A CAUSE I'VE WORKED WITH A LOT OF DIFFERENT PRESCHOOLERS I'VE
107 BEEN HERE DOING THIS FOR ALMOST FOUR YEARS NOW AND AND WHAT I
108 SENSED WAS THAT ONCE HE DID GET COMFORTABLE WITH ME HE WAS
109 LIKE A GLUED STUCK TO ME WHERE HE WAS JUST REALLY CLINGY AND

110 UM A...AND AND I I GET THAT I THINK YOU KNOW WHATS GOING ON
111 THERE IS THERES NO MOTHER AND SO AND SO ITS ONLY NATURAL BUT I
112 THAT'S YOU KNOW I DON'T KNOW HOW HELPFUL THAT IS BUT UM HE DID
113 DO PRESCHOOL GYMNASTICS A LITTLE BIT I GUESS.

114 RB: HOW'D HE DO?

115 CB: BUT A I I WASN'T AN INSTRUCTOR.

116 RB: Hmm...

117 CB: SO AND I SINCE I HAD THE LITTLE WHIPPER SNAPPERS SUMMER CLINICS I
118 DIDN'T GET TO WATCH ANY UM BE AROUND FOR THAT SO THAT'S
119 ACTUALLY BE A GOOD QUESTION WE MIGHT WOULD BE ABLE TO LOOK

123 RB: IM JUST BEING CURIOUS

124 CB: YEAH YEAH WELL BUT I I AM SAYING I JUST A THERE WAS A FEW
125 STATEMENTS SOMETIMES WHERE UM THE FATHER UM SEEMED TO JUST A
126 LITTLE BIT ON THE CONTROLLING SIDE I KINDA FELT BUT THAT WAS YOU
127 KNOW SOMETIMES WHEN YOUR TRYING TO GET YOUR KIDS TO CALM
128 DOWN AND WANT TO BE THERE AND YOU KNOW HE WAS LIKE THE CHILD
129 DIDN'T WANT TO HAVE DAD LEAVE THE ROOM HE WAS DOING THE
130 BRIBERING THING BUT ON THE ONE HAND YOU KNOW WHATS LIKE HERE
131 LOOK AT THIS YUMMY SNACK YOU NEED TO YOU KNOW COME OVER
132 HERE AND SIT DOWN AND BUT A...I'VE WATCHED MOTHERS DO THAT
133 WHERE YOU TRY AND JUST GET THE KIDS TO
