22 JP: NO, I DON'T UNDERSTAND WHY YOU, LET RUMORS, YOU'RE.
23 JG: I JUST, I JUST (INAUDIBLE) YOU KNOW WHAT IT DOESN'T LOOK GOOD

24 (INAUDIBLE).
25 JP: MEAN LIKE?
26 JG: IT WOULD REDUCE THE SENTENCE JOSH.
27 JP: NO, NO, DON'T BE RIDICULOUS.
28 JG: YOU KNOW THAT COULD PUT YOU AWAY FOR A LONG TIME. I DON'T
29 WANT TO SEE THAT HAPPEN AND YOU'RE NOT GOING TO BE ABLE TO SEE
30 YOUR BOYS FOR YEARS.
31 JP: UH, I HAVEN'T DONE ANYTHING AND THERE IS NO POLICE (INAUDIBLE)
32 JG: THEN WHAT DO YOU THINK ABOUT THESE RUMORS.
33 JP: I DON'T KNOW. I DON'T KNOW WHAT RUMORS YOU'RE TALKING ABOUT.
34 JG: (INAUDIBLE) THAT YOU WERE SOME (INAUDIBLE) WHERE WERE YOU
35 GOING WITH THAT? (INAUDIBLE) YOU TALKING ABOUT THAT? WHERE
36 DID YOU GO? I THINK YOU WERE GOING HUNDREDS OF MILES ON
37 TUESDAY, WHERE WERE YOU GOING WITH THAT? (INAUDIBLE) RIGHT

41 JG: FOR HUNDREDS OF MILES?
42 JP: YEAH.
43 JG: NOWHERE, WHERE?
44 JP: I DIDN'T GO ANYWHERE.
45 JG: YOU JUST DROVE AROUND ALL OVER THE PLACE?
46 JP: YEAH.
47 JG: K.
48 JP: I MEAN, WHATEVER YOU KNOW, THERE'S NO POLICE (INAUDIBLE), I
49 MEAN, YOU NOW. I DOUBT THE RUMORS. THERE'S NO (INAUDIBLE) YOU
50 KNOW. (INAUDIBLE) WHO KNOWS THEY'RE GOING TO DO WHAT THEY
51 DO?
52 JG: YEAH.
53 JP: AND THINK WHAT THEY THINK, I DON'T KNOW WHAT TO SAY.

54 JG: YEAH. (INAUDIBLE)

55 JP: I JUST DON'T THINK. I DON'T KNOW WHAT TO SAY, I MEAN I DON'T THINK

56 IT'S SOMETHING THAT, I'M, I'M, IT'S NOT SOMETHING I CAN PUT A LOT OF

57 WORRY INTO. YOU KNOW?

58 JG: YEAH. I DON'T KNOW SO WHAT HAPPENED ON SUNDAY. REALLY, YOU,

59 YOU TELL ME WHAT HAPPENED?

60 JP: MY ATTORNEY'S TOLD ME PLEASE DON'T TALK ABOUT IT. (INAUDIBLE).

61 JG: THIS ISN'T ABOUT YOUR ATTORNEY'S JOSH. WHAT HAPPENED? WHAT

62 HAPPENED THAT NIGHT?

63 JP: I'VE ALREADY TOLD, YOU KNOW I SAT DOWN WITH THE COPS I TOLD

64 THEM EVERYTHING.

65 JG: WELL YOU DIDN'T TELL ME ANYTHING. I'VE ASKED. BUT YOU HAVEN'T

66 SAID ANYTHING TO ME. I ASKED. BUT YOU NEVER SAID ANYTHING TO ME

67 (INAUDIBLE) WHAT HAPPENED?

68 JP: YOU KNOW, I'VE ALREADY TOLD YOU. I'M NOT GOING TO VIOLATE MY

69 ATTORNEY RIGHTS BECAUSE MY ATTORNEY SAID TO DEFLECT ME

70 AGAINST THE RUMORS.

71 JG: THIS ISN'T ABOUT RUMORS JOSH.

72 JP: I DON'T KNOW WHAT TO SAY. I MEAN IF THEY THINK THEY'VE GOT

73 SOMETHING THEY THINK THEY'VE GOT SOMETHING. THEY CAN COME

74 BARRELING IN HERE ANY DAY THEY WANT.

75 JG: YEAH.

76 JP: YOU KNOW LIKE I SAY.

77 JG: UH-HUH.

78 JP: YOU KNOW EVEN IF YOU LOOK AT THE EVIDENCE, WE DON'T WORRY

79 ABOUT RUMORS. I'M SURE THEY DON'T WORRY ABOUT THE RUMORS.

80 JG: (INAUDIBLE). WHY NOT? WHY DON'T YOU TELL ME? WHY DON'T YOU

81 PUT MY MIND AT EASE AND TELL ME WHAT HAPPENED. I'M YOUR SISTER,

82 THINK ABOUT YOUR CHILDREN. SHE'S YOUR WIFE, FOR CRYING OUT

83 LOUD. WHAT HAPPENED?

84 JP: I DON'T KNOW WHAT HAPPENED. I DON'T KNOW WHAT HAPPENED?
85 JG: WELL WHAT DID YOU DO? WHAT DID YOU DO THAT NIGHT? WHAT DO
86 YOU KNOW?
87 JP: I'LL TELL YOU THIS, WE, WE'VE BEEN DOING REALLY GOOD IN OUR
88 WHOLE RELATIONSHIP AND WE HAD, HAD A REALLY GOOD WEEKEND
89 THAT WHOLE WEEKEND.
90 JG: SO YOU HAD A GREAT WEEKEND. BUT IT WASN'T A GREAT RELATIONSHIP
91 THOUGH. LEADING UP TO THAT IT WASN'T.
92 JP: OKAY.
93 JG: (INAUDIBLE).
94 JP: I DON'T KNOW WHAT YOU, I DON'T KNOW WHAT YOU'RE TRYING TO GET
95 ME TO SAY, I MEAN THE FACT IS, YOU KNOW, PEOPLE HAVE RUMORS.
96 JG: YEAH.
97 JP: I DON'T KNOW WHAT TO SAY, THEY CAN HAVE ANYTHING THEY WANT.
98 JG: WELL.
99 JP: I MEAN IS THAT THE MEDIA? IS THAT NEWS STORY THAT THEY'RE
100 RUNNING OR SOMETHING LIKE THAT?
101 JG: NO. THAT'S THE PLAIN FACT THAT I KNOW, IT WASN'T GOOD FOR A LONG
102 TIME. (INAUDIBLE). I'M ACCORDING TO SUSAN, SHE WASN'T SHE WASN'T
103 HAPPY. JUST A FEW WEEKS BEFORE SHE CALLED ME OVER SOME BIG
104 BLOW UP THAT YOU GUYS HAD. AND SHE WAS PISSED. I'M JUST
105 WONDERING WHY, WHY SUDDENLY SHE ISN'T HERE AND YOU DIDN'T
106 HAVE ANYTHING TO DO WITH IT? REALLY, REALLY. CAN YOU LOOK ME
107 IN THE EYE, AND TELL ME YOU REALLY DID NOT HAVE ANYTHING TO DO
108 WITH IT?
109 JP: I DID NOT HAVE ANYTHING TO DO WITH IT. I, I'D BEEN UP
110 BEFORE. BEFORE, PEOPLE WANT ME TO, YOU KNOW?
111 JG: I GUESS I'M CONFUSED. THEY WANT YOU TO DO WHAT? THEY WANT YOU
112 TO TELL THEM WHAT HAPPENED AND YOU WON'T TELL THEM? I DON'T
113 UNDERSTAND WHY.

114 JP: THAT'S RIDICULOUS, THAT'S RIDICULOUS. I'VE ALWAYS TOLD
115 EVERYTHING TO THE PEOPLE WHO NEED TO KNOW AND THE PUBLIC AND
116 FRANKLY ANYONE ELSE DOESN'T.

117 JG: WELL, NO I DON'T THINK THE PUBLIC NEEDS TO KNOW, BUT WHAT ABOUT
118 THE POLICE? THE POLICE NEED TO KNOW. THE POLICE NEED YOUR HELP.
119 IF YOU REALLY DIDN'T HAVE ANYTHING TO DO WITH IT THEY NEED TO
120 KNOW. THE SMALL DETAILS, THEY NEED TO KNOW THE THINGS ABOUT
121 SUSAN THAT ONLY YOU WOULD KNOW. HOW COME YOU WON'T
122 COMMUNICATE WITH THEM?

123 JP: I COMMUNICATE WITH THEM AND I COMMUNICATE THROUGH MY
124 ATTORNEY.

125 JG: (INAUDIBLE) YOU AREN'T COMMUNICATING ANY MORE.

126 JP: NO, I DON'T KNOW WHAT TO SAY ABOUT THAT.

127 JG: IT JUST DOESN'T SEEM LIKE YOU CARE AT ALL.

128 JP: HONESTLY, I DON'T, I CAN'T BELIEVE THAT YOU'VE BEEN SAYING THAT
129 STUFF.

130 JG: YOU WALKED AWAY.

131 JP: WHAT DO YOU MEAN WALKED AWAY?

132 JG: YOU WALKED AWAY. YOUR, YOUR FAMILY MAY LOSE YOUR HOUSE,
133 YOU'RE WALKING AWAY FROM IT.

134 JP: THAT HOUSE I CAN'T AFFORD.

135 JG: WELL, THEY'RE NOT GOING TO TAKE IT OUT FROM UNDER YOU RIGHT
136 NOW.

137 JP: WELL.

138 JG: WELL YOU HAVEN'T PUT ANY EFFORT IN HELPING FIND HER AT ALL.

139 JP: THAT'S NOT TRUE.

140 JG: WHAT HAVE YOU DONE? HEY, (INAUDIBLE) WATCH THE DOOR.

141 SP: WHY DON'T YOU ME AND JENNY GO DOWN, PROBABLY GO DOWN TO
142 COSTCO AND LOOK AT CAKES WITH ME IF YOU WANT TO DO IT BACK ON
143 THE WAY TO (INAUDIBLE) YOU GUYS ARE PROBABLY GOING TO NEED TO

144 GO PRETTY SOON BECAUSE WE GOT A CAKE AND WE DON'T WANT THEM
145 TO, THEY MIGHT CLOSE THE BAKERY. UNLESS DID YOU TALK TO
146 SOMEBODY?

147 JP: NO, THE BAKERY ALREADY CLOSED.

148 SP: OH. THEN WHAT.

149 JP: THEN PROBABLY. IF WE WANT THEM TO DECORATE, WE HAVE TO PICK IT
150 UP IN THE MORNING.

151 SP: WELL WE SHOULD.

152 JG: (INAUDIBLE).

153 SP: (INAUDIBLE) CAN YOU ORDER IT TONIGHT THOUGH?

154 JP: WE'RE HOPING. WITH THAT SAID.

155 SP: OKAY, OKAY THEN DO IT, I'D GET OVER THERE THOUGH BECAUSE YOU'RE
156 PUSHING IT RIGHT UP TO THE END AND THERE'S NOT A (INAUDIBLE).

157 JP: OKAY.

158 SP: THEY'RE REALLY GOOD AT THAT. START PUSHING PEOPLE OUT THE
159 DOOR AT EIGHT-THIRTY. SO I'D GET OVER THERE RIGHT AWAY IF I WERE
160 YOU.

161 JP: ALRIGHT.

162 SP: YOU NEED ONE FOR SUNDAY TOO RIGHT? CAKE FOR BOTH PARTIES?
163 OKAY.

164 JP: YEAH WE WOULD HAVE TO ORDER TWO OF THEM.

165 SP: AND THEN PICK THEM UP TOMORROW YEAH. AND WE CAN KEEP THEM.

166 JP: PICK THEM UP BOTH TOMORROW, YEAH.

167 SP: YEAH.

168 JP: ALRIGHT.

169 SP: YEAH, THINK ABOUT THAT ANYWAY.

170 JP: I BETTER GET MY SHOES ON.

171 JG: (INAUDIBLE) BECAUSE IT DOES BUG ME WHEN YOU COMPLETELY STAY
172 AWAY FROM EVERYTHING THAT SEEMS TO BE HELPING AT ALL.

173 JP: WELL FOR ONE, I'M WORKING ON THE WEBSITE. IT'S NOT EXACTLY EASY,

174 BUT YOU KNOW, I'M HOPING THAT PRETTY SOON THAT WE'LL BE ABLE
175 TO GO LIVE WITH IT.

176 JG: WELL, I'M GLAD TO HEAR THAT.

177 JP: AND I'M NOT GOING TO DO ANYTHING IN THE PUBLIC, I DON'T CARE
178 WHAT ANYONE SAYS ABOUT ME. THEY CAN SAY WHAT THEY WANT.
179 THAT'S WHY I CAN'T REALLY GO OUT THERE.

180 JG: PEOPLE COMPARE YOU TO MARK HACKING. HE GOT UP AND WALKED
181 AWAY FROM HIS.

182 JP: WHO'S MARK HACKING? I DON'T EVEN KNOW WHO THAT IS

183 JG: AS SOON AS HE KILLED HIS WIFE. THAT'S THE GUY THAT KILLED HIS
184 WIFE, KILLED HIS WIFE AND PUT HER IN THE DUMP.

185 JP: OKAY, IS THERE SOMETHING ABOUT THAT?

186 JG: YEAH, (INAUDIBLE) YOU KNOW WHAT PUTTING HER NAME OUT THERE.

187 JP: WHICH I DO.

188 JG: WHY HAVEN'T YOU DONE THAT?

189 JP: I DO THAT TO EVERY PLACE I GO

190 JG: WHAT DO YOU MEAN EVERY PLACE YOU GO?

191 JP: I GIVE LOCAL FLYERS TO EVERYONE I SEE. I DO WHAT I CAN.

192 JG: YOU GO OUT?

193 JP: YEAH I DO.

194 JG: WELL GOOD.

195 JP: I DID ONE THIS MORNING I THINK.

196 JG: WELL GOOD.

197 JP: I DON'T KNOW IF IT IS UP IN THE WINDOW OR NOT, BUT YOU KNOW IT'S
198 UP TO PEOPLE WHAT THEY DO WITH THEM. I ASK, THEY SAY THEY WILL
199 AND.

200 JG: AND WHAT? WHY WERE YOU HAVING SO MANY PROBLEMS RIGHT BEFORE
201 (INAUDIBLE).

202 JP: WE WEREN'T HAVING A LOT OF PROBLEMS.

203 JG: (INAUDIBLE). YOU WEREN'T HAVING PROBLEMS?

204 JP: NO.

205 JG: I JUST DON'T BUY IT. I TALKED TO SUSAN MYSELF, JOSH. SO DON'T TELL
206 ME THAT I DIDN'T HEAR IT FROM HER. (PAUSE) JOSH, I'M CONFUSED, WHY
207 IS IT THAT YOU ABSOLUTELY REFUSED TO GO TO CHURCH? YOU SAID IT
208 WAS COMPLETELY, ABSOLUTELY A WASTE OF TIME AND THEN JUST
209 SUDDENLY YOU STARTED GOING RECENTLY. I DON'T UNDERSTAND
210 WHAT THAT WAS. LIKE THREE WEEKS BEFORE SHE DISAPPEARED, YOU
211 SUDDENLY DECIDE TO GO?

212 JP: WHAT DO YOU MEAN? I DIDN'T DO ANYTHING LIKE THAT.

213 JG: WAS THAT A PLAN? IS THAT A PLAN? IT'S PART OF A PLAN?

214 JP: I DON'T KNOW WHAT YOU'RE TRYING TO SAY HERE JENNY.

215 JG: I'M, I'M CONFUSED.

216 JP: THAT'S NOT, THAT'S NOT TRUE. BUT WE PROBABLY BETTER GO GET THE
217 CAKE. (STATIC) (INAUDIBLE) AND NO THERE IS NO PLAN AND FRANKLY
218 IT'S REALLY HURTFUL THAT YOU WOULD SAY THOSE THINGS.

219 (PAUSE) (INAUDIBLE)

220 JP: I'M NOT GOING TO HAVE DISCUSSIONS ABOUT THOSE THINGS. WHAT
221 YOU'RE SAYING IS NOT TRUE.

222 JG: WHERE, WHERE DID YOU PUT HER?

223 JP: SEE THESE ARE NOT, I CAN'T EVEN BELIEVE YOU'RE SAYING THAT.

224 JG: YEAH I CAN'T BELIEVE, I CAN'T BELIEVE WHAT'S GOING ON. I WAS THERE
225 THE DAY AFTER, YOU WERE CLEANING UP THE HOUSE, WHAT THE HECK IS
226 THAT ABOUT? GOING THROUGH (INAUDIBLE) WHO DOES THAT RIGHT
227 AFTER THEIR WIFE GOES MISSING? WHY DIDN'T YOU, WHY WEREN'T
228 YOU, WHY WEREN'T YOU OUT LOOKING? WHY WEREN'T YOU OUT TRYING
229 TO DO SOMETHING? WHY WERE YOU GOING AROUND THE HOUSE
230 CLEANING? I DON'T GET IT. WERE YOU TRYING TO COVER IT UP? WHERE
231 IS SHE JOSH? WHERE IS SUSAN? WHERE, WHERE'S THE BODY DID YOU
232 DUMP IT SOMEWHERE.

233 JP: I'VE ALREADY TOLD YOU THAT (INAUDIBLE) WHAT HAS HAPPENED TO

234 HER OR WHERE SHE IS AT.

235 JG: I CAN SEE IT IN YOUR EYES, THERE IS SOMETHING THERE.

236 JP: YOU'RE WRONG. I DON'T KNOW WHAT TO SAY, LET'S JUST GO.

237 JG: (WHISPERS) WHERE IS SHE?

238 JP: AND GO GET A CAKE AND I DON'T KNOW WHAT TO SAY, BECAUSE I'VE

239 ALREADY ANSWERED YOU.

240 JG: (INAUDIBLE)

241 JP: UM, I'LL TALK TO YOU LATER.

242 (STATIC) (INAUDIBLE)

243 UM: YOU KNOW WHAT, I, I MEAN DEFINITELY ONE OF THE LEADING THINGS

244 INFLUENCING OUR CONCEPTION OF THE BRAIN RIGHT NOW IS

245 COMPARISON TO COMPUTERS TO COMPUTING

246 JP: RIGHT, RIGHT, EVEN THOUGH THERE'S NOT MUCH COMPARISON.

247 UM: THERE, THERE ARE A LOT OF DIFFERENCES. AND BUT WHAT THE NEW

248 THING IS (INAUDIBLE) THERE'S BEEN SOME RESEARCH ON SOME

249 DIFFERENT THINGS, BUT THEY'VE KIND OF FIGURED OUT THAT THERE

250 THESE CERTAIN NUMBER OF ALGORITHMS THAT CAN TECHNICALLY

251 PROGRAM ANYTHING.

252 JP: RIGHT.

253 UM: LIKE ONCE YOU HAVE THIS, THIS, AND THIS, IT THEN ALLOWS FOR A

254 CERTAIN LEVEL OF CONDITIONALITY, CERTAIN LEVEL OF RECURSION A

255 CERTAIN LEVEL OF (INAUDIBLE).

256 JP: RIGHT.

257 UM: AND THEN YOU BASICALLY HAVE THE ABILITY TO MAKE A PROGRAM

258 THAT HAS ANY FUNCTIONALITY. NOW, SO, I THINK THE FACT THAT

259 (STATIC).

260 SP: GONNA HEAD OVER THERE?

261 JP: YEAH.

262 SP: JOSH YOU GOT TO LEAVE RIGHT AWAY, YOU'RE GOING TO MISS OUT.

263 JP: PEOPLE DON'T KNOW WHAT IT'S LIKE TO GO THROUGH THIS AND TO GO

264 THROUGH THE EVERYTHING, OKAY, THERE'S NOT JUST MISSING SUSAN. I
265 MISS SUSAN AND I'M DEALING WITH A LOT OF THINGS, AND, YOU KNOW,
266 THE MORE PEOPLE DO THESE THINGS, THESE ACCUSATORY THINGS, THE
267 MORE I'M GOING TO WITHDRAW. I DON'T KNOW WHAT TO SAY YOU
268 KNOW. AND PEOPLE CAN MAKE THEIR JUDGMENTS. I DON'T KNOW WHAT
269 TO SAY, I MEAN, PEOPLE HAVE TO MAKE JUDGMENTS THAT'S WHAT,
270 THAT'S WHAT HALF THIS COUNTRY DOES, THEY MAKE JUDGMENTS.

271 JG: (INAUDIBLE).

272 SP: I'M READY TO GO NOW JOSH.

273 (STATIC)

274 JG: I THINK YOU JUST NEED TO CONFESS NOW AND GET IT OVER WITH.

275 JP: DON'T BE RIDICULOUS. I'VE TOLD YOU ALREADY.

276 JG: I SEE IT IN YOUR FACE JOSH. I CAN SEE IT IN YOUR FACE.

277 JP: THEN, I DON'T KNOW WHAT TO SAY, BECAUSE I'VE ALREADY TOLD YOU.

278 JG: EVERYTHING I SEE AND NOW THIS. (INAUDIBLE).

279 JP: I DON'T KNOW WHAT YOU MEAN AND NOW THIS.

280 JG: AND NOW THIS IN YOUR FACE.

281 JP: I DON'T KNOW WHAT TO SAY.

282 JG: (INAUDIBLE).

283 JP: I'M GOING TO GO DO WHAT I'M GOING TO DO, I'M GOING TO GO GETTING
284 READY FOR A PARTY.

285 JG: (INAUDIBLE) FOR A LONG, LONG TIME.

286 JP: I DON'T BELIEVE THAT AT ALL. YOU MAY, BUT I DON'T BELIEVE THAT AT
287 ALL.

288 JG: (INAUDIBLE).

289 JP: NO, I KNOW THE TRUTH.

290 JG: WHAT IS THE TRUTH?

291 JP: I KNOW WHAT I'VE DONE AND I HAVEN'T DONE ANYTHING.

292 JG: (INAUDIBLE).

293 JP: I HAVEN'T DONE ANYTHING I DON'T KNOW WHERE SHE'S AT. SO, I GUESS,

294 UM, I GUESS, TO BE HONEST MAYBE WE BETTER GO GET THE CAKE AND.
295 JG: (INAUDIBLE).
296 JP: FIRST OF ALL THAT'S NOT TRUE.
297 JG: IT IS TRUE. (INAUDIBLE).
298 JP: BUT, I'M GOING TO GO, I'M GOING TO GO
299 JG: (INAUDIBLE).
300 JP: UH, UH, I'M GOING TO GO, I GOTTA GO JENNY. AND TO BE QUITE HONEST,
301 I MEAN,
302 JG: YOU TOLD HIM AFTER THEN?
303 JP: TO BE QUITE HONEST, IF YOU WANT TO, UM, JUST HANG OUT OR
304 WHATEVER THAT'S FINE.
305 JG: (INAUDIBLE).
306 JP: NO.
