1. HOW TO ENTER

These rules govern the KSL TV GARTH BROOKS GIVEAWAY 2026 (Contest), which is being conducted by KSL ("Station"). The Contest begins on September 11, 2026 at 8:00am (MT) and ends on September 17th, 2026 at 9:59pm (MT) ("Entry Period"). Entrants may enter via online form during this time ("Entry Period").

- i. **To enter online**, visit the contest page at ksl.com/contests and follow the instructions to enter the Contest and complete and submit the online entry form ("Online Entry") during the Entry Period outlined above. Entrants can also listen for the BONUS KEYWORD on the 6PM News on KSL TV, Monday September 14th-Thursday September 17th, and take the keyword to the online entry form for additional entries. Online Entrants are subject to all notices posted online including but not limited to the Station's Terms of Use and Privacy Policy. Multiple Entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator.

The winner will win the prize upon confirmation of eligibility.

Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.

There will be up to a total of two (2) winners selected in the Contest.

All entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

The Contest is open to all persons who are legal U.S. residents of the state of Utah eighteen (18) years of age or older, and who reside in one of the jurisdictions that make up the Utah DMA listening area. Void where prohibited or restricted by law.

The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (i) Any employees (i.e., full-time, part-time and/or temporary employees) of the KSL Media Station, Bonneville International Station, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (ii) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (iii) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including significant others, and partners.

Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station events from any of the KSL Media or Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to THE CONTEST are not eligible to participate. Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to THE CONTEST are not eligible to participate. Persons who have won a prize valued between \$500 and \$999 in the six (6) months prior to THE CONTEST are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to THE CONTEST are not eligible to participate. These restrictions also apply to immediate household members of contest or Winners.

To claim any prizes, the person selected to win a prize ("Winner") must provide valid government-issued photo identification and provide their complete address, date of birth, email address and phone number, and Social Security Number.

Entrants are required to provide truthful information to the Station and will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any Entrant who does not meet the eligibility requirements and will also delete any entry as required by law. This Contest is subject to all applicable federal, state and local laws and regulations. By participating in this Contest and/or acceptance of a prize, Entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

3. PRIZES

Two (2) Prizes will be awarded. Each winner will receive:

- (i) **A Pair (2 tickets)** of tickets to Garth Brooks: Blame It On My Roots Tour 2026 on Friday October 9th.
- (ii) The Approximate Retail Value (“ARV”) of the Prize is five hundred thirty dollars (\$530). Prize does not include transportation or rental car, travel insurance, gratuity, parking fees, meals, merchandise or souvenirs, local or long-distance telephone calls, service charges, taxes or any other cost or expense not expressly stated. Any difference between stated ARV and actual value will not be awarded.
- (iii) If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, disease, epidemic, pandemic, national or regional emergency, or for any reason beyond the control of the Station or Contest Sponsor, their sole responsibility to the Winner(s) will be to award the remaining available elements of the prize and no substitution or compensation will be provided for the unawarded elements of the prize. The Station or Contest Sponsor, in their sole discretion, reserves the right to deny entry to or to remove the Winner(s) and/or guest(s) if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize related event(s).
- (iv) All sales, taxes, gratuities and any other incidentals associated with the prize are the sole responsibility of the Winner. Federal, state and local taxes relating to the prize are the responsibility of the winner and station or sponsor will issue all tax forms, including a 1099 form to the winner. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station and Contest Sponsor are final.

4. WINNER SELECTION AND NOTIFICATION

Two (2) Winners will be selected in the Contest when the entry period is concluded. Winner is not required to be present to win.

- i. Odds of winning the Prize depend upon the number of eligible Online Entries received.

Potential Winner(s) will be notified by call/text after the entry period. The Prize will be awarded only upon confirmation of eligibility and completion of all requisite releases.

Station will also email the winner by September 18th, 2026. **Upon winner(s) notification**

or notification attempt, the potential Winner(s) will be required to respond to such notification attempt and must execute and return an IRS Form W-9, affidavit of acceptance, eligibility, liability, publicity release within thirty (30) days of such notification or notification attempt or the Prize will be forfeited. If a potential Winner(s) is deemed ineligible for any reason, cannot be contacted, fails to sign and return the fully-executed affidavit of eligibility and/or liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential Winner forfeits the Prize. The Contest Administrator is not responsible for any changes in an Entrant or Winner's email address, phone number, mailing address or other contact information.

5. CONDITIONS

Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins or any other methods may void that Entrant's entries and that Entrant may be disqualified. Multiple entries from the same Authorized Account Holder will be disqualified. In the event of a dispute, all entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who: (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address; or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an Entrant's disqualification and/or forfeiture of any prize or prizes. If the Station makes a good-faith determination that an Entrant has cheated or committed fraudulent activity in connection with a Contest, the Station may disqualify that Entrant from entering and/or winning this and any or all future Station-administered contests and seek damages to the fullest extent permitted by law.

The Station reserves the right to modify these rules for clarification or equitable purposes without materially affecting the terms and conditions of the Contest, including, without limitation, the substitution of the Prize of equivalent value, which will become effective upon announcement. To the extent the Station makes material changes to the terms and conditions of the Contest, any such material changes will be broadcast on the Station and/or posted on its website: www.ksl.com within twenty-four (24) hours of the change and periodically thereafter. If any provision of these Official Rules is irrevocably

inconsistent with any provision set forth on the Contest webpages, then the provision of these Official Rules will prevail but solely to the extent of the inconsistency.

By entering the Contest and/or acceptance of Prize, all Entrants consent to the use of their name, photograph, likeness, biography, voice, video, entry materials, prize information (if any), or any statements made for trade, publicity, advertising, or promotional purposes, in any and all media, now known or hereafter devised, including online announcements, without limitation and without compensation, except where prohibited by law.

The Winner will be required to produce identification satisfactory to the Station. For example, Winner will be required to sign an IRS Form W-9, affidavit of eligibility and release, including a publicity release, as prepared by the Station prior to receiving their Prize. The Winner will solely be responsible for any (federal, state, or local) taxes or fees that result from the receipt and/or use of their Prize and may receive an IRS Form 1099-Misc for all prizes won from the Station in any calendar year where the aggregate value of all such prizes is \$2000 or more. The Contest is void where prohibited by law. Failure to comply with the terms and conditions applicable to Contest entry, including without limitation submitting an incomplete or fraudulent entry, and/or failing to complete the entry process, will result in such entry being disqualified from such Contest. Any individual(s) that is found to be, or suspected of, tampering with a Contest in any way, including without limitation by making a fraudulent entry, by engaging in any “deal-making” with or between other Contest Entrants or third parties, by creating a public hazard, by cheating, by engaging in improper or illegal activity, by causing interference with or the destruction of property and/or utilized public safety resources will be disqualified from participating and/or winning any prize(s), as applicable, and may be banned from any future participation in any Contest as determined by Station at its sole discretion and on a case-by-case basis.

Participation in a Contest and/or acceptance of the Prize constitutes agreement by Entrant and/or Winner to release, forever discharge, indemnify, and hold harmless Station, its affiliates, parents, assigns, successors, employees, agents, along with all others connected with them and the Contest (the “Released Parties”) from any and all liability, claims, actions, and damages sustained or incurred by participation in the said Contest, and the receipt and use of any prize(s) awarded (if any) through such Contest arising in any manner whatsoever, including but not limited to an act or omission, whether negligent, intentional or otherwise caused by Station, its affiliates, parents, assigns, successors, employees, sponsors, agents and all others connected with them and the Contest.

The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering, or the administration of the Contest or in the announcement of a prize; (ii)

incorrect or inaccurate information, human error, failure, or omission; (iii) unauthorized human intervention; (iv) lost, stolen, mangled, misdirected, illegible, incomplete, or late entries; (v) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, telephone service outages, delays, busy signals, poor signals or signal interference, accidental disconnection, equipment malfunctions, and any other technological failures; or (vi) any cancellations, delays, diversions, or substitutions or omissions by any transportation providers or any other persons or entities providing any services to Entrant(s) and/or Winner(s) including any results thereof such as changes in services or location necessitated by same. Further, the Released Parties are not responsible if any part of a Contest cannot be conducted and/or if a prize, either in whole or in part, cannot be awarded due to acts of God, acts of war, natural disasters, weather, acts of terrorism, or other factors beyond the Released Parties' control.

Except where prohibited, by entering the Contest, each Entrant and Winner agrees that (i) any and all disputes, claims and causes of action arising out of or connected with this Contest or any prize(s) awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in Salt Lake City, Utah; (ii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event shall such costs include attorneys' fees; and (iii) no punitive, incidental, special, consequential or other damages, including, without limitation, lost profits may be awarded (collectively, "Special Damages"), and (iv) Entrant hereby waives all rights to claim Special Damages and all rights to have any damages awarded multiplied or increased. Utah law governs the interpretation and construction of these Official Rules and all aspects related thereto.

6. PRIVACY

In the event of conflict between the Station's Terms of Use Agreement and these Official Rules, the terms of these Official Rules shall apply.
